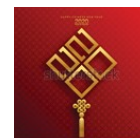

The Press Conference

On November 20, 2020 at a press conference, Trump's campaign attorney Sidney Powell said "release the Kraken." What is the Kraken?

A Kraken is a legendary squid-like sea monster of gigantic size in Scandinavian folklore. According to the Norse sagas, the Kraken dwells off the coasts of Norway and Greenland and terrorizes nearby sailors.



So what did Powell mean using this term? We will find out.

At the same press conference Trump's lawyer Rudy Giuliani spoke about the allegations of fraud in Pennsylvania, Wisconsin, and Michigan. He said the issue was widespread and that he had enough evidence on just fraud alone to overturn the election.

Senior Legal Advisor for the Trump campaign, Jenna Ellis said the press conference was an "opening statement, so the American people can understand what the networks have been hiding and what they refuse to cover." She said all of the "fake news headlines are dancing around the merits of this case and are trying to delegitimize what Trump's legal team is doing." She said this overview is what you'd expect to see when they go to court and show the evidence.

Powell spoke more about the allegations surrounding Dominion Voting System. Powell said that there was an algorithm that would flip votes from one candidate to another. Powell said that experts, including a group of Princeton University professors, have discussed multiple end-user vulnerabilities in Dominion.

"We have more evidence now than half the prison population is imprisoned on," Powell told Fox Business, responding to a statement from Dominion Voting Systems in denying the Trump team's claim that software could be manipulated to overturn the election against President Donald Trump, as well as claims the company had links to Venezuela's regime.

"All I can tell you is that well, the company might have somehow severed or tried to sever the relationships recently, I don't know how they are parsing their words, but I can tell you that the company was started with Venezuelan money in Venezuela for the express purpose of rigging elections for Hugo Chavez," Powell said. Powell also said that people could remotely watch the votes and flip them in real time.

"We have evidence now of information from the systems going to three or four different foreign countries during the time of the election, those countries themselves could have watched the live votes come in and changed the numbers," said Powell. "There's significant evidence of foreign

interference from the worst communist countries on the Earth with our election.”

“People can admittedly go in and change whatever they want. They can set the ratio of votes from one thing to another. They can say a Biden vote counts as 1.25 and a Trump vote counts as 0.75 and those may be the actual numbers that were actually used here,” Powell said.

She said this algorithm was likely used all across the country.

She said in addition to flipping votes, the system also can inject votes for a certain candidate as well. According to her, some of these provisions are written in the manual as being “features.”

Powell also spoke of shocking allegations that some Dominion employees said they were trained to throw away Trump votes.

“We have testimony of different Dominion workers admitting that they were trained how to dispose of Trump votes and add to Biden votes. The gentleman who founded Smartmatic, there’s video of him on the internet that said yes, at least in one occasion, he admits they changed 1 million votes with no problem.”

Powell continued, saying that she had mathematical evidence in a number of states of Trump votes being trashed and Biden votes being injected.

She called these allegations one of the most infuriating, heartbreaking, and most unpatriotic acts for people to have participated in. Powell said American patriots were fed up with corruption from the local level to the highest level of government.

“And we are going to take this country back. We are not going to be intimidated. We are not going to back down. We are going to clean this mess up now. President Trump won by a landslide. We are going to prove it. And we are going to reclaim the United States of America for the people who vote for freedom.”

Powell said she will “release the Kraken” and the evidence will come to light in court.

I am an attorney and therefore am prone to make remarks that are hedged with adjectives such as “possible” “perhaps” and “notwithstanding.” Seldom do attorneys make clear declaratory statements that can come back to haunt them. Sidney Powell is a preeminent attorney of the first order. For her to say “President Trump won by a landslide. We are going to prove it” tells me she is in possession of evidence that she believes to be irrefutable. We will see what she meant after she files her lawsuits.

The Law Suits

The Epoch Times reported that on November 25 attorney Sidney Power filed a federal civil action lawsuit in Georgia against Georgia Gov. Brian Kemp, Secretary of State Brad Raffensperger, and other election officials alleging “massive election fraud” and multiple violations of the Constitution and Georgia’s state laws in the 2020 general election, as well as issues pertaining to Dominion Voting Systems.

The civil action alleges that the purpose of the scheme was for “illegally and fraudulently manipulating the vote count to make certain the election of Joe Biden as president of the United States.” A similar separate suit was filed in Michigan.

The suit seeks to compel the court to invalidate the election results in Georgia. It was filed on behalf of plaintiffs including Republican Party nominees for the electoral college, the chairman of the Cobb County Republican Party Jason Shepherd, and the Assistant Secretary of the Georgia Republican Party, Brian Jay Van Gundy

The 104-page complaint argues that “incontrovertible evidence Board of Elections records demonstrates that at least 96,600 absentee ballots were requested and counted but were never recorded as being returned to county election boards by the voter. Thus, at a minimum, 96,600 votes must be disregarded.”

According to the suit, fraud was also allegedly “executed by many means” but the “most troubling, insidious, and egregious” way was the “systemic adaptation of old-fashioned ‘ballot-stuffing.’” It alleges computerized ballot-stuffing and manipulation by software created and run by domestic and foreign actors. The complaint cited affidavits from multiple witnesses, documentation, as well as expert testimony that raised “sheer mathematical impossibilities” in the election results supporting the claims.

“Especially egregious conduct arose in Forsyth, Paulding, Cherokee, Hall, and Barrow County,” the complaint read. “This scheme and artifice to defraud affected tens of thousands of votes in Georgia alone and ‘rigged’ the election in Georgia for Joe Biden.”

In particular, the suit took issue with election software and hardware from Dominion Voting Systems, which it noted was recently purchased and “rushed into use” by Kemp, Raffensperger, and the Georgia Board of Elections.

Plaintiffs allege that the design and features of the Dominion software do not allow for a simple audit to see whether votes were misallocated, redistributed, or deleted, pointing to a Jan. 24 decision by the Texas secretary of state to deny certifying the software “because of a lack of evidence of efficiency and accuracy and to be safe from fraud and unauthorized manipulation.”

“First, the system’s central accumulator does not include a protected real-time audit log that maintains the date and time stamps of all significant election events. Key components of the system utilize unprotected logs,” the filing reads. “Essentially this allows an unauthorized user the opportunity to arbitrarily add, modify, or remove log entries, causing the machine to log election events that do not reflect actual voting tabulations—or more specifically, do not reflect the actual votes of or the will of the people.”

The suit also alleges “incontrovertible physical evidence that the standards of physical security of the voting machines and the software were breached, and machines were connected to the Internet in violation of professional standards and state and federal laws.”

Part of the suit mentions a delay in voting at State Farm Arena in Fulton County, where video on Nov. 3 shows that election workers “falsely claimed a water leak required the facility to close.” It adds, “All poll workers and challengers were evacuated for several hours at about 10:00 PM. However, several election workers remained unsupervised and unchallenged working at the computers for the voting tabulation machines until after 1:00 AM.”

Another part of the complaint said that cybersecurity expert Navid Keshavarz-Nia testified that “U.S. intelligence services had developed tools to infiltrate foreign voting systems including Dominion.” Pointing to vulnerabilities in the Dominion’s software, he claims that “hundreds of thousands of votes” were transferred from President Donald Trump to Democratic presidential nominee Joe Biden in battleground states.

The complaint also cites a former electronic intelligence analyst under the 305th Military Intelligence Battalion, who declared that the Dominion software was accessed by agents acting on behalf of China and Iran to monitor and manipulate elections, including the 2020 U.S. general election.

A former U.S. Military Intelligence expert had analyzed the Dominion software system and concluded that the system and software “were certainly compromised by rogue actors, such as Iran and China,” according to another part of the complaint.

“By using servers and employees connected with rogue actors and hostile foreign influences combined with numerous easily discoverable leaked credentials, Dominion neglectfully allowed foreign adversaries to access data and intentionally provided access to their infrastructure in order to monitor and manipulate elections, including the most recent one in 2020,” the filing said.

The lawsuit also claims: “Georgia’s election officials and poll workers exacerbated and helped, whether knowingly or unknowingly, the Dominion system carry out massive voter manipulation by refusing to observe statutory safeguards for absentee ballots. Election officials failed to verify signatures and check security envelopes. They barred challengers from observing the count, which also facilitated the fraud.”

The Georgia secretary of state and Dominion Voting Systems did not immediately respond to The Epoch Times’ requests for comment on the suit.

Dominion released a statement on Wednesday saying: “Claims that Dominion deleted or switched votes are completely false. Dominion systems are 100 percent auditable.”

The lawsuit comes after election results were certified for Georgia on Nov. 20. At the time, Kemp did not clearly endorse the results but said the law required him to “formalize the certification, which paves the way for the Trump campaign to pursue other legal options and a separate recount if they choose.”

Now to answer the question what did Powell mean by “release the Kraken.” To answer that we turn to former military insider and present-day analyst Jeffrey Prather (jeffreypather.com) who just released a video entitled “The Great Reset vs. the Great Awakening.”

In this video Prather describes the Kraken to be a Department of Defense (DoD) run cyber warfare program that tracks and hacks various other systems to acquire evidence of nefarious actions by the deep state. According to Prather Trump loyalists in the Air Force, Space Command and now in certain sectors of the DoD and even the NSA have all the evidence of voter fraud and election-related treason. Trump has all this now and will be using it against the enemies of America very soon.

If this is true, this will be the biggest political scandal in U.S. history. But at this time, it’s still a big “IF”

The Bottom Line

On November 9, president Trump fired Mark Esper, a former secretary of the Army as Director of the Department of Defense (DoD)

and replaced him with Christopher Miller, a former director of the National Counterterrorism Center and his assistant the brilliant Undersecretary of Defense Ezra Cohen-Watnick who served under General Michael Flynn at the Defense Intelligence Agency.

On November 19, Christopher Miller declared that all special forces operations units (i.e. Army Rangers, Navy Seals and Delta Force) now report directly to him, bypassing the DoD itself that purportedly has allegiance to globalists and the Democrats. This puts the many tens of thousands of special forces operations units and assets directly under the control of pro-Trump patriots, and it points to a “Plan B” which apparently envisions president Trump invoking the National Defense Authorization Act (NDAA) and the Insurrection Act, and dispatching special forces units across the USA to apprehend actors who participated in the election fraud and take down the Big Tech and Big Media actors who supported the operation to throw the election against president Trump.

According to admitted extreme conservative political columnist Mike Adams, the entire system is completely corrupted with political enemies of president Trump who, if found guilty should be arrested and imprisoned.

Unfulfilled Prophecies

The *Trumpet* has been explaining biblical prophecies that apply to Donald Trump and to America—specific end-time prophecies that *must be* and *will be* fulfilled.

As I explained in my article “Saving America From the Radical Left—Temporarily,” this fulfills a prophecy in the biblical book of Kings about an end-time “Jeroboam” whom God would use to save the nation momentarily.

That period in Israel anciently was a forerunner of what is happening in America today. An enemy was attacking, and 2 Kings 13:5 says “the Lord gave Israel a saviour.” “For the Lord saw the affliction of Israel, that it was very bitter: for there was not any shut up, nor any left, nor any helper for Israel. And the Lord said not that *he would blot out the name of Israel from under heaven*: but he saved them by the hand of Jeroboam the son of Joash” (2 Kings 14:26-27). The book of Kings is one of the former prophets, and most of its prophecy is for this end time.

There are forces attacking America today that are terribly destructive—and the worst of them are *within the nation*. (My free booklet *America Under Attack* explains this.) But looking at this *modern-day* Jeroboam, you have to say God gave Israel a “savior”—at least to the extent that He wouldn’t let these enemies bring down the nation. He has been blocking this movement to “blot out the name of Israel [which includes America] from under heaven.”

There are forces attacking America today that are terribly destructive—and the worst of them are within the nation.

And is his job finished? No, it isn’t. So I don’t believe *at all* that he is going to disappear from the scene!

The *Trumpet* has also pointed to a prophecy in Amos 7 that tells us a lot about this end-time Jeroboam. None of that prophecy has yet been fulfilled—but we can be sure that it will be, and President Trump *must*

be in power for this to take place. God is going to fulfill every prophecy of His Bible!

I still believe these prophecies are 100 percent accurate. This means this nation is about to be shocked. I believe you are going to see frauds exposed like you’ve never even imagined! In a sense, you could say the left is fighting against God and God’s prophecy! Who do you suppose is going to win that battle?

Election Fraud

The mainstream media insist there is “no evidence” the Democrats tried to steal this election. This is *patently false*—there is plenty of evidence. But it is also absurd, when you think about what the left has been doing for the past several years! You would have to be naive not to think they are committing great frauds with this election.

Just look at the way it all happened: Several of the states President Trump was winning on election night simply *stopped counting* for four or five hours. They were all synchronized. I believe Democrats were beginning to see that they didn’t have enough votes—so they had to find a way to get them.

Then, as mail-in ballots were counted, everything changed. Those states all ended up switching over to former Vice President Biden. Isn’t that amazing?

Mail-in ballots open the door for *terrible fraud*. Did you know that among the 27 countries in the European Union, 17 ban mail-in voting except in very rare cases? They *know* how susceptible such ballots are to fraud. Yet Democrats have used the coronavirus pandemic as a pretense to encourage *as much mail-in voting as possible*—and even to extend deadlines past Election Day. I truly believe they did that to enable themselves to steal this election—and I say that without apology! They have a *long history* of using voter fraud to sway elections!

Back in June, the Pennsylvania Democratic Party filed a lawsuit demanding that the state of Pennsylvania count mail-in ballots received up to three days after Election Day. Pennsylvania law required that mail-in ballots be received by 8 p.m. on Election Day, but the Democrats wanted to use *the courts* to rewrite state law. This demand was a clear act of judicial activism, but the majority of the state Supreme Court judges in Pennsylvania are elected Democrats. So on September 17, the Pennsylvania Supreme Court ruled 4–3 to rewrite Pennsylvania’s election statutes and allow mail-in ballots to be received until November 6.

Republican officials petitioned the U.S. Supreme Court to rule the Pennsylvania Supreme Court decision an act of judicial overreach. But Chief Justice John Roberts sided with the radical left and ruled that the U.S. Supreme Court should not get involved. That made a 4–4 tie over whether to hear the case, which meant the lower court ruling stood.

What a terrible mistake! It shows shocking naivety and delusion. Just remember what these people have done in the past. The Steele dossier was nothing but lies created by the radical left. For *three years* they used it as “proof” that Donald Trump was a Russian agent—and they *knew* from beginning to end that it was nothing but lies! So do you think they wouldn’t steal some votes? I would be shocked if they didn’t! That report proved to be treasonous. Now they have moved on to something perhaps *even more* treasonous! Yet the Supreme Court just opened the way.

The Goals of the Left

Many on the left want a civil war. Some have already declared war! They certainly want to bring the nation to the point where they can pounce on their opponents and destroy them. And they are going all out!

We don’t have to *speculate* on the goals of the left. They are pretty outspoken if you pay attention!

America has changed like you have never seen it change—in just *months* or even weeks—into a different country! It’s not the country it was a couple years ago—or even at the start of this year! And on November 4, the Trump campaign filled a motion for the U.S. Supreme Court to intervene in this case, and is awaiting

an answer.

I don’t know, but I would think the Supreme Court is going to have to rule on this election eventually—whether regarding Pennsylvania or other cases. The fact that Justice Barrett will be there when that happens increases the odds that the law will be upheld! And that would make all the difference for the president. You can read a specific prophecy that points to this in my article “Can President Trump Get Control of His Own Divided Government?” I would *think* that is the way God is going to solve this, but He may have other ideas.

Something is going to have to happen, and for God to fulfill this prophecy, it will have to be a miracle. But He is a God of miracles! And He is the one who ultimately places leaders in power (Daniel 4:17, 25; Psalm 75:6-7; Romans 13:1).

What is the dark history of the new Vice President Kamala Harris?



Now that Kamala Harris is going to be the vice-presidential elect. Let's review some facts...

Here goes:

"Kamala Devi Harris was born to Donald Harris, her Jamaican-born father and Dr. Shyamala Gopalan, her Tamil Brahmin mother from India. Her father is a Marxist economist who taught at Stanford University."

Who is Willie Brown and what's the connection?

"In 1994, she met Willie Brown, who at the time was the second-most-powerful man in California politics. As Speaker of the State Assembly, Brown was a legend in Sacramento and around the state."

"Brown was under investigation several times, by the State Bar of California, Fair Political Practices Commission, the FBI.

In 1986 ...as California Assembly Speaker, he "received at least \$124,000 in income & gifts...from special interests that had biz before the Legislature."

Now this is neither here nor there for me, except for the political angle:

"Brown was sixty at the time he began dating Kamala, who was twenty-nine. Brown was actually two years older than her father. Their affair was the talk of San Francisco in 1994."

"Kamala's mother defends her daughter's decision - and offered choice comments about Brown. "Why shouldn't she have gone out with Willie Brown? He was a player. And what could Willie Brown expect from her in the future? He has not much life left."

"He (Willie Brown) put Kamala on the State Unemployment Insurance Appeals Board and later the California Medical Assistance Commission. The MAC paid \$99k a year in 2002.. UIAB ~\$114k.

Both posts were part-time.

At the time, she was working as a county employee making ~\$100k"

"During his tenure, Brown came under FBI investigation twice for corruption involving lucrative contracts flowing from the city to his political friends."

"I thought it was only in Third World countries that people were forced to pay bribes to get services they're entitled to from their government," said U.S. district judge Charles Legge about the rampant corruption under Brown. "But we find it right here in San Francisco."

"In January 2003, shortly after announcing her campaign, (Kamala) Harris had signed a form saying that she would stick to the city's \$211,000 voluntary spending cap for the campaign (for the San Francisco district attorney election)."

"Harris signed the pledge-and then blew right past the spending limit. By the end of Nov, she had raised \$621,000...

The San Francisco Ethics Commission vote to fine Harris was unanimous. Her campaign had to pay a \$34,000 fine, a record in city elections."

Moving on to the next, and by far the most disturbing aspect:

"Harris often recounts her background as a sex crimes prosecutor earlier in her career to attack others for their legal failings in this area."

"During her decade-and-a-half tenure as a chief prosecutor, Harris would fail to prosecute a single case of priest abuse and her office would strangely hide vital records on abuses that had occurred despite the protests of victims groups."

"Harris's predecessor as San Francisco district attorney, Terence Hallinan, was aware of and had prosecuted numerous Catholic priests on sexual misconduct involving children. And he had been gathering case files for even more."

"Hallinan's office had launched an investigation and quickly discovered that the San Francisco Archdiocese had extensive internal records concerning complaints going back some seventy-five years."

"In spring of 2002, Hallinan demanded the church turn them over to his office. A month later, the archdiocese reluctantly complied."

"The secret documents were explosive and reportedly contained the names of about forty current and former priests in the San Francisco area who had been identified in sexual abuse complaints."

"Hallinan used the information from the files to begin pursuing legal

cases against them. In nearby San Mateo and Marin County, prosecutors obtained the same church records and those in Marin charged Father Gregory Ingels in 2003"

"But by June 2003, Hallinan and other prosecutors had hit a roadblock: the U.S. Supreme Court ruled that California's law extending the statute of limitations for priest abuse cases was unconstitutional."

"The records that Hallinan had in his possession touched on well-connected institutions at the heart of California's power structure. St. Ignatius College Preparatory School, in the Archdiocese of San Francisco, counted California governor Jerry Brown ... as alumni."

Now comes the Kamala connection:

"According to San Francisco election financial disclosures, high-dollar donations to Harris's campaign began to roll in from those connected to the Catholic Church institutional hierarchy."

"For some reason, she did not want the documents released in any form.

Harris's office claimed that the cover-up was about protecting the victims of abuse.

Victims' groups wanted the documents released and Harris was stopping it."

"They're full of shit," said Joey Piscitelli, the northwest regional director of Survivors Network of Those Abused by Priests (SNAP), the largest and most active victims' group. "You can quote me on that. They're not protecting the victims."

"With the outcry of victims groups, Harris's office then attempted to shift blame, claiming that the idea of burying the evidence had been first suggested by her predecessor, Hallinan."

"But he [Hallinan] responded angrily to her claims. "I told Jack Hammel [the archdiocese's legal counsel] in no uncertain terms that I wouldn't go along with anything like that."

"James Jenkins, the founding chairman of the archdiocese's Independent Review Board... resigned from the board... Jenkins argued that Harris's deal with the archdiocese not only denied the rights of known victims, it also prevented other possible cases from coming forward."

"In April 2010, a journalist with the San Francisco Weekly asked for the records through California's Public Records Act. Harris's office denied the request, offering conflicting explanations as to why they could not provide them."

"In 2019, I requested those records through a California attorney. The San Francisco district attorney's office responded that they no longer had them in their possession. Were they destroyed? Were

they moved somewhere else? It remains a disturbing mystery."

"She somehow served as San Francisco district attorney from 2004 to 2011, and then as California attorney general from 2011 to 2017, and never brought a single documented case forward against an abusive priest."

"To put this lack of action in perspective, at least fifty other cities charged priests in sexual abuse cases during her tenure as San Francisco district attorney. San Francisco is conspicuous by its absence."

The next one:

"At San Francisco's adult entertainment clubs, dancers were taking customers behind closed doors and having sex for money. ... After repeated complaints ... the San Francisco Police Department decided to take action."

"The police action caught the attention of newly installed district attorney Kamala Harris, and her staff sent the message to hold off on the enforcement."

"Meanwhile, in response to continued complaints, the police conducted a pair of sting operations. Three undercover officers went into each of the two clubs and were quickly solicited by female employees for paid sex."

"At both the Market Street Theater & New Century Theater, it happened "within minutes."

When the operations were done, 9 women were arrested, as was the GM of the New Century. The cops claimed that they were "slam-dunk cases."

But Kamala Harris dropped the cases."

"It just leaves me in amazement," said San Francisco Police Department vice captain Tim Hettrich. It was "almost legalizing prostitution."

"Harris's strange objections to prosecuting prostitution cases connected to these raids have a possible explanation. The owner of both the Market Street and New Century theaters was a company called Déjà Vu."

"An owner of Déjà Vu, Sam Conti, had a long history with Willie Brown. Conti had first hired Brown as his defense attorney back in 1977. They remained friends. At Conti's 2009 funeral, Brown delivered a videotaped eulogy."

Next one:

"Ricardo Ramirez. Ramirez ran a cement and concrete company called Pacific Cement. As of 2003, a full one-third of the public works projects in San Francisco used Pacific. ... Those contributions

often went to the Willie Brown machine and were not always legal."

"In 1997, state officials found that Ramirez had illegally contributed \$2,000 to Brown's 1995 mayoral campaign.

Ramirez never faced charges for delivering substandard concrete. Instead, Harris's office settled for a plea deal involving a single environmental count"

"illegally storing waste oil at one of his production facilities.

Harris & her office refused to offer an explanation as to why they were going so light on Willie Brown's friend & donor. "Harris' office had no explanation for why it dropped the concrete case," - the Chronicle."

"Kamala Harris's signature program as San Francisco district attorney was called Back on Track-a program designed to give first-time drug offenders an opportunity to avoid a criminal record."

"Those (in the program) included were not just nonviolent, first-time offenders who had committed a single drug offense. Some were illegal immigrants and violent criminals such as Alexander Izaguirre."

"Amanda Kiefer was walking down the street when Izaguirre snatched her purse and jumped into a waiting SUV. Rather than drive off, the SUV sped toward Kiefer to run her down. Kiefer jumped on the hood and saw Izaguirre and the driver laughing."

"The driver slammed on the brakes throwing Kiefer to the ground. The impact fractured her skull.

Harris did not offer an explanation. Instead, she simply explained that enforcing federal immigration law was not her job."

Next one:

"...in 2015 the attorneys general from fourteen other states, including New York, launched an effort to investigate nutrition companies on the grounds of false advertising and mislabeling."

"the Obama administration's Department of Justice (DOJ) was also going after dietary supplement producers, charging them with exaggerated claims"

"The Federal Trade Commission (FTC) opened an investigation into Herbalife in March 2014.

In July 2016, the FTC won a \$200 million settlement against Herbalife.

But Harris never even investigated the company."

"It is worth noting that those corporations in question all happened

to be clients of her husband's law firm, Venable LLP. GNC, Herbalife, AdvoCare International, Vitamin Shoppe, and others were represented by Venable."

"In 2015, prosecutors from Harris's own attorney general's office based out of San Diego sent her a long memorandum arguing that Herbalife needed to be investigated. ... Harris declined to investigate or provide the resources-and never offered a reason."

Should the average American be concerned with the rising influence of globalism in their community? Fifty years ago, probably not. But times have dramatically changed.

In 2018 at a rally in Texas, president Trump said "Radical Democrats want to turn back the clock. Restore the rule of corrupt, power-hungry globalists You know what a globalist is, right?"

Trump went on to explain "A globalist is a person that wants the globe to do well, frankly not caring about our country so much. And, you know what? We can't have that."

Most people would describe president Trump as a nationalist.

The words "nationalist" and "globalist" — both loaded terms with sometimes sinister implications — have made their way into the popular political lexicon since Trump became president.

Nationalism can refer to the promotion of self-governance and one country's interests. But it has also been associated with the "alt-right" movement, which is broadly supportive of president Trump's agenda but has occasionally been accused of harboring white supremacist tendencies. Globalism can imply a more economically connected world of multinational alliances, and is sometimes employed by racial commentators on the internet in a conspiratorial sense as a euphemism for Jewish people.

With the apparent ascendancy of Joe Biden as president of the U.S. the decline of nationalism and the ascendancy of globalism in America is now a pronounced probability. Therefore, it would behoove us to find out what globalism is.

There was a time not so long ago when talking about the U.S. dollar being dethroned and replaced with a new one world currency system and a cashless society controlled by the IMF was considered a bizarre theory. Now it's openly called for by numerous leaders in the financial industry and in economic governance. The claim that these things are "conspiracy theory" no longer holds up anymore. In reality, the people who made such accusations a few years ago now look like idiots as the establishment floods the media with information and propaganda promoting everything the liberty movement has been warning about.

The argument on whether or not a globalist agenda "exists" is over. The liberty movement and the alternative media won that debate, and through the efforts of libertarian organizations such as Info Wars, have even forced the establishment into admitting the existence of some of their plans for a completely centralized global system managed by them. Now, the argument has changed. Now, the argument is over whether or not the globalist agenda is a good thing or a bad thing.

So, is the globalist agenda a good thing or a bad thing?

According to Steve Balich, the well-known conservative activist, based on the sheer level of deception and disinformation used by the "globalists" over the past several decades to maneuver the public toward accepting a one world economy and eventually one world governance, if you have to lie consistently to people about your ideology in order to get them to support it, then there must be something very wrong with your ideology.

Also, the establishment may be going public with their plans for globalization, but they aren't being honest about the consequences for the average person. And there are many misconceptions out there, even in the liberty movement, about what exactly these people want. So, we need to construct a list of globalist desires vs globalist lies in order to define who we are dealing with. Here are the beliefs and arguments of your run-of-the-mill globalist:

Centralization

A globalist believes everything must be centralized, from finance to

money to social access to production to government. They argue that centralization makes the system "more fair" for everyone, but in reality they desire a system in which they have total control over every aspect of life. Globalists, more than anything, want to dominate and micro-manage every detail of civilization and socially engineer humanity in the image they prefer.

One world currency system and cashless society

As an extension of centralization, globalists want a single currency system for the world. Not only this, but they want it digitized and easy to track. Meaning, a cashless society in which every act of trade by every person can be watched and scrutinized. If trade is no longer private, preparation for rebellion becomes rather difficult. A one world currency and cashless system would be the bedrock of one world governance. You cannot have one without the other.

One world government

Globalists want to erase all national borders and sovereignty and create a single elite bureaucracy, a one world empire in which they are the "philosopher kings" as described in Plato's Republic. This system would be highly inbred, though they may continue to give the masses the illusion of public participation and "democracy" for a time. Ultimately, the globalists desire a faceless and unaccountable round table government, a seat of power which acts as an institution with limited liability, much like a corporation, and run in the same sociopathic manner without real public oversight. In the globalist world, there will be no redress of grievances.

Sustainability as religion

Globalists often use the word "sustainability" in their white papers and agendas, from Agenda 21 to Agenda 2030. Environmentalism is the facade they employ to guilt the population into supporting global governance, among other things. As Balich noted in his recent article 'Why Is The Elitist Establishment So Obsessed With Meat', fake environmentalism and fraudulent global warming "science" is being exploited by globalists to demand control over everything from how much electricity you can use in your home, to how many children you can have, to how much our society is allowed to manufacture or produce, to what you are allowed to eat.

So-called carbon pollution, perhaps the biggest scam in history, is a key component of the globalist agenda. As the globalist organization The Club Of Rome, a sub-institution attached to the United Nations, stated in their book 'The First Global Revolution':

"In searching for a common enemy against whom we can unite, we came up with the idea that pollution, the threat of global warming, water shortages, famine and the like, would fit the bill. In their totality and their interactions these phenomena do constitute a common threat which must be confronted by everyone together. But in designating these dangers as the enemy, we fall into the trap, namely mistaking symptoms for causes. All these dangers are caused by human

intervention in natural processes. and it is only through changed attitudes and behavior that they can be overcome. The real enemy then is humanity itself.”

In other words, by presenting human beings as a species as the great threat, the globalists hope to convince humanity to sublimate itself before the mother earth goddess and beg to be kept in line. And as the self-designated “guardians” of the Earth, the elites become the high priests of the new religion of sustainability. They and they alone would determine who is a loyal servant and who is a heretic. Carbon pollution becomes the new “original sin”; everyone is a sinner against the Earth, for everyone breathes and uses resources, and we must all do our part to appease the Earth by sacrificing as much as possible, even ourselves.

Population control

Globalists come from an ideological background which worships eugenics — the belief that genetics must be controlled and regulated, and those people they deem to be undesirables must be sterilized or exterminated.

The modern eugenics movement was launched by the Rockefeller Foundation in the early 1900s in America, and was treated as a legitimate scientific endeavor for decades. Eugenics was taught in schools and even celebrated at the World’s Fair. States like California that adopted eugenics legislation forcefully sterilized tens of thousands of people and denied thousands of marriage certificates based on genetics. The system was transferred to Germany in the 1930s where it gained world renown for its inherent brutality.

This ideology holds that 4 percent or less of the population is genetically worthy of leadership, and the elites conveniently represent part of that genetic purity.

After WWII the public developed a distaste for the idea of eugenics and population control, but under the guise of environmentalism the agenda is making a comeback, as population reduction in the name of “saving the Earth” is in the mainstream media once again.

Narcissistic sociopathy

It is interesting that the globalists used to present the 4 percent leadership argument in their eugenics publications, because 4 percent of the population is also consistent with the number of people who have inherent narcissistic sociopathy, either in latent or full-blown form. Is this a coincidence?

The behavior of the globalists is consistent with the common diagnosis of full-blown narcissists, a condition which is believed to be inborn and incurable. Narcissists (psychopaths) are devoid of empathy and are often self-obsessed. They suffer from delusions of grandeur and see themselves as “gods” among men. They believe other lowly people are tools to be used for their pleasure or to further their ascendance to godhood. Narcissists feel no compassion toward those they harm or murder, yet crave attention and adoration from

the same people they see as inferior. More than anything, they seek the power to micro-manage the lives of everyone around them and to feed off those people like a parasite feeds off a host victim.

Luciferianism

This is a highly complicated issue which requires its own essay to examine in full. Balich believes he did this effectively in his article ‘Luciferianism: A Secular Look At A Destructive Globalist Belief System.’ Needless to say, this agenda is not one that globalists are willing to admit to openly very often, but Balich has outlined extensive evidence that Luciferianism is indeed the underlying globalist cult religion. It is essentially an ideology which promotes the worship of the self and the attainment of godhood by any means necessary — which fits perfectly with globalism and globalist behavior.

It is also the only ideological institution adopted by the U.N., through the U.N.’s relationship with Lucis Trust, also originally called Lucifer Publishing Company. Lucis Trust still has a private library within the U.N. building today.

So, using Balich’s concise attributes we can discern the various agendas and identifiers of the globalists, we can now ask “Who are the globalists?” The answer is — anyone who promotes the above agendas, related arguments, or any corporate or political leader who works directly with them.

To make a list of names is simple; merely study the membership rosters of globalists organizations like the Bilderberg Group, the Council on Foreign Relations, the Trilateral Commission, Tavistock Institute, the IMF, the BIS, World Bank, the U.N., etc. You will find a broad range of people from every nation and every ethnicity all sharing one goal — a world in which the future for every other person is dictated by them for all time; a world in which freedom is a memory and individual choice is a commodity only they have the right to enjoy.

For Americans, it’s clear that in the coming years, the world will change.

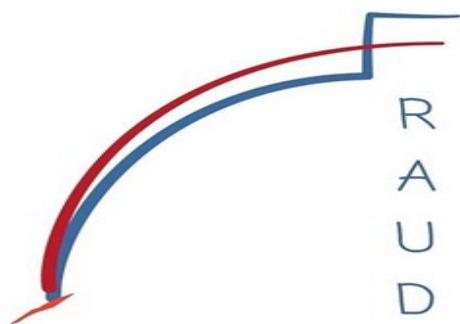
Why Globalists want Trump to win

That will justify the violence the Globalists plans to unleash, and this time it will be with serious arms perhaps supplied by communist China and smuggled through Democrat states like California. The following is an intriguing, insightful and incisive interview of Casey on the state of our country by Rachel Boddien, the managing editor of his company Casey Research. It appeared on the web on Nov 20, 2020. I present it here for your reading consideration. D. Miyoshi

Rachel Boddien, managing editor, Casey Research: In our last con-

versation, we talked about changes stemming from this election, like the continued legalization of cannabis and the new legalization of those so-called harder drugs. But what are your thoughts on this general election?

We've heard some of your thoughts about President Trump, but we haven't heard any musings from you about Joe Biden.

Doug Casey, founder, Casey Research: There's very little, if anything, to be said in favor of Joe Biden. He's a reflexive leftist, statist, and crony. A lifelong government employee, he and his family have become amazingly wealthy on civil service salaries. From a personal liberty point of view, he's almost always been in the camp of the adversary, even the enemy. He's a glad-handing nobody, devoid of talent or virtue. But in the context of the D.C. Beltway, mostly inoffensive, like a beige kitchen appliance.

Kamala Harris, his vice presidential running mate, however, is actively dangerous. I don't believe she has any redeeming values, beyond ambition. A prosecutor her entire life, until she was elected as a U.S. senator in 2016, she impresses me as someone who tried to put people in jail primarily to add scalps to her belt in order to move up the ladder -- not promote justice. She's a thoroughgoing progressive and SJW, all-in for higher taxes, guaranteed annual income, free college, free medical for all, open immigration, special privileges for LGBTQ types, and the rest of it.

She's a wannabe Evita Perón, without the charisma. What I don't understand is how she got the nod for VP, since she had no support when she ran for president in 2019. She was quite unlikable -- at best she was smarmy. What kind of backroom deals were cut to put people like these forward to rule the world?

When Biden steps down -- assuming he's elected after the lawsuits and recounts end -- we could have Kamala for our new president. If so, I promise we'll wish for a return of Sleepy and Corrupt Joe. The Democratic Party has been captured by people who want to completely remake the U.S., to conform with the notions put forward by Black Lives Matter, Antifa, and similar groups.

I did an article two months ago explaining the six reasons why I thought Biden was going to win and why this was going to be the most important election in U.S. history -- certainly since that of 1860 -- which put Abraham Lincoln in office.

The 2020 election wasn't just a political election with economic consequences. It's much more serious. We're at a major cultural turning point in the U.S. In fact, we're on the edge of a cultural war. It could devolve into an actual civil war, as unlikely as that may sound to some. But the fact is that people in the blue counties and red counties can't even talk to each other anymore. They no longer share values, or have the same views on what's right and wrong, good or evil. Many actually hate each other.

I hasten to add that the unpleasantness of 1861 to 1865 was not a civil war; it was a failed war of secession -- a very different thing. A civil war is one where two or more groups are fighting for the control of the same territory, and the same central government. A civil war, if it happens, won't just be about political and fiscal differences, but cultural differences. That's much more serious.

Rachel: Do you think that there would be a higher likelihood of this civil war if Trump won, or if Biden won? Or do you think we're just at a bubbling-over point and it's inevitable?

Doug: You can't solve moral and cultural differences by passing more laws. If you put antagonistic tribes in the same political entity you're always asking for trouble. As little as 50 or 60 years ago there were some regional differences in the U.S., sure, but we generally shared the same values, traditions, beliefs, history, language, and religion. Race was a problem, but – at least before Washington started herding blacks into vertical ghettos, putting them on welfare, and destroying their families – things were getting better. Now the U.S. has turned into a multicultural domestic empire. Empires never end well.

The best possible outcome that we can have today is for the people in the left-leaning, so-called blue counties, and the right-leaning, so-called red counties, to separate in the manner of cantons in Switzerland.

Swiss cantons, you'll recall, pay a relatively small national defense tax. But all other government functions and taxes are local. In fact, that's pretty much the way the U.S. states once were. A return to that, however, is a longshot bet, because the Federal government has intruded into absolutely every area of American life.

Regarding the colors, red and blue, I said "so-called" because that differentiation was only made about 20 years ago. Historically, leftists have always been associated with red, not blue. But somebody in the media turned it on its head, and associated them with the color blue – the traditional conservative color. Nobody said "Wait... that's ridiculous. Red has been the color of the left since at least the days of Karl Marx..."

Like so many things in today's Bizarro World, even traditional color associations have been reversed, further confusing the public. That's only a tangential observation, I know, but worthwhile noting.

In any event, the red and blue people are viscerally at odds. Trump wasn't the cause; he was only the catalyst. But it's broken up families; they can no longer voice even polite political opinions among each other.

Really deep philosophical differences divide Americans about moral issues, and the way the world should work. We're now looking at irreconcilable differences. The best way to solve them is for people to go their separate ways, as opposed to fight for control of the central government, and then impose their views on the losers.

I expect the U.S. itself is going to change form radically over the next few generations – much more even than the last 50 years. Allow me to make another seemingly outrageous prediction: the U.S. will probably break up into different regions – to start with.

But the U.S. is already no longer America. America was more than just a piece of geography; it was actually a unique and excellent idea, one that its citizens shared. But now many want to disavow everything from Columbus Day to Thanksgiving, its principles, its founders, and their ideas.

Many young people have been completely indoctrinated by four years of college, where they've been bankrupted financially and mentally; almost all the professors are hard-core leftists. The same is true of the high schools and grade schools, where kids absorb concepts by osmosis. Surveys show most Millennials think socialism is better than capitalism.

Rachel: Yes, that's very interesting. Do you think right now, the U.S. is like the "Stans" that are just arbitrarily drawn lines in a country, with no culture or shared beliefs holding us together?

Doug: Increasingly. The main things holding the country together now aren't values and traditions, but artifacts like fast food franchises, hotel chains, big box stores, the Interstate Highway System, and government-issued ID. And what you said is interesting, because the fact is that most of the countries in the world today are artificial constructs. Most countries in the world are... on the edge. It's not just the U.S.

Every country in Africa was assembled from completely arbitrary lines drawn in 19th-century boardrooms in Europe. As were every country in the Middle East and Central Asia. Frankly, even countries like China are likely to break up into five or six different entities corresponding numerous local languages, cultures, and traditions. The Communist Party is widely – but quietly – viewed as a scam to benefit mainly its members. Of course, Inner Mongolia, Tibet, and Xinjiang are all actually different countries that have antagonistic relations with the Han Chinese and Beijing.

We'll see not only the breakup of the ill-advised European Union, but the breakup of countries in Europe itself.

The colors on the map on the wall are always running. And this is one of those times. It's like the paleontological concept of punctuated equilibrium, where things go along for a long time without changing, and then all of a sudden they change radically.

I think we're at a point like that right now, both within the U.S. and around the world. It's going to be a turbulent time, lasting at least through this decade, probably longer. It will resemble the 1930s and '40s a lot more than the '50s and '60s.

Rachel: That's a stressful outlook, but it could be a very interesting time to live through. And especially right now.

Doug: You know the old Chinese saying about interesting, don't you?

Rachel: No... But I know about the Chinese symbol for crisis and opportunity being the same, as in the Crisis Investing letter.

Doug: Good point. But it's a Chinese curse, "may you live in interesting times."

In history, "interesting" can be a euphemism for "buckle up, it's going to be a bumpy ride."

Rachel: In some ways, it might be better to have things boil over rather than sit here, worrying about it, just simmering forever.

So, you think that there's going to be a lot of countries breaking up around the world. What's your best guess for the U.S.? I mean a lot of people think, "Okay, the war of secession." That was just the North and the South.

But do you think that there's actually more like five or six different countries that the U.S. should be broken up into politically, culturally?

Doug: Yes, I do. And there have been a few papers and books written on the subject. For instance, young Chicano males in Southern California and Texas have absolutely nothing in common with elder-

ly female Medicare recipients in Massachusetts. And as various government welfare systems go bankrupt, they're not going to want to pay for old white women with whom they have absolutely nothing in common. Nor should they, quite frankly.

The Hispanic areas of the Southwest are going to move towards independence, viewing it as the Reconquista. Ecotopia in Northern California, Oregon, Washington – and for that matter, British Columbia – have nothing in common with the Rust Belt, or the Deep South. The farming regions in the middle of the country have nothing in common with the BosWash corridor.

This type of thing is a natural evolution throughout 5,000 years of recorded history. It's nothing new. It's normal and natural. The political lines on the map aren't part of the cosmic firmament.

Rachel: Yes. I mean, empires typically have a shelf life, correct? And we've exceeded that, don't you think?

Doug: Like I said, the U.S. has devolved into a multicultural domestic empire, and hopefully it will come apart peacefully. The way Yugoslavia did into six countries, the Soviet Union did into 15, and Czechoslovakia into two. The outcome can be salubrious and peaceful – unless somebody, a modern Lincoln equivalent, tries to hold the country together by force.

Rachel: I guess we can only hope for as peaceable a solution as possible.

Thank you for your insights today, Doug.

Doug: Thanks, Rachel.

Rasmussen: One Third of Democrats Believe Election Stolen from Trump

While the election hasn't been certified, and the results are pending, the media has effectively crowned Joe Biden the victor in the 2020 election, and voters have some strong opinions on the matter.

According to a Rasmussen poll conducted November 17-18, nearly half of likely voters, 47 percent, believe the election was stolen from Trump. If Joe Biden is ultimately certified as the winner, there will undoubtedly be a big fat asterisk on his presidency. This should be very concerning for Joe Biden. President George W. Bush had the 2000 election cast a dark shadow over his presidency, with many Democrats to this day refusing to acknowledge his presidency as legitimate. If Biden is confident in the legitimacy of the results as they stand now, he should be willing to let the process continue, and should publicly express his support for this.

But, Joe Biden's problems are not simply because many Republicans believe the election was stolen. It's true that the poll showed a significant partisan divide on this issue: 75 percent of Republicans believe it is very likely (61 percent) or somewhat likely (14 percent) that the election was stolen from Trump. But, according to the poll, while 69 percent of Democrats say it is not at all likely (61 percent) or not very likely (8 percent) that the election was stolen from Trump, 30 percent of Democrats believe it is very likely (20 percent) or somewhat likely (10 percent) that it was.

Let me repeat, nearly a third of Democrats believe it is likely that the election was stolen from President Trump. That's a remarkable number. Huge, in fact.

Despite the fact that nearly half of all voters believe the election was likely stolen from Trump, 61 percent believe Trump should concede. How many Democrats believe it is likely that the election was stolen, but think Trump should concede anyway? That's quite a disturbing thing to consider.

No matter what happens, Americans' faith in our elections has taken a huge hit this year. It's not uncommon for the losing party to feel things were unfair, but this is clearly the moment for big changes to happen to restore our faith in our elections to ensure that Americans can feel confident in our elections regardless of the results.

Stealing the Presidency



The left-wing news media didn't just poison the information environment with their incessantly negative coverage of President Trump going into the 2020 election. They also refused to give airtime to important arguments of the Republican campaign — both pro-Trump and anti-Biden — which meant millions of voters cast their ballots knowing only what the media permitted them to know about the candidates.

To measure the true effect of the media's censorship on the election, the Media Research Center asked The Polling Company to survey 1,750 Biden voters in seven swing states (Arizona, Georgia, Michigan, Nevada, North Carolina, Pennsylvania and Wisconsin), six of which (all but North Carolina) were called for Biden (survey details below). We tested these voters' knowledge of eight news stories — all important topics that our ongoing analysis had shown the liberal news media had failed to cover properly. We found that a huge majority (82%) of Biden voters were unaware of at least one of these key items, with five percent saying they were unaware of all eight of the issues we tested.

This lack of information proved crucial: One of every six Biden voters we surveyed (17%) said they would have abandoned the Democratic candidate had they known the facts about one or more of these news stories. A shift of this magnitude would have changed the outcome in all six of the swing states won by Joe Biden, and Donald Trump would have comfortably won a second term as president.

Here's what we found:

? Burying Biden's Bad News: The media's censorship of Biden's scandals had the strongest impact on this year's election. According to our survey, more than one-third of Biden voters (35.4%) were unaware of the serious allegations brought against the Democratic nominee by Tara Reade, a former staffer who said Biden sexually assaulted her in the 1990s.

If they had known about Tara Reade's sexual assault allegations, 8.9% told us they would have changed their vote — either switching to Trump or a 3rd party candidate, not voting for any presidential candidate, or not voting at all. By itself, this would have flipped all six of the swing states won by Biden (Arizona, Georgia, Michigan, Nevada, Pennsylvania and Wisconsin), giving the President a win with 311 electoral college votes.

Even more Biden voters (45.1%) said they were unaware of the financial scandal enveloping Biden and his son, Hunter (a story infamously censored by Twitter and Facebook, as well as ignored by the liberal media). According to our poll, full awareness of the Hunter Biden scandal would have led 9.4% of Biden voters to abandon the Democratic candidate, flipping all six of the swing states he won to Trump, giving the President 311 electoral votes.

The ticket's left-wing ideology was another issue barely mentioned by the national press. A GovTrack analysis found Biden's running mate, California Senator Kamala Harris, had the most left-wing record of any Senator in 2019 (even more than self-described socialist Bernie Sanders). Our poll found that 25.3% of Biden voters said they didn't know about Senator Harris's left-wing ideology. If voters had the complete story, it would have led 4.1% of Biden voters to change their vote, flipping Arizona, Georgia, Nevada, Pennsylvania and Wisconsin to Trump. The result would have been a Trump victory, with 295 electoral college votes.

? Hiding Trump's Successes: The liberal media also prevented many Biden voters from learning about record-breaking positive economic news in the months leading up to the election. The five pre-election jobs reports from June 5 to October 2 showed a record 11,161,000 jobs were created in the extraordinary snapback from the pandemic recession. Yet a large number of Biden voters (39.4%) said they didn't know about this achievement. If they had, 5.4% said they would have changed their vote; this would have swung Arizona, Georgia, Nevada, Pennsylvania and Wisconsin to Trump, who would have won with 295 electoral votes.

On October 29, the government reported a huge jump in economic growth — 33.1% on an annual basis, double the previous record. Yet nearly half of Biden voters (49.0%) said they had no idea about this record-breaking achievement. Armed with that information, 5.6% said they would have changed their vote, swinging Arizona, Georgia, Nevada, Pennsylvania and Wisconsin and a total of 295 electoral votes to Trump.

We saw the same effect when it came to foreign policy. The President and his team made history by brokering peace agreements with Israel and several of her Arab neighbors — one reason Trump received three nominations for the Nobel Peace Prize. Yet 43.5% of

Biden voters had no idea about these historic agreements. The information would have led five percent of overall Biden voters to change their vote, putting Trump in front in Arizona, Georgia, Nevada, Pennsylvania and Wisconsin, for a total of 295 electoral votes.


Energy independence was another Trump success. The President took action to start long-stalled pipeline projects and expand drilling offshore and in the Arctic, and it paid off with America becoming a net exporter of oil for the first time in September 2019. More than half (50.5%) of Biden voters said they did not know about this important accomplishment, either. If the information was known by all, 5.8% of Biden's voters say they would have changed how they voted. This would have changed the outcome in Arizona, Georgia, Nevada, Pennsylvania and Wisconsin, putting Trump in front with 295 electoral college votes.

One important issue that did get a lot of coverage in 2020: the coronavirus pandemic. But what made the news every night was criticism of the President and his administration. Lost in the blistering barrage of bad news were successes such as Operation Warp Speed, which even before the election was well on track to deliver 300,000,000 doses of a safe vaccine as soon as next year.

Our poll found 36.1% of Biden voters said they did not know about the administration's key role in promoting vaccine research through Operation Warp Speed. If they had, 5.3% told us they would have abandoned Biden, flipping Arizona, Georgia, Nevada, Pennsylvania and Wisconsin, giving the President 295 electoral votes.

? Putting It All Together: Looking at all eight of these issues together, our poll found that a total of 17% of Biden's voters told us they would have changed their vote if they had been aware of one or more of these important stories. This would have moved every one of the swing states into Trump's column, some by a huge margin. The President would have trounced Biden in the electoral college, 311 to 227.

In Pennsylvania, 15% of Biden voters said they would have defected. Using the reported vote totals as of noon on November 19, this would have reduced his total by 518,204 votes, flipping the state to Trump. In Michigan, the percentage who would have left Biden was

14%, deducting 392,966 from his tally and flipping that state, too.

In Georgia, 15% of Biden's voters say they would have defected based on full information, taking 370,838 votes out of his column, and putting Trump comfortably ahead. In Arizona, 21% say they would have changed their vote, deducting 351,150 from Biden's column and putting Trump in front there, too.

In Wisconsin, Biden would have lost 13% of his voters, taking away 211,987 from his column. In Nevada, the percentage of those who would have left Biden was 18%, or 126,627 voters. Such a shift would have put both of those states in Trump's column, too.

[In the final state we polled, North Carolina, 21% of Biden's voters say they would have changed their minds, deducting 563,703 votes from his total and significantly bolstering Trump's margin of victory in that state.]

It's important to note that not all of these voters would have switched to President Trump, of course (although about 6% of Biden's voters say that's exactly what they would have done). Just by choosing to abandon Biden, these voters would have handed all six of these states, and a second term, to the President — if the news media had properly informed them about the two candidates.

The most basic principle of our electoral system is that our leaders are chosen by the people themselves. But if the people are given systematically one-sided information, with crucial facts omitted, then the real power to choose has been stolen from them.

This unique study of the media and voters suggests that's exactly what happened in 2020.

For this report, The Polling Company conducted a national survey of 1,750 individuals living in Arizona, Georgia, Michigan, Nevada, North Carolina, Pennsylvania and Wisconsin who reported voting for Joe Biden in the 2020 election.

The survey was conducted entirely online, between November 9-18, 2020. The poll has an accuracy of +/- 2.34% at a 95% confidence interval.

Too Many Elites



In the December issue of *The Atlantic* magazine there is an interesting if not intriguing interview with Peter Turchin, a University of Connecticut professor with unique ideas on human history.

Turchin is actually a zoologist. He spent his early career analyzing population dynamics. Why does a particular species of beetle inhabit a certain forest, or why does it disappear from that same forest? He developed some general principles for such things, and wondered if they apply to humans, too. Answering that requires data, so he went from studying beetle history to human history.

Financial consultant John Mauldin gives his take on this interview and how it applies to us today in the western world.

Mauldin mentions that one recurring pattern that Turchin noticed is something he calls “elite overproduction.” This happens when a society’s ruling class grows faster than the number of rulers it needs. (For Turchin, “elite” seems to mean not just political leaders but all those managing companies, universities, and other large social institutions as well as those at the top of the economic food chain.)

As *The Atlantic* describes it:

One way for a ruling class to grow is biologically—think of Saudi Arabia, where princes and princesses are born faster than royal roles can be created for them. In the United States, elites overproduce themselves through economic and educational upward mobility: More and more people get rich, and more and more get educated. Neither of these sounds bad on its own. Don’t we want everyone to be rich and educated? The problems begin when money and Ivy League degrees become like royal titles in Saudi Arabia. If lots of people have them, but only some have real power, the ones who don’t have power eventually turn on the ones who do...

Elite jobs do not multiply as fast as elites do. There are still only 100 Senate seats, but more people than ever have enough money or degrees to think they should be running the country.

“You have a situation now where there are many more elites fighting for the same position, and some portion of them will convert to counter-elites,” Turchin said.

The excess elites become counter-elites, who then try to make alliances with the lower classes which usually don’t work out. But Mauldin’s eyebrows went up when he saw how Turchin describes the endgame.

The final trigger of impending collapse, Turchin says, tends to be state insolvency. At some point rising insecurity becomes expensive. The elites have to pacify unhappy citizens with handouts and freebies—and when these run out, they have to police dissent and oppress people. Eventually the state exhausts all short-term solutions, and what was heretofore a coherent civilization disintegrates.

Terrifying? Yes. It sounds amazingly like what the World Economic Forum proposes. I am sure Klaus Schwab and the others there recognize the frustration that many people have. They are proposing programs to alleviate that frustration—expensive, society-altering programs. But they would still let the game at the top continue.

But it gets worse.

Instability Spikes

In 2010, the scientific journal *Nature* published a collection of opinions looking ahead 10 years, i.e., where we are right now. *Nature* then published a short response from Turchin in its February 2010 issue.

Quantitative historical analysis reveals that complex human societies are affected by recurrent—and predictable—waves of political instability (P. Turchin and S.A. Nefedov, *Secular Cycles*, Princeton Univ. Press; 2009). In the United States, we have stagnating or declining real wages, a growing gap between rich and poor, overproduction of young graduates with advanced degrees, and exploding public debt. These seemingly disparate social indicators are actually related to each other dynamically. They all experienced turning points during the 1970s. Historically, such developments have served as leading indicators of looming political instability.

Very long ‘secular cycles’ interact with shorter-term processes. In the United States, 50-year instability spikes occurred around 1870, 1920, and 1970, so another could be due around 2020. We are also entering a dip in the so-called Kondratiev wave, which traces 40-60-year economic growth cycles. This could mean that future recessions will be severe. In addition, the next decade will see a rapid growth in the number of people in their twenties, like the youth bulge that accompanied the turbulence of the 1960s and 1970s. All these cycles look set to peak in the years around 2020.

Again, that was from 2010. Right on schedule, we are experiencing the “instability spike” Turchin says tends to come along every 50 years.

Why 50 years? It relates to the human lifespan. Consider who was “in charge” during the period around 1970. We Baby Boomers were all 25 or younger at the time. Managing the chaos fell on older generations, who remembered it well and spent the rest of their lives trying to prevent more of it. But after 50 years or so, they are mostly gone. We who remain must learn the lesson again.

Mauldin has explained before about Neil Howe’s “Fourth Turning” idea, and George Friedman’s geopolitical cycles, both of which are peaking in this decade. Interestingly, Friedman also sees a different

geopolitical 50-year cycle playing out in the mid- to late '20s. Which overlaps with his 80-year geopolitical cycle for the first time. The mid- to late '20s should see the climax of Neil Howe's Fourth Turning. Now we see Peter Turchin postulating a similar time frame for different reasons. None of them, to Mauldin's knowledge, expected the pandemic we are now experiencing. What is its effect?

Well, we know the pandemic triggered a recession that may, before it's over, rival the Great Depression. For millions of Americans, it is not just something they read about. They feel it.

You've probably seen this famous 1931 photo of Al Capone's Chicago soup kitchen.



The 2020 equivalent is this from Mauldin's former hometown Dallas this November.



We do see progress in these images. The people obviously have cars and fuel. Those were elite luxuries in 1931. Some of these people may be educated and intelligent, but they're not elites. Actual elites don't have to wait in line for food. They call Whole Foods or Door-Dash and have it delivered.

The problem, borrowing Turchin's framework, is that some thought

they were elites, or if not exactly thinking of themselves as elite, did enjoy the benefits of good jobs, at least until recently. This year took away that illusion, and they're naturally disappointed. They may join the "counter-elites" and seek more power.

This is where we are. The hard times we've long anticipated are here. That 1931 soup kitchen photo was just the beginning of a long, dark period. It got a lot worse.

Will our situation similarly worsen? That remains to be seen. As Mauldin says, good things keep happening even in the darkness. The mRNA technology behind the new coronavirus vaccines may lead to breakthrough treatments for other conditions. mRNA technology allows the delivery of specific proteins to the human body. If you have a disease, and there are many of them that simply come along as part of the process of aging, it may soon be possible to deliver specific proteins that cure or at least mitigate your condition.

Mauldin wants to further explore Peter Turchin's ideas, but in fairness to him, he wants to read more of his work first.

Mauldin believes we are now at what Turchin calls the final stage, when elites try to pacify the masses with bread and circuses. Doing so racks up the debt and suppresses economic growth. Debt is accumulating faster than Mauldin expected, so "The Great Reset" may happen sooner than expected.

Whenever it comes, we should welcome it. Mauldin believes the alternatives may be even worse.

Wall Street bets on Biden win, GOP majority Senate, divided government, and smaller stimulus



Wall Street Bets on Biden



Wall Street is betting on Joe Biden winning the presidency, Republicans controlling Congress, and a divided government. As a result, there'll be a much smaller stimulus package in early 2021 and few, if any, tax hikes.

"Gridlock is the most likely outcome," Brian Gardner, chief policy analyst for Stifel & Co. in New York, told clients in a report, predicting that the GOP would retain control of the Senate.

"Progressives had their wings clipped" Gardner wrote. Bad feelings between leftist Democrats and conservative Republicans "will likely prevent widespread collaboration." He expects Congress, with the GOP in control of the upper chamber, will disappoint investors by spending less than the Democrats' promised \$2 billion to prop up the economy, though more highway spending is likely.

"The likelihood that the Senate will not flip to the Democrats gives comfort that major legislation is unlikely," James M. Meyer, chief investment officer at West Conshohocken-based Tower Bridge Advisors, which invests over \$1 billion, told clients in a note. "That leaves the economic reins in the hands of the Fed. Investors should like that."

Meyer added that, if the Senate remains Republican, "the stock market barely reacts to social unrest, crude political speech, wars, or climate change." It reacts, instead, to corporate profits and Federal Reserve interest rates. "No one can fault investors who want to see more of the same": cheap borrowing rates, modest but steady growth, and "hopefully, an end to the pandemic sometime in 2021."

Which sectors benefit

In response, the Dow Jones Industrial Average jumped 367 points on Nov 5 to close trading at 27,847.

A divided Congress is unlikely to pass drug-pricing limits, so that's a good outcome for pharmaceutical companies, while a Biden presidency, even without full congressional support, could bring "a more rigorous and thoughtful approach to science," Geoffrey Porges, analyst at SVB Leerink, told investors in a note excerpted in Endpoints News, a drug industry newsletter.

The GOP majority "takes extreme scenarios off the table, including large tax hikes, major health care changes, and a huge stimulus package," said Jeff Mills, chief investment officer of Bryn Mawr Trust Wealth.

Biden has said he would only raises taxes on the wealthy, on those who make more than \$400,000 a year.

Strange as it sounds, divided governments often result in stock prices moving higher.

"Ultimately a gridlock scenario ends up being a good thing. We can start to focus on earnings, vs. handicapping major swings in policy," Mills said.

Key takeaways for investors under this scenario include a weaker U.S. dollar, compared with other currencies.

"We see pressure on the dollar under a Biden presidency, with a reversal of tariffs and trade policy," Mills said. Tariffs tend to tamp down growth internationally, so scrapping the Trump-era tariffs would have the opposite effect.

"If tariffs are reversed, on a net basis, that's better for growth in international markets, but has the opposite effect on the U.S. dollar," he said.

Interest rates: With a smaller stimulus package, that means less possibility of inflation in the U.S. economy, Mills said.

"If we get a stimulus package, it won't happen until Congress is sworn in Jan. 3, and then likely wouldn't pass before February," he said.

Less inflation means less likelihood of higher interest rates, so yields on Treasury bonds have dropped early today in trading.

Trumps Plan A and Plan B

Health care: This sector, which includes insurers, biotechnology, and pharmaceuticals, is “the biggest winner,” Mills said, since changes to the Affordable Care Act or a so-called “public option” would be off the table.

“That was weighing on this area of the market.”

Big Technology: Should the GOP continue to control the Senate, regulatory scrutiny of Big Tech will likely fade, which prompted share prices of Facebook (FB) and Amazon (AMZN) to rise in early trading.

Marijuana legalization: Voters in New Jersey, Arizona, Montana, and South Dakota legalized recreational marijuana, and now 1 in 3 Americans live in a state where adult pot use is legal.

The results sent a mild ripple through the marijuana sector. Shares of Canadian companies were down 7 to 9 percent. Canadian cannabis companies cannot own assets in the United States and they cannot sell Canadian grown marijuana in the U.S. So they had nothing to gain from the four states legalizing.

Stocks in the American-owned multistate operators — among which Cresco Labs and Green Thumb Industries are the largest — were flat to slightly up, according to analysts.

“On the whole, it was a wash,” said Pablo Zuanic, analyst for Cantor Fitzgerald

Pot sales tax revenue will help cash-strapped New Jersey and towns that allow and tax marijuana retailers, but it could take “two to three years” to start collecting even limited revenues, and by then neighboring states will have likely cut into New Jersey sales, Baye Larsen, vice president at Moody’s Investors Service, said in a report.

More drug-related initiatives were also passed, with Oregon becoming the first in the nation to decriminalize possession of “hard drugs,” while D.C. voters approved a measure decriminalizing “magic mushrooms” and other organic psychedelics. Denver, Oakland and Santa Cruz passed similar proposals.

Muni bonds: “As the economy improves and we get to a vaccine, we should see higher [interest] rates no matter who is finally elected President,” wrote David Kotok, municipal bond and fixed income investor with Cumberland Advisors. For now, however, interest rates remain low.

“Munis should be fine,” he wrote, although these bonds “will probably not get a tax-increase boost right away, from a demand/supply standpoint they are in very good shape.”

Until a second stimulus bill passes Congress, “we may see some additional actions from the Federal Reserve to shore up markets if needed. We also expect further jawboning from the Fed to Congress on the importance of additional stimulus.”

Tax moves: Hank Smith, head of investment strategy at Haverford Trust said if Biden wins, and the Senate remains Republican, there is “no shot of any major legislation, tax increases or state tax changes” including a wealth tax passing Congress, he noted.

“We won’t see anything crazy in the cabinet because everything has to be approved by the Senate. Elizabeth Warren will not become Treasury secretary. All Biden will be able to do is issue executive orders,” Smith said.

Trump’s Plan A and Plan B



In the Marine Corps I was taught to always have a Plan B. I thought about how cavalier president Trump is these days going about his everyday duties amidst the tremendous pressures he is facing to maintain his presidency and I thought maybe he has a Plan B.

On November 23, I listened to Mike Adams on his *Natural News* show where he clued me in on a few schemes that president Trump has in his repertoire. For the sake of

simplicity, I will call them Plan A and Plan B.

Adams said president Trump realizes that if he loses the election, he likely faces prison because his enemies will do just about anything to incarcerate and shut him up. Thus, Adams believes Trump has nothing to lose and everything to gain to do everything possible to keep himself in power.

Adams is also confident that Trump will be reelected as president.

In support of this Adams was informed by congressman Mo Brooks of Alabama that on Jan 6 Congress will meet to gather the electoral votes. At this meeting the Senate Majority Leader Mitch McConnell will preside over the House of Representatives who will count the votes as they are read in alphabetical order by states. After the votes are read, the question is asked are there any present who objects to the vote and, according to Mo Brooks, if there is just one Senator and one member of the House who objects, then the entire vote is not accepted. Usually no one objects because one candidate has already conceded by that time. But if Trump has not conceded, the possibility of one Senator and one House member objecting is great. If that happens and the vote is not accepted, the process is transferred to the House of Representatives. Representative Brooks said at that point, it is not clear what happens. The Founding Fathers simply did not provide language to cover this possibility.

According to Brooks if this happens there are two possible outcomes. The first is that each state in the House will be accorded one vote to select the president and the Senate will select the Vice President.

In this scenario it is possible for Trump to be chosen as president by the House and perhaps Harris as Vice President by the Senate.

The other scenario is that every member of the House will get one vote and because the Democrats have the majority in the House, they would select Biden as president.

But representative Brooks does not know which of these scenarios will come to pass. However, we do know that the procedure for each state getting one vote to select the president is in Article 12 of the Constitution. Because 31 of the 50 of the legislatures are controlled by the Republi-

cans it is expected that Trump would be selected as president under this procedure.

So, what is the bottom line for president Trump?

Provided he does not concede, apparently, there are several pathways for him to keep his presidency.

I describe the hierarchy of options available to president Trump as Plan A (the Legal Plan) and Plan B (the Military Plan).

Plan A the Legal Plan is using the Supreme Court to overturn the election. The underlying lawsuits (16 challenges in 4 states) have already been brought by attorneys Rudy Giuliani, Sidney Powell and Lin Wood. But this process takes time and these lawsuits may be too late to overturn the election. In a civil case only a preponderance of evidence is needed to prove the case. But the Supreme Court Justices are not mathematicians and they may not understand the voluminous statistical data that will be submitted in support of these lawsuits. Trump needs the Supreme Court to decide that because of the voter fraud, the election is "irrevocably tainted" and therefore must be voided.

But if the political winds are not right and the Supreme Court rules against Trump, he still has Plan B the Military Plan which is arguably quite radical in its application. Perhaps having this plan explains why president Trump has been so calm during this crisis.

According to Adams, Plan B the Military Plan envisions taking the jurisdiction of the matter from the civil courts and placing it within the Department of Defense (DoD) which is under the control of the president. Within the DoD is the Special Operations Forces consisting of the Army Rangers, Navy Seals and Delta Force. An indication that Plan B has been already initiated is the fact that president Trump recently fired career bureaucrat Mark Esper as the Director of the DoD and replaced him with Christopher Mills who then immediately ordered the Special Operations Forces to report directly to the president.

Back on September 12, 2018 Trump signed an executive order that stated: "the ability of persons located, in whole or in substantial part, outside the United States to interfere in or undermine public confidence in United States elections, including through the unauthorized accessing of

election and campaign infrastructure or the covert distribution of propaganda and disinformation, constitutes an unusual and extraordinary threat to the national security and foreign policy of the United States.”

In that order, Trump declared a national emergency, meaning the 2020 election took place under a national emergency order. This allowed Trump and white hat elements inside the DoD to set up a SCIF and monitor the election theft happening in real time. Trump allowed the Democrats to steal the election, in other words, so that they would entrap themselves in a grand scheme of treason and cyber warfare that would ultimately lead to perhaps the downfall of the entire Democrat party.
