## China and the Democratic Party

**T**he Democrats are the party of China, meaning the Chinese Communist Party, not the Chinese people, who seem to be of little interest to them.

That disinterest includes not just millions of Uyghurs, Tibetans, and Falun Gong practitioners, well known to have faced various forms of extreme malevolence from concentration camps to forced organ transplants, but just about any citizen of the country who evinces a public inclination for democracy.

The Democrats have been the party of this China for some time, even before the Obama administration when the relationship rose to a new level.

The endless talk of Trump-Russia collusion that began at the end of that administration and went on for three years, that anybody paying attention knew was fallacious from the start, was as an attempt to derail Donald Trump but also served as an ongoing and, at least partly, deliberate distraction from the real issue at the crux of global politics.

That issue is, of course, the Chinese communist's desire for world domination, far more threatening than the relatively weak, impecunious, and shrinking (in population) Russia.

### Intimate Connection

Many of us have known or suspected the intimate Democrat-China connection for a long time. Joe Biden all but spelled it out early in the campaign when he informed us "folks" that China "was not the enemy," before he had to walk it back for appearance's sake.

Not that that was of much moment to Senator Dianne Feinstein (D-Calif.) who had a Chinese agent as her chauffeur for twenty years and whose husband Richard Blum made a fortune in the People's Republic. (Former president Jiang Zemin was their Thanksgiving guest.)

Nor would it have disturbed Michael Bloomberg (D-N.Y., sometimes) who made even more of a fortune, a spectacular one, in fact, from his cooperation and kind words about the Chinese totalitarian regime that allowed him to distribute his real-time stock trading "Bloomberg Boards" throughout the most populous country in the world.

But these famous people are likely just the "tip of the iceberg," in the words Richard Grenell used on "Hannity" to describe the latest Democrat-China scandal.

Rep. Eric Swalwell, Democratic congressman from California's 15th district, was implicated in a Chinese "honey pot"-style spy situation with one Fang Fang, known locally as Christine Fang, an agent of China's Ministry of State Security (MSS).

Swallwell's district, as the congressman brags on his own website, has more PhD's than any other district in the United States, underscoring what William F. Buckley said years ago about preferring to be governed by the first 2,000 people in the Boston phone book than by the Harvard professorate.

Mr. Swallwell—who never seemed to have met a television camera he didn't like and is married with two young children—ran for president earlier in 2019 to little avail. He now seems destined for oblivion—we can hope.

But what of the rest of the “iceberg” to which Grenell refers? The FBI, after the presidential election, of course, more of that in a bit, has isolated other Chinese “honey trap” targets among California officials. Apparently the young ladies made the very liberal, tech heavy Bay Area a territory of special interest.

Grenell, who, it will be remembered, was recently acting Director of National Intelligence and therefore had access to a great deal of confidential information, had considerably more to say.

“Eric Swallwell did exactly what the Chinese wanted,” he told Sean Hannity. “We need to figure out, are there others? And I can tell you without giving away too much intelligence, this is the tip of the iceberg when it comes to the leverage that China is putting on our politicians. There are many, many more,” adding, “There's a variety of mayors, governors, senior people.”

### The Money

All of this about clandestine sex?

To some degree, apparently, but there's something likely more attractive in the long run or, as H.L. Mencken put it, “When somebody says it's not about the money, it's about the money.”

The Chinese have plenty of it and are willing to use it, knowing full well that everyone, well, nearly everyone, has his or her price, even renowned chemistry professors commuting to the Wuhan Institute of Technology, speaking of Harvard.

And speaking of money, we now have the revelation, as if we needed it, again coming after the election, that Hunter and Jim Biden, son and brother of the man the media has dubbed the president-elect, have long been under investigation for tax fraud and money laundering for money paid by the Chinese.

In essence, the Chinese Communist Party is attempting to buy, indeed has bought, a good part of the United States and the rest of the world by any means necessary.

Recently, I was told, they made a \$1bn offer for the port of Genoa, Italy, allegedly because that city is where the new internet cable hub for Europe is being constructed that will control all communications

for that continent.

So where have the FBI and the Central Intelligence Agency been in all this?

Why have they been so tardy in dribbling out the information, holding as much as they can until after the election, as noted. (We can add the recent revelations about Seth Rich, though not specifically about China, into the tawdry mix of crucial information revealed years late, clearly deliberately.)

It is my best guess that significant parts of the Central Intelligence Agency and the Federal Bureau of Investigation have long ago thrown in their lot with China. Whether consciously or unconsciously is hard to say.

Nevertheless, many of them must assume that the Chinese way is the way the world is going and, in some cases, don't even object, even assist.

In all cases, they, like so many, want to profit by the new order.

## China Plans to Control the Moon



### What China Accomplished:

**R**euters reported that China successfully landed a spacecraft on the moon's surface on Dec 1, 2020 in a historic mission to retrieve lunar surface samples.

According to the report, China launched its Chang'e-5 probe on Nov. 24. The non-crewed mission, named after the mythical Chinese goddess of the moon, aims to collect lunar material to help scientists learn more about the moon's origins.

The mission will attempt to collect 2 kg (4-1/2 lbs) of samples in a previously unvisited area in a massive lava plain known as Oceanus Procellarum, or "Ocean of Storms".

If the mission is completed as planned, it would make China the third nation to have retrieved lunar samples after the United States and the Soviet Union.

The lander vehicle that touched down on the moon's surface was one of several spacecraft deployed by the Chang'e-5 probe.

Upon landing, the lander vehicle is supposed to drill into the ground with a robotic arm, then transfer its soil and rock samples to an ascender vehicle that would lift off and dock with an orbiting module.

State broadcaster CCTV said it would start collecting samples on the lunar surface in the next two days. The samples would be transferred

to a return capsule for the trip back to Earth, landing in China's Inner Mongolia region.

China made its first lunar landing in 2013. In January last year, the Chang'e-4 probe touched down on the far side of the moon, the first space probe from any nation to do so.

### What China Really Plans:

Given their behavior in the South China Sea, the Straits of Taiwan and elsewhere, it's reasonable to expect that China's lunar goals have some geopolitical end in mind. For example, China could potentially establish a permanent settlement and radiation weapons designed to disrupt earth-based and satellite-based defense systems of the U.S. and its allies.

### What U.S. Should Do in Return:

The above is one more big reason to insist that U.S. technology not be made available to Chinese labs or firms working hand-in-hand with the Chinese military. China may achieve its goals in the long run, but there's no reason why the U.S. should help them. The best way to slow down a future Chinese military presence on the moon is to stop technology transfers to China today.

## Google Manipulated 6 Million Votes

## Google Manipulated 6 Million Votes

Tech expert and researcher for the American Institute for Behavioral Research and Technology Dr. Robert Epstein told Tucker Carlson on his Fox News program that Google manipulated search and other data, including using voting reminders, to manipulate the results of the 2020 election.

The Harvard Ph.D. and his 33-member research team watched tech giants Google, Yahoo, YouTube, Bing, and Facebook in three swing states—Arizona, North Carolina, and Florida—during the 2020 election. The former Psychology Today editor said his team “preserved 500,000 ephemeral experiences,” which he says are those short, quick bursts of information or experiences that disappear within seconds. He described “ephemeral experiences” in a 2019 interview and said how important it is to catch them in real-time.

“If you don’t monitor, you can’t go back in time and figure out what these companies were showing people because what they’re showing people is ephemeral. That’s the term that Google’s own employees use internally, they’re showing ephemeral experiences, those really short-lived experiences that kind of appear before your eyes and then disappear, like search results for example.”

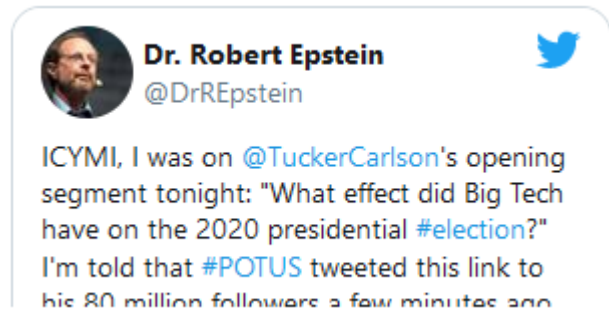
He told Carlson that the 500,000 ephemeral experiences his team captured in the lead-up to the 2020 election gleaned 30 times more data than they got in 2016.

Here’s what Google did.

“Google’s search results were strongly biased in favor of liberals and democrats. This was not true on Bing or Yahoo. The bias was being shown to pretty much every demographic group we looked at, including conservatives. In fact, conservatives got slightly more liberal bias in their search results than liberals did. How do you account for that? [...] These manipulations that we’ve so far quantified could easily have shifted at least six million votes in one direction. That’s the bare minimum at this point that I’m confident of. The maximum we haven’t even begun to estimate because we have so much data to look at.”

He says his team caught Google in the act and described what he called “a smoking gun.”

That was at least the margin of the election.



Epstein says this wasn’t unexpected. After all, in a leaked video from a 2018 all-employee meeting following the 2016 election, Google executives bemoaned the election results and vowed to do something about it in Trump’s re-election bid. But on Tucker Carlson Tonight, Carlson asked Epstein if “manipulations of one company, Google, could have determined the outcome of the election.” His chilling answer was, “yes.”

“We’ve been told this by nearly a year by whistleblowers from Google. We’ve seen it in leaked documents from Google, leaked videos from Google. There’s no question that they set about that after the 2016 election to make sure that President Trump, whom I do not support by the way, to make sure he is not reelected. And the massive amount of data that we’ve collected is consistent with what the whistleblowers and leaks have been telling us for a long time now, so yes, the answer is yes.”

After that video appeared in 2018, Epstein said they could shift more than six million votes to the Democrats. In the data that he and his researchers are culling, it’s probably many million more votes than that.

Breitbart was given the leaked tape that includes some stunning assessments of Trump and his voters.

These individuals, who preside over a company with unrivaled influence over the flow of information, can be seen disparaging the motivations of Trump voters and plotting ways to use their vast resources to thwart the Trump agenda.

Co-founder Sergey Brin can be heard comparing Trump supporters to fascists and extremists. Brin argues that like other extremists, Trump voters were motivated by “boredom,” which he says in the past led to fascism and communism.

The Google co-founder then asks his company to consider what it can do to ensure a “better quality of governance and decision-making.”

VP for Global Affairs Kent Walker argues that supporters of popu-

list causes like the Trump campaign are motivated by “fear, xenophobia, hatred, and a desire for answers that may or may not be there.”

Later, Walker says that Google should fight to ensure the populist movement – not just in the U.S. but around the world – is merely a “blip” and a “hiccup” in a historical arc that “bends toward progress.”

Another Google executive appeared to be crying in the video over the results of the 2016 election. Maybe the results of Google’s concerted manipulations in 2020 will turn her frown upside down.

After pushing the idea that a couple hundred thousand dollars in Russian Facebook ads, many seen after the election, stole the election for Trump in 2016, Democrats don’t have a leg to stand on if they want to push back on this assessment of Google’s powerful and frightening efforts. In fact, Epstein says Democrats will probably be happy about the results of the tech manipulation – until they’re in the crosshairs.

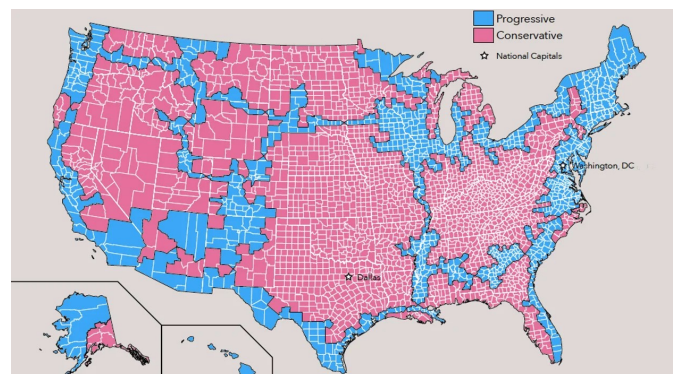

## How to split the USA into two countries: Red and Blue

Progressive America would be half as big, but twice as populated as its conservative twin.



America's two political tribes have consolidated into 'red' and 'blue' nations, with seemingly irreconcilable differences.

Perhaps the best way to stop the infighting is to go for a divorce and give the two nations a country each

Based on the UN's partition plan for Israel/Palestine, this proposal provides territorial contiguity and sea access to both 'red' and 'blue' America

If more proof were needed that the U.S. is two nations in one, it was offered by the recent mid-term elections. Democrats swept the House, but Republicans managed to increase their Senate majority. There is less middle ground, and less appetite for compromise, than ever.

To oversimplify America's electoral divide: Democrats win votes in urban, coastal areas; Republicans gain seats in the rural middle of the country. Those opposing blocs have consolidated into 'red' and 'blue' states decades ago.

Occasionally, and often after tight-run presidential elections, that divide is translated into a cartographic meme that reflects the state of the nation.

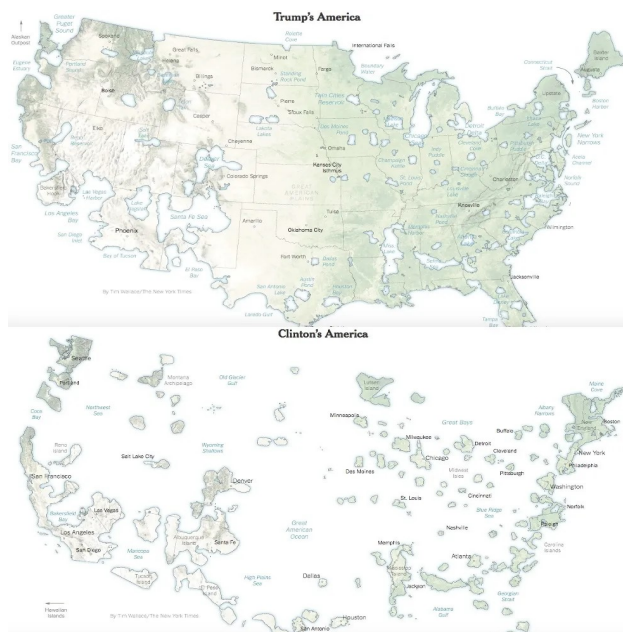
### Jesusland vs. the U.S. of Canada



Canada annexes the entire West Coast and borders Mexico.

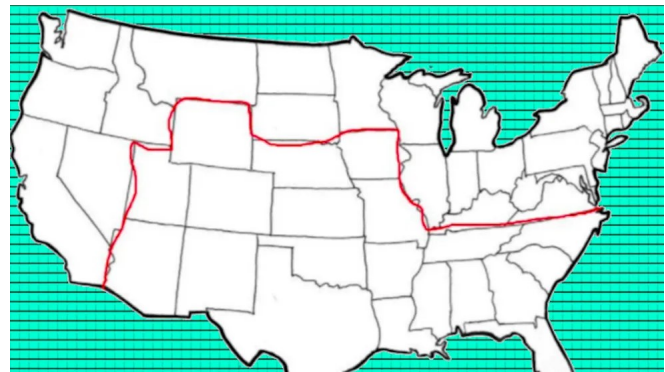
In 2004, this cartoon saw the states that had voted for Democratic presidential candidate John F. Kerry join America's northern neighbor to form the United States of Canada. The states re-electing George W. Bush were dubbed Jesusland.

### Trumpistan vs. Clintonesia



Trumpistan is a perforated continent, Clintonesia is a disjointed archipelago.

In 2016, these two maps disassembled the U.S. into Trumpistan, a vast, largely empty and severely punctuated land mass; and Clintonesia, a much smaller but more densely populated archipelago whose biggest bits of dry land were at the edges, with a huge, empty sea in the middle.



Following state borders, a line separates 'red' America (in the south) from the 'blue' half of the country.

Writing in The Federalist, Jesse Kelly in April 2020 likened America to a couple that can't stop fighting and should get a divorce. Literally. His proposal was to split the country into two new ones: a 'red' state and a 'blue' state.

On a map accompanying the article, he proposed a division of the U.S. into the People's Republic of Soyland and the Federalist States of America (no prizes for guessing Mr Kelly's politics).

It's a fairly crude map. For example, it includes Republican-leaning states such as Montana and the Dakotas in the 'blue' state for seemingly no other reason than to provide a corridor between the blue zones in the west and east of the country.

Mr Kelly admitted that his demarcational talents left some room for improvement: "We can and will draw the map and argue over it a million different ways for a million different reasons but draw it we must," he wrote. "I suspect the final draft would look similar (to mine)."

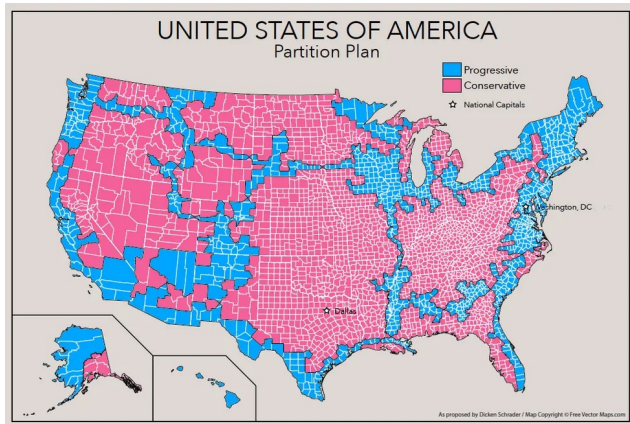

Partition, Palestine-style



A county-level division between red and blue, with contiguous territories for both.

"No, this map won't do," comments reader Dicken Schrader. "It's too crude and would leave too many members of the 'blue' tribe in the 'red' nation, and too much 'red' in the 'blue' state."

Agreeing with the basic premise behind Mr Kelly's map but not with its crude execution, Mr Schrader took it upon himself to propose a better border between red and blue.

Analyzing election maps from the past 12 years, he devised his own map of America's two nations, "inspired by the original UN partition map for Israel and Palestine from 1947." Some notes on the map:

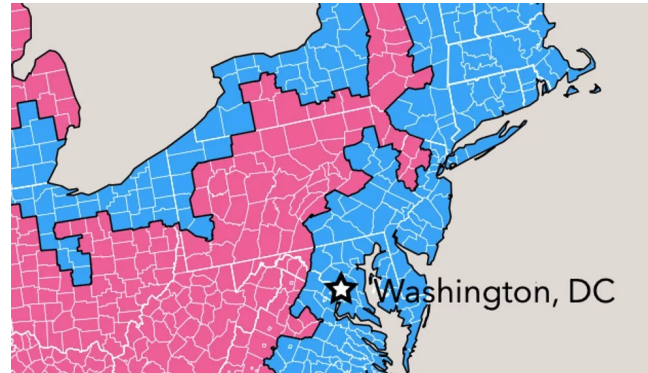
To avoid the distortions of gerrymandering, it is based on electoral majorities in counties, rather than electoral districts.

As with the UN partition plan for Israel/Palestine, all territories of both states are contiguous. There are no enclaves. Citizens of either state can travel around their nation without having to cross a border.

The intersections between both nations are placed at actual interstate overpasses, so both states have frictionless access to their own territory.

In order to avoid enclaves, some 'blue' islands had to be transferred to 'red', and some 'red' zones were granted to the 'blue' nation. "This exchange is fair to both sides, in terms of area and population".

Both nations have access to the East, West and Gulf Coasts, and each has a portion of Alaska.



Washington DC would remain part of 'blue' America, and its capital.

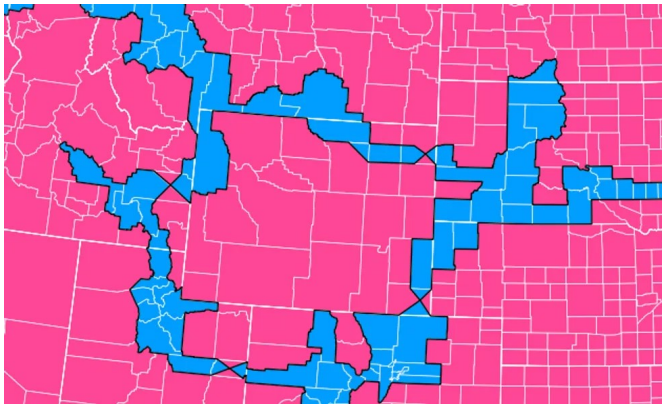

The partition would not create enclaves, but allow citizens of either nation frictionless access to the entire territory of their state.

'Blue' America would be roughly half the size of 'red' America but have almost double the population.

In terms of area, 'blue' America would be the 13th-largest country in the world, larger than Mexico but smaller than Saudi Arabia. 'Red' America would be the 6th-largest country in the world, larger than India but smaller than Australia.

In terms of population, 'blue' America would now be the 5th-most populous country in the world, with more population than Brazil but less than Indonesia. 'Red' America would be the 12th, with more population than Ethiopia but less than Japan.

For those who think this divorce would end the argument between both tribes, consider that both countries would still have to live next to each other. And then there's the question of the kids. Or, in Mr Schrader's translation to geopolitics: "Who gets the nukes?"

- Most people who have an opinion are probably wrong.
- If people don't know who you are, they are more likely to

reject you.

- Nobody wakes up and says, "Today is the day I make some unknown person a superstar!"
- Most people don't care about their jobs. Which is fine. But don't rely on them for your success.
- Even successful people don't want you to skip the line. I always hear, "You have to pay your dues." This is BS. It means:
- You have to take control of your own career and opportunities.
- You have a first book? Self-publish it. You have an indie movie? Load it up on Amazon. You have an idea for a radio show? Do a podcast.
- You have an app you want to build? Don't raise money. Save money and build it and get customers.
- You want to be a movie star? Write your own script or shoot your own movie (i.e., Sylvester Stallone in Rocky).

Most people can't be entrepreneurs or creatives. Don't believe anyone who says everyone can be an entrepreneur.

They are lying.

Most people can't handle nonstop rejection and the anxiety and depression that comes with it.

I've been so depressed so many times. It really hasn't been worth it, to be honest.

It's a catch-22 because in order to be good, you have to be unique. In order to be unique, nobody will know you. And nobody does favors for the unknown.

Dr. Seuss' first book was rejected 27 times. "Too different from other juveniles on the market to warrant its selling," wrote one top editor.

Harry Potter was rejected by every publisher until the 7-year-old daughter of one publisher begged her father to publish it.

If Moses wrote the 10 Commandments today, he'd be rejected by every publisher and probably give up. I would if I were him.

Even 50 Shades of Grey started off self-published.

It sold 250,000 copies on Amazon and still was rejected by many publishers. Amazon's in-house publisher rejected it.

Finally Simon & Schuster published it. It sold over 125 million copies.

Don't trust anyone. Don't listen to anyone. Ignore them.

Either give up or go around the gatekeepers.

So I did an experiment:

I took 50 Shades of Grey and hired someone in India to take a thesaurus and change every word in the book.

For instance, "She hurried to her tests" became "Brenda rushed to get to the exams on time."

I used a fake name, changed the title, made a book cover and uploaded it to Amazon. It's now a published book.

It's EXACTLY 50 Shades of Grey but with every single word changed, sentence by sentence. Maybe... just maybe... I was hoping

it would also sell a lot of copies.

It sold about 80 copies. It's a piece of s\*\*\*.

But it cost me about \$200 in total and two hours of my time. It was an experiment.

Why did 50 Shades of Grey sell so well? What did E.L. James do? Doing my failed experiment forced me to learn.

Why did "50 Shades" succeed?

- She had a platform. She probably had about a million people following her Twilight fan fiction on various fan fiction websites.

- 50 Shades of Grey came out around the same time the Kindle was getting popular. So people could read her soft-core porn book in public without anyone seeing what they were reading. Avoiding the stigma.

- It was unique.

She had a platform. And technology and timing were just right. But she would never know that unless she had experimented, built a platform, wrote her own book without "permission," and self-published.

Good for her.

This is not about self-publishing. This is not about how people are stupid (well, it is a little).

This is about not waiting for permission.

This is about doing experiments with everything you care about.

And from every experiment you will learn. There's no other way to learn.

A billion people are standing in the way of what you want to do.

Stupid people, mean people, people who hate you, people who don't want you to get ahead. People who will even sabotage you.

People who are frustrated in their own lives, dealing with their own problems, sad, anxious, fearful.

Experiment with how to get around them. Every day. It's not their fault. But that doesn't matter. You have to go around them.

You have to experiment every single day.

I'm doing another experiment right now. I am loving this experiment. So far, over three million people have seen this experiment.

It's not really working the way I expected. But we'll see. It'll probably fail. But I've stopped caring.

## The Insurrection Act of 1807



**T**he past few days has seen much discussion among conservative pundits about president Trump invoking the Insurrection Act. It's possible that after January 6<sup>th</sup>, president Trump may very well do that. Therefore, I decided to write an article about it.

The Insurrection Act of 1807 gives U.S. presidents the authority to deploy active-duty military to maintain or restore peace in times of crisis. The Insurrection Act was invoked numerous times in the 20th century, most famously when Dwight D. Eisenhower sent the 101st Airborne Division to enforce the desegregation of public schools in Little Rock, Arkansas.

The Insurrection Act of 1807 is a United States federal law (10 U.S.C. §§ 251–255; prior to 2016, 10 U.S.C. §§ 331–335; amended 2006, 2007) that empowers the President of the United States to deploy U.S. military and federalized National Guard troops within the United States in particular circumstances, such as to suppress civil disorder, insurrection and rebellion.

The act provides a "statutory exception" to the Posse Comitatus Act of 1878, which limits the use of military personnel under federal command for law enforcement purposes within the United States.

Before invoking the powers under the Act, 10 U.S.C. § 254 requires the President to first publish a proclamation ordering the insurgents to disperse. As part of the Posse Comitatus Act of 1878, these provisions are now codified as amended.

There are Constitutional exceptions to Posse Comitatus restrictions rooted in the President's own constitutional authority. Defense Department guidelines describe "homeland defense" as a "constitutional exception" to Posse Comitatus restriction, meaning that measures necessary to guarantee National Security from external threats are not subject to the same limitations.

### Purpose and content

The Act empowers the U.S. president to call into service the U.S. Armed Forces and the National Guard:

when requested by a state's legislature, or governor if the legislature cannot be convened, to address an insurrection against that state (§ 251),

to address an insurrection, in any state, which makes it impracticable to enforce the law (§ 252), or

to address an insurrection, domestic violence, unlawful combination or conspiracy, in any state, which results in the deprivation of Constitutionally-secured rights, and where the state is unable, fails, or refuses to protect said rights (§ 253).

The 1807 Act replaced the earlier Calling Forth Act of 1792, which had allowed for federalization of state militias, with similar language that allowed either for federalization of state militias or use of the regular armed forces in the case of rebellion against a state government.

The 1807 Act has been modified twice. In 1861, a new section was added allowing the federal government to use the National Guard and armed forces against the will of the state government in the case of "rebellion against the authority of the government of the United States," in anticipation of continued unrest after the Civil War. In 1871, the Third Enforcement Act revised this section (§ 253) to protect Black Americans from attacks by the Ku Klux Klan. The language added at that time allows the federal government to use the act to enforce the Equal Protection Clause of the Fourteenth Amendment to the United States Constitution. This section of the act was invoked during the Reconstruction era, and again during desegregation fights during the Civil Rights Era.

The chief clause of the Insurrection Act, in its original 1807 verbiage (which has been thoroughly updated since to reflect modern legalese), reads:

An Act authorizing the employment of the land and naval forces of the United States, in cases of insurrections Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That in all cases of insurrection, or obstruction to the laws, either of the United States, or of any individual state or territory, where it is lawful for the President of the United States to call forth the militia for the purpose of suppressing such insurrection, or of causing the laws to be duly executed, it shall be lawful for him to employ, for the same purposes, such part of the land or naval force of the United States, as shall be judged necessary, having first observed all the pre-requisites of the law in that respect.

In 2016, Public Law 114-328 was amended to include Guam and the US Virgin Islands under Ch. 13 jurisdiction. §252: "Use of militia and armed forces to enforce Federal authority" currently reads:

Whenever the President considers that unlawful obstructions, combinations, or assemblages, or rebellion against the authority of the United States, make it impracticable to enforce the laws of the United States in any State by the ordinary course of judicial proceedings, he may call into Federal service such of the militia of any State, and use such of the armed forces, as he considers necessary to enforce those laws or to suppress the rebellion.

### Application

The Insurrection Act has been invoked throughout American history. In the 19th century, it was invoked during conflicts with Native Americans. In the late 19th and early 20th centuries, it was invoked during labor conflicts. Later in the 20th century, it was used to enforce federally mandated desegregation, with Presidents Dwight D. Eisenhower and John F. Kennedy invoking the Act in opposition to the affected states' political leaders to enforce court-ordered desegregation. More recently, governors have requested and received support most recently following looting in the aftermath of Hurricane Hugo in 1989 and during the 1992 Los Angeles riots.

In 2006, the George W. Bush administration considered intervening in the state of Louisiana's response to Hurricane Katrina despite the refusal from Louisiana's governor, but this was inconsistent with past precedent, politically difficult, and potentially unconstitutional. A provision of the John Warner National Defense Authorization Act for Fiscal Year 2007, added by an unidentified sponsor, amended the Insurrection act to permit military intervention without state consent, in case of an emergency that hindered the enforcement of laws. Bush

signed this amendment into law, but some months after it was enacted, all fifty state governors issued a joint statement against it, and the changes were repealed in January 2008.

On June 1, 2020, President Donald Trump warned that he would invoke the Act in response to the demonstrations following the killing of George Floyd. In his official statement, Trump urged "every governor to deploy the National Guard in sufficient numbers" to re-establish civil law and order "until the violence has been quelled".

This is a lot of tedious detail on the Insurrection Act but I hope this explanation on a law that could possibly be invoked in January is helpful to you.

ing the system was under a "coordinated assault and siege."

"This colossal expansion of mail-in voting opened the flood gates to massive fraud," Trump said in his 46-minute address recorded in the White House Diplomatic Room.

"It's a widely known fact that the voting rolls are packed with people who are not lawfully eligible to vote, including those who are deceased, have moved out of their state, and even are non-citizens of our country.

"Beyond this the records are riddled with errors, wrong addresses, and many other issues. This is not disputed. It has never been disputed."

Trump, making the case for a "rigged election," stressed many of the following points:

We have "an Election Day," but we were told months before the election to expect the ballot counting to take weeks, if not months.

There appeared to be "an orchestrated effort to anoint a winner" despite votes still being counted.

Democrats mailed out tens of millions of ballots, permitting "fraud and abuse on a scale never seen before," he claimed.

Bloated voter rolls were used to send out ballots, he further asserted, despite reliance on names of the dead and on voters who had moved out of the specific voting districts.

Using "the pandemic as a pretext," Democrats and courts overrode constitutional election law in some cases without the permission of the state legislatures.

"Dozens of counties in key swing states have more registered voters on the rolls than they have voting age citizens, including 67 counties in Michigan," Trump said.

"Wisconsin could not confirm the residency of more than 100,000 people," Trump said, adding they refused before the election to clean up the registrations. "I knew why: because they're illegal voters."

Key battleground states, like Wisconsin, saw a "massive dump of votes" overnight, swinging the lead from Trump to his opponent. "Mostly [Joe] Biden, almost all Biden," Trump said. "I went from leading by a lot to losing by a little."

Michigan had a dump of 149,772 votes overnight (6:31 a.m.), flipping Trump's lead to Biden, he maintained.

He said hundreds of thousands of votes were unlawfully counted without meaningful observation, or no observation at all.

He also described "tens of thousands" of voters who showed up to vote on Election Day but were told they had already voted by mail-in ballot, despite not having done so.

Democrats ballot harvesting mass mail-in ballots, which is illegal in some states.

Dominion Voting Systems, he said, has technology that can flip votes from one candidate to the other, which can go undetected without forensic examination. The company's CEO has denied these

claims.

"They called it a glitch," where 6,000 votes in Michigan were discovered to have been incorrectly flipped from Trump to Biden.

Dominion Systems might have counted votes on overseas servers, which were vulnerable to hacking and fraud. The company has again denied these allegations.

Republicans across the U.S. won and flipped many seats in states and the U.S. House, suggesting a massive GOP voter turnout that was not equally represented in the presidential election. "It is statistically impossible, the person that led the charge, me, lost," Trump said. "We led the country to victory and you are the only one that was lost. It's not possible."

Lacking mail-in ballot signature verification that is unlawful.

Recounts that are failing to check signatures and matching them with envelopes that have been separated from the ballots.

Many people received multiple ballots from error-prone voter rolls.

Dead voters have been found to have voted.

Illegal votes cast in many battleground states.

"We're showing you hundreds of thousands," Trump said. "Far more than we need. Far more than the margin. Far more than the law requires. We can show many times what is necessary to win the state.

"The media knows this, but they don't want to report it. In fact, they outright refuse to even cover it, because they know the result if they do.

"Even what I am saying now will be demeaned and disparaged, but that's OK. I just keep on going forward."

"Their mail-in voting scam is the latest part of their four-year effort to overturn the results of the 2016 election, and it's been like living in Hell."

Separate from his lengthy list of alleged fraudulent acts, Trump took a moment to rip special counsel John Durham for moving too slowly.

Trump lamented that findings from Durham's investigation into potential FBI malfeasance in its probe of Russian meddling in the 2016 political cycle did not surface before the most recent election last month, effectively altering the course of the race.

"We caught them all," Trump said from the White House Diplomatic Room. "We're still waiting for a report from a man named Durham who I've never spoken to and never met. They can go after me before the election as much as they want, but unfortunately Mr. Durham didn't want to go after these people . . . before the election, so who knows if he'll ever even do a report."

Attorney General William Barr has granted Durham special counsel

authority in his investigation of the investigators.

"If you look at the lies and leaks and illegal acts done by so many people," Trump insisted, "something should happen. The hardest thing I have to do is explain why nothing is happening to all of these people who got caught spying on my campaign."

But it was the fraud claims dominating the president's remarks, as he reemphasized his claim that the Nov. 3 election was "rigged." This, though AG Barr announced he has unearthed no proof of widespread voter fraud that would alter the outcome of the vote. Major news outlets have declared Biden winner, a conclusion Trump's legal team is challenging on the basis of those fraud claims.

(Though *Newsmax* has called several battleground states for Biden following official certification of their vote tallies, it has not yet called the overall election for either man, pending the outcome of the legal challenges.)

"This is not just about honoring the votes of 74 million Americans who voted for me," Trump said. "It's about ensuring that Americans can have faith in this election. And in all future elections."

His overarching claim: "This election is about great voter fraud, fraud that has never been seen like this before."

## Why Covid Vaccines are Risky

Most importantly, as people start dying from coronavirus vaccines, the medical establishment will categorize all those deaths as “covid-19 deaths” in order to claim the pandemic is getting worse.

## Why We Picked Biden Over Trump

**O**r perhaps another way of asking the questions is why is America headed for a fall under democracy.

To answer that question, I direct you to an article written by Brad McDonald that appeared in the Nov 10 issue of the Christian publication *The Trumpet*. I present it here for your thoughtful consideration. D. Miyoshi

If you took a group of 10 children and gave them a choice for breakfast between Coke and Pop-Tarts or eggs and freshly squeezed orange juice, how many would choose the healthier option? One, two, maybe three. The majority would choose diabetes-for-breakfast.

This is the problem with making decisions by majority rule. If the electorate isn't sufficiently educated and moral, the decisions it makes will be the product of ignorance more than information, of impulse more than reflection, of selfishness more than selflessness. In a democracy, the mob decides. The problem with this, as Herodotus said, is that "the mob is altogether devoid of knowledge"—which makes it likelier that deadly decisions will prevail.

On November 4, when tens of millions of Americans chose Joe Biden to be president, this great flaw of democracy was exposed. We are told that almost 80 million people voted for Joe Biden, but this figure is almost certainly inflated, perhaps significantly. Even still, and even though we expect Donald Trump to remain president, it's safe to say that many millions of Americans voted for Joe Biden.

The choice between Donald Trump and Joe Biden was not a choice between healthy and unhealthy. Americans had a choice between two deeply flawed men and administrations. However, one is clearly much worse for America than the other. Mr. Biden and Kamala Harris are both keen advocates of Barack Obama's great ambition to "fundamentally change America." They want to radically overhaul the government, economy, military and social structure of the United States.

Yet tens of millions of Americans want this duo to work in the White House.

This should make us think seriously about the moral and intellectual condition of the American people, and even about democracy itself.

Today we are sending the January issue of the Philadelphia *Trumpet* to the printer. In the lead article, editor in chief Gerald Flurry wrote, "I marvel that so many Americans voted for the radical platform the Democratic Party has embraced. They encourage illegal immigration, even giving them free health care, welfare and education. They want to ravage the economy to combat 'climate change.' They accept radical racist ideals and far-out sexual practices. They applaud lawlessness and insurrection. It doesn't take much to understand that in a democracy, when that many people are so ignorant, it is over. This nation is lost, virtually."

What a remark: America is over, virtually—thanks to democracy. Did you ever think democracy could be so destructive?

Mr. Biden has a long, easily proven track record of political corruption. The Hunter Biden scandal shone the light of truth on this reality just days before the election. Joe Biden supports both Antifa and Black Lives Matter. He also has a record of rejecting the rule of law and the Constitution (for example, he is a key member of the Obama-led cabal behind the Mueller report and impeachment trial, both of which were unconstitutional). Meanwhile, Kamala Harris, the candidate for vice president, is even more far left than Joe Biden.

This is not opinion, and I'm not being partisan. These are accepted facts. Yet tens of millions of Americans voted for Mr. Biden and Ms. Harris. Again, this election was not a choice between perfection and imperfection. Donald Trump has many, many problems. But for all his issues, he values traditional America and does not want to radically overhaul the nation.

How do you explain the fact that tens of millions of Americans voted for a Black Lives Matter-supporting, pro-Iran, pro-Green New Deal, anti-Constitution, anti-Bible, immoral, socialist government in the White House?

To choose Joe Biden and his radical agenda, one must suffer from at least one of two basic flaws in thinking. For democracy to work, the mob must also have clearly defined values. Even more importantly, if the children were taught to value good health and the laws of good health, they would be more predisposed to making the right choice. This point is crucial, both in a democracy and in life: Ultimately, right decisions depend more on morality, on character, than knowledge. The mere possession of knowledge does not automatically guarantee right choices. Our choices are ultimately shaped by our values, the laws and ideologies we love and believe in. We have to choose the right.

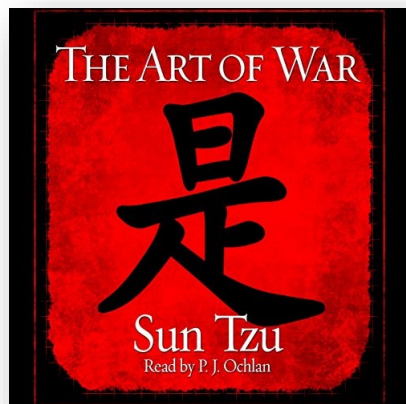

Dr. Eifrig has talked many times about the importance of keeping your brain healthy. As we reach our mid-50s, our mental acuity starts to decline. I, for one can certainly attest to that. Several studies point to ages 50 to 60 as the start of this decline, but a handful believe it starts even earlier. What they all agree on is simple: The earlier you take steps to keep your brain strong, the longer you'll delay any signs of decline.



## A Possible Reason for the Nashville Bombing

Dr. Eifrig says one of the best ways to learn and keep your mind sharp is with financial literacy.

Studies out of Rush University used brain scans to determine that seniors who had better scores on financial literacy tests also had stronger connections between their brain regions.

An earlier study also showed changes in gray matter in an area called the medial prefrontal cortex. This is the area responsible for attention and complex decisions. Folks who had less gray matter in that area of the brain also had more problems with financial tests.

A similar study in 2016 from Keck School of Medicine at the University of Southern California focused on these connections in particular.

When we learn and use financial education, we use different parts of our brains. Learning the material uses regions in the temporal parietal area. That's a region near the middle-back of the brain. Applying that material uses the frontal lobe of the brain. The researchers wanted to test if greater financial literacy improved the connections between these sections. What they found was that the more financially literate a person, the stronger the connections.

Reading is an excellent way to build up our brain strength. It engages several parts of the brain at once, making stronger connections. That, in turn, helps you sharpen your decision-making process.

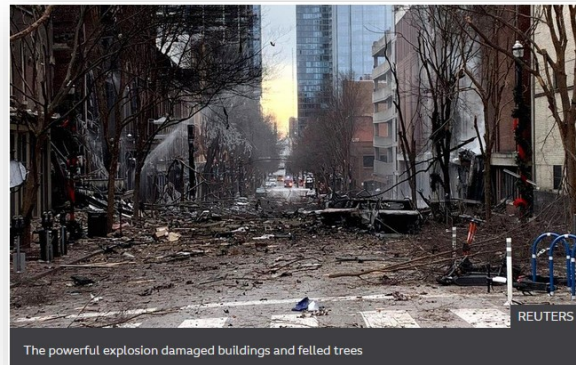
One study from the University of Texas, Dallas, looked at the length of sustained engagement. The more engaging a class is, the more your mind works. You power through working memory, episodic memory, and reasoning. Researchers found that classes like quilting or photography boosted memory function in the participants.

So keep reading those financial lessons, not only to keep your mind sharp, but also improve your investing.

## A Possible Reason for the Nashville Bombing

## The Coming Climatic Clash of Progressivism and Conservatism



A soldier stands in front of a courthouse in Pittsboro, N.C. He stands at ease, his fingers wrapped around the barrel of a bronze musket, his Confederate uniform gone green with age. He has stood there peacefully for more than a century — but in August of 2019, the Chatham County Board of Commissioners ruled that the statue was to be taken down.

Protestors gathered in two groups by the statue, on either side of the adjoining Sanford Road. On the left side of the street were progressives holding anti-racist signs, demanding that the statue — a symbol of a racist history — be demolished. To the right of the road were Chatham residents who stood in the defense of their heritage, waving Confederate flags.

The scene at the protests, each side shouting rude labels across the road, embodies the long-standing clash between progressive and conservative values in America. It's easy to

point to the achievements of progressive movements — emancipation, suffrage, civil rights, labor laws — and conclude that the clash has been settled: Progressives move history forward, while conservatives dig their heels into the ground to hold it back. The argument is not without merit; throughout the arc of history, every bend toward justice has been met by the conservators of an unjust status quo.

But this argument also leaves us with a troubling, imprecise and divisive stereotype: Progressives are the party of justice, while conservatives stand in the way of progress. The connotation of these words — progression against conservation — leaves us with a truncated and deceptive view of their underlying philosophies. Similarly, unhelpful stereotypes are made of progressives, that they are the starry-eyed idealists, their naive aspirations having no grasp of the real world.

The fact that these philosophies have come to be associated with Democrats or Republicans politically forces us on either side of Sanford Road. Each group misapprehends the goals of the other which turns their opponents into boogymen. Conservatives become guardians of broken, racist and unjust systems, while progressives are intent on ruining the nation in their attempts to “perfect” it.

The true ideology of conservatism has nothing to do with bigotry or injustice. Its foundations are in the respect for tradition and a belief in the maintenance of certain values — whether these be religious, constitutional or cultural.

Take the policies of democratic socialism, one of the most progressive movements now moving through our nation. The movement aims to take the policies of socialist countries like Sweden and Denmark and apply them to America. Democratic candidate Sen. Bernie Sanders said of these policies: “When I talk about democratic socialism, what I mean is moving away from where we are right now.”

To a conservative (I being one), the idea of trading away one's values and way of life for free health care and college tuition is fundamentally objectionable. Considering that Sweden and Denmark's socialist giveaways have saddled them with some of the highest tax rates in the world, the conservative desire to maintain American traditions seems rather reasonable.

But what about the great American traditions of injustice, racism and inequality? Many progressives criticize conservative thinking as regressive, the kind of stuck-in-its-ways mentality that has allowed injustice to persist for as long as it has. Admittedly, many necessary advancements are retarded

by a desire to keep things more or less the same.

Yet, conservatism can't be written off as regressive, or worse, racist in itself. The respect for tradition is not a bad thing; there are a great many traditions that have served to make our country great such as the respect for the rules of our Constitution. This respect is only fault worthy where the traditions are unjust, and though progressives have historically challenged injustice and exclusion, this doesn't make progressivism the champion over conservative wrongs.

Progressivism is often enough wrong on its own. The democratic socialist idea of free college tuition sounds like a fair and promising progression, but the same can't be said of its likely outcomes.

One reason for this is that free tuition actually raises drop-out rates, as there is less incentive for students to complete their degrees. One Manhattan Institute study found that graduation rates were actually higher in G-7 countries that charged tuition as opposed to those with free college. This, on top of a host of other practical issues such as a direct harm to private colleges, an overcrowding of schools and a \$70 billion price tag, shows us that a more conservative approach could be better suited to the problem.

The bottom line is that neither progressivism nor conservatism can be removed without our country stagnating. Without a healthy clash of ideology, the state has only one voice and one direction — not necessarily the right ones. The idea that growth is always achieved by progressives keeps us shouting from either side of the road; it keeps us from meeting somewhere in the middle and moving forward.

But if the extreme views of these ideologies become intense and radicalized to the point where the shouting of invectives morphs to the throwing of rocks and worse, the problems can become existential for our society. And this is exactly where we find ourselves embroiled in America in the month of January 2021.

The world witnessed in November that the 2020 presidential election turned out to be one of the most mystifying elections of all time, especially for the Republican incumbent Trump. Here are some of the reasons why:

President Trump received more votes than any previous incumbent seeking reelection. He got 11 million more votes than in 2016, the third largest rise in support ever for an incumbent. By way of comparison, President Obama was com-

fortably reelected in 2012 with 3.5 million fewer votes than he received in 2008.

Trump's vote increased so much because, according to exit polls, he performed far better with many key demographic groups. Ninety-five percent of Republicans voted for him. He did extraordinarily well with rural male working-class whites.

Trump grew his support among black voters by 50 percent over 2016. Nationally, Joe Biden's black support fell well below 90 percent, the level below which Democratic presidential candidates usually lose.

Trump increased his share of the national Hispanic vote to 35 percent. With 60 percent or less of the national Hispanic vote, it is arithmetically impossible for a Democratic presidential candidate to win Florida, Arizona, Nevada, and New Mexico. Bellwether states swung further in Trump's direction than in 2016. Florida, Ohio and Iowa each defied America's media polls with huge wins for Trump. Since 1852, only Richard Nixon has lost the Electoral College after winning this trio, and that 1960 defeat to John F. Kennedy is still the subject of great suspicion.

Midwestern states Michigan, Pennsylvania, and Wisconsin always swing in the same direction as Ohio and Iowa, their regional peers. Ohio likewise swings with Florida. Current tallies show that, outside of a few cities, the Rust Belt swung in Trump's direction. Yet, Biden apparently took Michigan, Pennsylvania, and Wisconsin because of an apparent avalanche of black votes in Detroit, Philadelphia, and Milwaukee. Biden's 'winning' margin was derived almost entirely from such voters in these cities, as coincidentally his black vote spiked only in exactly the locations necessary to secure victory. He did not receive comparable levels of support among comparable demographic groups in comparable states, which is highly unusual for the presidential victor.

The main stream media reports that Biden won more votes nationally than any presidential candidate in history. But he won a record low of 17 percent of counties; he only won 524 counties, as opposed to the 873 counties Obama won in 2008. Yet, Biden somehow outdid Obama in total votes.

Victorious presidential candidates, especially challengers, usually have down-ballot coattails; Biden did not. The Republicans held the Senate and enjoyed a 'red wave' in the House, where they gained a large number of seats while winning all 27 toss-up contests. Trump's party did not lose a single state legislature and actually made gains at the state

level.

Another anomaly is found in the comparison between the polls and non-polling metrics. The latter include: party registrations trends; the candidates' respective primary votes; candidate enthusiasm; social media followings; broadcast and digital media ratings; online searches; the number of (especially small) donors; and the number of individuals betting on each candidate.

Despite poor recent performances, media and academic polls have an impressive 80 percent record predicting the winner during the modern era. But, when the polls err, non-polling metrics do not; the latter have a 100 percent record. Every non-polling metric forecast Trump's reelection. For Trump to lose this election, the mainstream polls needed to be correct, which they were not. Furthermore, for Trump to lose, not only did one or more of these metrics have to be wrong for the first time ever, but every single one had to be wrong, and at the very same time; not an impossible outcome, but extremely unlikely nonetheless.

Atypical voting patterns married with misses by polling and non-polling metrics should give observers pause for thought. Adding to the mystery is a cascade of information about the bizarre manner in which so many ballots were accumulated and counted.

The following peculiarities also lack compelling explanations:

1. Late on election night, with Trump comfortably ahead, many swing states stopped counting ballots. In most cases, observers were removed from the counting facilities. Counting generally continued without the observers

2. Statistically abnormal vote counts were the new normal when counting resumed. They were unusually large in size (hundreds of thousands) and had an unusually high (90 percent and above) Biden-to-Trump ratio

3. Late arriving ballots were counted. In Pennsylvania, 23,000 absentee ballots have impossible postal return dates and another 86,000 have such extraordinary return dates they raise serious questions

4. The failure to match signatures on mail-in ballots. The destruction of mail-in ballot envelopes, which must contain signatures

5. Historically low absentee ballot rejection rates despite the massive expansion of mail voting. Such is Biden's narrow margin that, as political analyst Robert Barnes observes, 'If the states simply imposed the same absentee ballot rejection rate as recent cycles, then Trump wins the election'

6. Missing votes. In Delaware County, Pennsylvania, 50,000 votes held on 47 USB cards are missing

7. Non-resident voters. Matt Braynard's Voter Integrity Project estimates that 20,312 people who no longer met residency requirements cast ballots in Georgia. Biden's margin is 12,670 votes

8. Serious 'chain of custody' breakdowns. Invalid residential addresses. Record numbers of dead people voting. Ballots in pristine condition without creases, that is, they had not been mailed in envelopes as required by law

9. Statistical anomalies. In Georgia, Biden overtook Trump with 89 percent of the votes counted. For the next 53 batches of votes counted, Biden led Trump by the same exact 50.05 to 49.95 percent margin in every single batch. It is particularly perplexing that all statistical anomalies and tabulation abnormalities were in Biden's favor. Whether the cause was simple human error or nefarious activity, or a combination, clearly something peculiar happened.

With all these peculiarities, president Trump issued a series of challenges in the state and Federal courts to try and overturn the election. Through the end of December, however, no courts have taken the cases nor have they even seen the proffered evidence.

In fact, an onsite witness has actually attested that he heard Chief Justice John Roberts in his chambers berating the other justices of the Supreme Court to decline the case lest they cause riots in the streets of America.

And so, in the beginning of 2021, we find ourselves with a self-proclaimed president elect Joe Biden, demanding that president Donald Trump concede the election while he Trump retorts that he will continue to fight and prove he won the election.

Yet in spite of all this, president Trump appears quite confident he will serve another term as president. Either he has concrete plans that give him this confidence or he is a very good actor. Based on his past behavior I would venture to

guess he has plans in play that give him this confidence. We should also consider the anomaly that at this very late stage of the process, Kamala Harris had not yet relinquished her senate seat. Normally, a VP elect would be in full public preparation of their transition to the office. Perhaps Harris has hint of Trump's plans that could give him the election.

On Dec 27, president Trump tweeted to his followers "See you in Washington DC on January 6th. Don't miss it. Will be Wild"

Why would Trump entreat his follows to come to DC on Jan 6th?

Well, recently, a Rasmussen poll laid out a plan that hints of the reason why Trump wants his followers in DC on Jan 6th. Because on that day that members of Congress will convene in a joint session to count the electoral votes for the presidency. And then VP Pence will be presented with the sealed certificates containing the ballots of the presidential electors. Under the Constitution, VP Pence has the plenary and non-appealable authority as president of the Senate from declining to open and count the certificates from the six disputed states (Pennsylvania, Michigan, Wisconsin, Georgia, Arizona, Nevada). If the votes from these disputed states are not counted, then Donald Trump would have 232 votes to Joe Biden's 222 votes. And per the 12th Amendment the votes would be counted and the person having the greatest number of votes (which would be Trump) would be declared president.

In fact, Thomas Jefferson only became president because he used his unilateral power as president of the Senate to openly count the ballots in his favor that gave him the presidency.

Now, the question is will VP Pence use his presumed authority to decline to accept the electoral votes of the six disputed states? If VP Pence were to accept the electoral votes of most of the disputed states, this would give Biden sufficient votes to claim the presidency.

But even if VP Pence fails to object to the votes, there is yet another avenue available for Trump to gain the presidency, albeit a slim one.

If at least one House member and one Senator submit an objection to the vote count of any particular state such as one of the disputed states, the two chambers of Congress (House and Senate) are required to separate to debate for two hours and vote on whether to continue counting the votes in light

of the objection. Both chambers must vote by a simple majority to concur with the objection for it to stand, otherwise the objection fails under the Electoral Count Act of 1887.. If both chambers of congress affirm the objection that state's votes are not counted and if no candidate receives the necessary 270 votes, the 12th Amendment dictates a congressional process called a contingent election for selecting a president and vice president. The House of Representatives votes to elect the new president. As a bloc, members of the House cast one vote per state, choosing between the three candidates who received the most Electoral College votes. The Senate votes to elect the Vice President, casting one vote per senator. But realistically, there is very little confidence this method will prevail for Trump.

So, it's evident, the reason Trump called his supporters to Wash DC on Jan 6th is to build momentum and pressure on that day to change the hearts and minds of congress people who weren't yet decided or saw everyone outside and said "I can't be on the other said of that mob."

But if VP Pence accepts the votes of the disputed states or if the Congress does not object to the electoral votes thereby invoking a contingent election, then presumably Biden would be declared the president.

However, it likely does not stop there.

Back on December 22, conservative columnist Mike Adams published a list of 10 pathways that Trump could use to claim the presidency for his second term. They are:

1. Invoke the "Pence Maneuver" (discussed above): Have Pence reject electoral votes from states that certified fraudulent, illegal votes.
2. Use the 2018 Executive Order on election interference to seize Big Tech and the legacy media, while arresting Biden and all complicit operators, charging them with treason. This would nullify the election and force a re-do. This pathway can be triggered if John Ratcliffe, the Director of National Intelligence issues a formal report confirming foreign interference in the election.
3. Activate the 1807 Insurrection Act (see earlier article) and deploy the military seize ballots and voting machines, then conduct a recount under military authority.
4. Roll out all the evidence of cyber warfare from China, declare the election an act of warfare against the United States, declare new elections to be held under military authority. (We the People Convention.)
5. Declassify everything and expose Joe Biden as a crimi-

nal, treasonous puppet of the CCP, then arrest him for treason or offer him a pardon in exchange for Biden to concede.

6. Invoke 14th Amendment to strip electoral votes from states engaged in insurrection or rebellion against the United States.

7. Appoint Sidney Powell special prosecutor, and allow her to issue subpoenas / search warrants and issue indictments against treasonous actors. Then acquire confessions.

8. Invoke the National Emergency Broadcast System, seize control over the treasonous media, broadcast all the evidence of vote fraud and urge the American people to demand Congress vote for the Trump electors on Jan. 6th.
