conomic freedom is the fundamental right of every human to control his or her own labor and property. In an economically free society, individuals are free to work, produce, consume, and invest in any way they please. In economically free societies, governments allow labor, capital, and goods to move freely, and refrain from coercion or constraint of liberty beyond the extent necessary to protect and maintain liberty itself.

Economic freedom brings greater prosperity. The Index of Economic Freedom documents the positive relationship between economic freedom and a variety of positive social and economic goals. The ideals of economic freedom are strongly associated with healthier societies, cleaner environments, greater per capita wealth, human development, democracy, and poverty elimination.

For much of human history, most individuals have lacked economic freedom and opportunity, condemning them to poverty and deprivation.

Today, arguably we live in the most prosperous time in human history. Poverty, sicknesses, and ignorance have been receding throughout the world, due in large part to the advance of economic freedom. Unfortunately, indications are evident that this progress is now reversing to the great detriment of the world, as often reported in this newsletter, but that is an argument for another time.

The Heritage Foundation, Washington's No. 1 think tank recently published its latest 2023 survey that measures the principles of economic freedom that fuels said progress.

The Index covers 12 freedoms – from property rights to financial freedom – in 184 countries.

These 12 freedoms are grouped into four broad categories, or pillars, of economic freedom:

Rule of Law (property rights, government integrity, judicial effectiveness)

Government Size (government spending, tax burden, fiscal health)

Regulatory Efficiency (business freedom, labor freedom, monetary freedom)

Open Markets (trade freedom, investment freedom, financial freedom)

Each of the twelve economic freedoms within these categories is graded on a scale of 0 to 100. A country's overall score is derived by averaging these twelve economic freedoms, with equal weight being given to each.

For a quick visual comparison of how each country and region compares with each other on these freedoms, I present colored maps of the world showing each country's ranking of these 12 freedoms. You will note, the US didn't do well in the government spending and fiscal health freedoms. I think you will find it informative.

Generally green is good and red is regretful. But keep in mind, this is published by the Heritage Foundation in Washington D.C. so there may be some political favoritism involved.

INTERACTIVE HEAT MAP














Why global warming proponents don't condemn China for pollution.



hina is responsible for more than one quarter of the world's annual greenhouse gas emissions.

Just days before COP26's opening in Nov 2021, the country released a new plan to lower them, but critics said it contained little in the way of new "ambition." Rather, China restated a forecast that it will hit peak emissions by 2030 and reduce its "carbon intensity" AFTER THAT.

Coal, a mainstay of Chinese energy production, will remain dominant for decades to come, although the country will start phasing it out in 2025.

In a past keynote speech, Obama chided China's leadership, suggesting it all adds up to a lack of commitment to making COP26 a success.

It reflects "a dangerous lack of urgency," said Obama, singling out not only China but Russia as well.

But analysts who've followed China's slow transition from a fossil fuel behemoth to an emerging clean energy giant say the reality of China's commitment to hitting the goals laid out in the 2015 Paris climate accord — and updated at the COP26 conference — is more nuanced.

In December 2020, Xi told the United Nations General Assembly that China would get to carbon neutrality by 2060. But that's a full decade later than the net-zero target set by many Western nations.

This begs the question, why does the world give China a pass on global polluting when all other nations "seem" (and that's the operative word) to be intent on getting to zero carbon emission as soon as possible?

Why aren't global warming proponents condemning China, who has far more emissions especially by coal fired industries?




Perception by US Politicians and the Public

Hollywood images of Rambo, independence, and American military victories.


A total lack of history.

DoD conspired with communist China to unleash covid "vaccine" bioweapons on citizens

Former pharmaceutical industry executive Sasha Latypova has come forward with damning information linking the Department of Defense (DoD) and Pfizer's Wuhan coronavirus (Covid-19) "vaccine" scheme to the Chinese Communist Party (CCP).

Government documents obtained by Latypova show that the DoD partnered with a CCP-linked drug company to develop and distribute the "biological warfare agents marketed as 'Covid-19 vaccines'" from Pfizer and BioNTech.

"It is curious that the U.S. DoD awarded \$10 billion ... to a venture whose substantial equity (and IP) holder is the Chinese Communist Party," Latypova wrote in a December 28 Substack article.

Over the past year, Latypova has dropped numerous bombshell revelations on the world pertaining to Wuhan coronavirus (Covid-19) "vaccines," all of which are a scam.

Government officials, Latypova claims, have been trying to conceal the relationship between Pfizer, the United States deep state, and communist China as it pertains to covid injections – but the cat is now out of the bag.

"I know what is in the redacted part," Latypova wrote about images she shared of heavily redacted text naming the third party that part-

nered with Pfizer and BioNTech for the "co-development and distribution" of a "coronavirus vaccine."

"Fosun Pharmaceuticals ... it was not hard to figure out," she revealed.

(Related: Three months before covid appeared, the DoD issued a "COVID-19 Research" contract to a Ukrainian company.)

It should really be called the Fosun-Pfizer-BioNTech covid "vaccine"

Another document dated March 16, 2020, substantiates Latypova's claim that Fosun is the redacted third-party partner that worked with Pfizer, BioNTech, and the CCP to unleash covid shots under Operation Warp Speed.

This "strategic alliance," that document states, was formed to ensure swift development and commercialization of the experimental genemodification injections.

"Pfizer-BioNTech is really a 3-party R&D alliance: Fosun-Pfizer-BioNTech, and by 'party' I mean that one of the three is the Chinese Communist Party," Latypova maintains.

"Fosun is a huge Chinese conglomerate that owns a large number of global companies, and its chairman, Guo Guangchang, is a very high ranking member of the CCP."

According to Forbes, Guangehang is currently worth over \$4 billion, and is a member of at least three different CCP-aligned organizations, including the 12th Chinese People's Political Consultative Conference (CPPCC).

Under the supervision and direction of the CCP, the CPPCC provides consultation and advisory input to various CCP legislative bodies.

A native of the Soviet Union, Latypova has a unique and insightful perspective into the geopolitics of communist China, which is located right next to Russia.

"In China, every large employer, especially in something strategic like biopharma sector, is controlled by the CCP," she says, adding that this was also the case in her homeland.

"... in the Soviet Union, where each workplace had a 'partorg,' a representative supervisor from the Communist party, or a whole department of them."

There is also a fourth party involved in all this: Israel. The Israeli Ministry of Health was added to the "pharmacovigilance" agreement for data sharing on Jan. 6, 2021, the day of the so-called "insurrection" in the U.S. capital.

Latypova says this foursome agreed to "count the bodies and share the data with each other."

Latypova also maintains that the DoD was directly in charge of the production and distribution of all covid injections unleashed by the Trump administration and its Operation Warp Speed scheme.

These so-called "vaccines" were never categorized by the DoD as medicines or pharmaceuticals, but rather as "COVID countermeasures" under the authority of the military. This is why Trump unleashed them as a military operation after declaring covid to be a health emergency of a pandemic nature.

FINANCIAL SYSTEM: And We All Fall Down.

Once again! The global financial system finds itself in crisis. Indeed, a new full-on worldwide financial system/banking crisis is upon us. (And it's just getting started).

Let us consider...

Is it even remotely possible that banking regulators and central banks simply missed this? Meanwhile We the People saw this coming? Is that even possible? Really? How about no. There is absolutely no feasible or realistic way that banking regulators and central banks could have not seen this coming from miles away, and here are just a few reasons why.

Let's start with this. Every bank is required to submit financial reports to regulatory authorities every quarter and moreover, even without seeing these reports, its plainly obvious that banks were failing because of just three things.

Number 1. No deposits, Number 2. No loans, and

Number 3. No deals.

I brought these three things listed above up to the attention of those who follow my work beginning no less than eight months ago.

Now, just to put this into further perspective. The average savings rate, which is calculated as the percentage of cash which people put away after expenses is 8.84%. Again 8.84% is the average. Well today, the savings rate has dropped to just 4.7% (and personally I believe that this number is inflated). This 4.7% savings rate appears inflated to me because currently more and more people are becoming dependent on credit card usage. (Credit card debt has exploded, rising 11% in just the last year).

With respect to "no loans and no deals." Year over year mortgage applications have dropped a record 43%, and bank refi's have dropped another record 74%. And on top of all this, loan delinquencies across the board continue to skyrocket.

But it gets even worse.

People are withdrawing cash from both their money market and savings accounts at a record pace.

So, no... It is not possible, even in the remote! That those who stand in charge of the world economy, the banking system, and the markets just missed all this. Therefore, it is deliberate. In fact, it's more than just deliberate!

This entire banking system crisis/global financial system collapse has been perfectly orchestrated and engineered by central planners/banks. But why?

The question of why comes down to just a few things. Central banks are "rearranging the deck chairs" so to speak, and it comes down to a consolidation of the banking system in preparation for the rollout of an entirely new central bank digital/cashless system.

It is also about a consolidation of power.

Understanding that even the Super Banks are also facing those same issues as the smaller regional banks, with "no deposits, no loans, and no deals." That situation, combined with rising loan delinquencies. What better way could central planners use to re-liquify the large Wall Street Super Banks than to foster a meltdown of the smaller regional banks who will have no choice but to be forced into selling their assets to the mega banks at fire sale prices? Moreover, foster runs on the smaller banks with people closing their accounts only to open new ones in the more "secure" Super Banks. (With regard to the \$30 billion dollar "rescue" for First Republic Bank, as it is being sold to the public via the mainstream media. This is no "rescue." This \$30 billion is to cover withdrawals, as there is currently a run on that bank).

Republicans don't care what Trump does or what he says. The way the Republican party works, when it comes to delegates is, in most of the races as long you get one more vote than whoever comes in second place, you walk away with every single delegate. So, it's really easy for someone to come in from the outside, just like Donald Trump did, because by most metrics he's not a conservative in the American sense and certainly not in the Republican sense. But, he was able to mobilize a group of people who'd been left to the outside of the populace and has catapulted into, not just to the presidency, but to control the Republican Party as a result.

So, in the environment that were in now, since we already have another three people declared for the presidency, it doesn't matter if someone like Florida Gov. DeSantis runs at this point. The vote is already sufficiently split that Donald Trump will walk away with the Republican nomination. That's pretty much hardwired in at this point. So, that's the Republicans.

Let's talk about the Democrats. The Democrats select their candidates a little bit differently. They don't have that winner take all mentality when it comes to the delegates, so if you get a number of strong candidates, they are going to break up the delegate count among them and it's going to semi-come down to the convention. At the convention there are a significant number of what they call superdelegates, which are people who were not representative of the primary of the caucus system but instead represent the party's institution which are primarily centrists. And the superdelegates came into play in the last presidential cycle, when for a brief, shining, terrifying moment it looked like Bernie Sanders might actually get the Democratic nominee. And since most centrists and center-left Democrats were like "ooh that would be disastrous by any number of manners" they all ratted together and used the party apparatus to make sure that Bernie did not get the nomination. And, as a result Biden was able to squeak through and then ultimately ran for president and ultimately gained the White House.

Now the centrists and the center-left within the Democratic coalition

have made the decision already that they're not going through that again. And so, if Bernie or more likely when Bernie decides to once again run for president, the centrists will swing into action to make sure it's nipped in the bud as quickly as possible. In addition, the Democrats have always had a problem, I shouldn't say always, the Democrats in the last 25 years have had a problem that it's really hard for them to bring in fresh blood because you've got these charismatic people at the top who are politically and maybe even economically powerful who kind of suck all the oxygen out of the room and make it very difficult for young up and comers to make it into the system. Republicans don't have that particular problem. You just get these freaks that come in from the outside, freaks like Bernie Sanders. Well, since the centrists have already decided what they're going to do this time around that means Biden is a shoe in to get the nomination. Which puts us into a weird race. You get Republicans who are cult dedicated to Donald Trump and you got Democrats who are willing to shut out everyone else so long as Biden doesn't have a complete meltdown and start drooling effusively on stage. Barring those two extreme events, were talking about a redux of the last election of Biden versus Trump.

I don't think that any of the things that people are talking about right now as having an impact on the election would really matter at all. So, for example, the age issue. I mean yes, yes, yes, Biden is older than dirt by a wide margin and he would be the oldest president ever if he wins again. However, if Trump beats him Trump would then be the oldest president ever. So, the age issue is really a non-condition for any voter who says it is. It may be a compacting factor but since the runner up in this case has shown most of all it doesn't play.

And the same comes for replacing the vice presidency with somebody besides Kamala Harris. Has she risen to the occasion? No. Has she turned out to be good VP? Probably not by most measures. But replacing her isn't going to really change anyone's mind. Nobody

votes for the vice president. So were left with Biden versus the Trump.

So, the question then is who walks away with that. From my point of view, it's pretty straightforward. Roughly 20 to 25% of the electorate is either hard-core Republican or hard-core Democrat and they may not like the candidate but they will hold their nose, pull the lever and vote for whoever their party's candidate is. They are locked in. There is no negotiating room there. Then you have another about 20% on each side that says they're independent, but like in 85% of races they vote for either Republican or Democrat so they're really only independent in name. Really, they're just subsidiaries of the left and the right in the American system. There's not a lot of wiggle room.

There there's only 10% of the American electorate that is truly independent and they are wishy-washy and they are judgmental and they get "buyer's remorse" and the votes of this last 10% is the primary reason why in midterms usually the party in power loses because they're having buyer's remorse. I know this very, very clearly because I am part of that 10%. We are never happy with what we are and were not part of the decision-making to determine what the candidates are and so we get handed this pallet that we just don't like, that we have to make do with and that usually manifests as us voting against whoever happens to be the guy in charge at the moment. So, that is how it normally runs. That's how it's always run. That's how it ran until we got to the 2022 midterms.

Because at the 2022 midterms almost exclusively the independents polled as not liking Joe Biden particularly on economic affairs. They saw his continued governance as being against their own economic best interests and yet they decisively sided with Democrats in all the races that really matter and so for the most part independents poll does not like the Biden administration's economic policies and they saw a continuation of those policies as against their own personal economic interests and yet they decisively voted against Republicans. Why? Well, it's not too hard to understand.

A lot of this talk about what's going on with the election system is

real but you have to look at it from the independents point of view to really understand. If the Republican Party under Trump is able to change the electoral system in a way that they say they want to then swing voters don't matter anymore and independent voters don't have a party. That's the general election is the only way that they play in American democracy. And if you remove that, they are powerless. lbert Einstein's definition of insanity—doing the same thing over and over and expecting different results—describes the behavior of U.S. policymakers. Whether the objective is to reduce inequality, slow climate change, or curb the market power of dominant firms, government policies simply have not worked. Nonetheless, urged on by policy advocates, elected officials adopt new policies and expect positive outcomes without knowing why previous policies have failed to accomplish their goals.

Political-economy theories of government stress the importance of organized special interests, including people in government, who distort policy formation and implementation or—the flip side—resist efficient policy changes. Although those theories are plausible, the causal evidence is weak, and the best conclusion that can be reached is that government suffers from status-quo bias because it fails to include essential reforms in the new policies it adopts. This implies

Alberta reported last year that precisely zero Karens were born in 2022. And, according to the Social Security Administration, Karen dropped from 660th place in 2019 to 831st in 2020.

The reason's clear.

Nobody wants the slur cast in their direction.

Not just that.

These days, if you're unfortunate enough to catch a Karen, you also run the risk of inflaming the Internet's spontaneous, but always half-cocked, Anti-Karen League. Sometimes (though certainly not always) even if one's complaints come with reason.

A landlord asks her tenant to pay her rent on time?

If you're wondering if this animosity is a symptom of a larger trend...

You're not alone.

One might point toward a thickened sense of complacency — learned helplessness, as it's called — about a fraying of the social, political, and economic fabric of America.

But then, an even bigger question arises: What's at the root of this unraveling?

If you ask Scott McKay at the Spectator, he'd say it's obvious.

He calls it...

Weaponized Governmental Failure

Especially in our major cities.

Many operate under the assumption that the majority of our political leaders are just... well... incompetent. (Although many put it in ways less polite.)

That's why things — even basic things — don't get done.

McKay argues the opposite. "The crime and the graft and the potholes and the bad drainage, not to mention the spotty trash collection or nonexistent snow shoveling, aren't incompetence. In fact, none of what you see in the American public sector is incompetence. The people responsible for it are quite highly educated and well-trained in their craft. You just need to understand what their craft is."

McKay defines Weaponized Governmental Failure (WGF) as the

"deliberate refusal to perform the basic tasks of urban governance for a specific political purpose."

To do a bad job, he argues, is a choice. Especially when it comes to the basic amenities of a well-functioning city.

There are consequences to doing those things effectively: "If you do those things effectively, after all, what you will get is middle-class voters moving in."

And, therein lies the problem: "middle-class voters are a pain in the ass."

To Rule Over Ruin

Because they have more mobility, middle-class voters demand more bang for their buck from their taxes. They demand things like good roads, safe streets, functional drainage, decent schools, friendly business climates, etc.

Rich voters aren't usually as aggressive. They're not going to show up en masse and yell at the school board. They can afford private security, private schools, and gated communities.

When middle-class voters don't get what they want... they leave.

And, McKay points out, this isn't just about the so-called white flight: "Those suburbs the folks are leaving for?" McKays asks. "Their minority population share usually increases as their population does."

McKay's argument is this: The more middle-class voters you drive out of the city, the fewer "Karens" you have to deal with. Add to that, says McKay, "the more pliable the electorate becomes. A pliable electorate is one you can rule forever without successfully governing."

Therefore, he says, the craft of politicians isn't to govern effectively.

It's to rule.

"They rule over a ruin," says McKay, "but they rule."

The Thin Pink Line

If we revisit the original definition from Wikipedia, we see that a Karen is one who demands those things "beyond the scope of what is normal." If we are to believe McKay, the current progression in America is to normalize lower standards.

The house edge is the reason why Las Vegas casinos make so much money with such regularity and such certainty.

The house edge is a simple mathematical concept. It's the percentage of a player's bet that the casino is likely to win. Said another way, it is the statistical advantage a casino holds in any given game.

You see, casinos don't win year in and year out because they get lucky.

Casinos have an ocean-deep knowledge of probabilities. Nobody knows more about probabilities and payoffs than the people running casinos.

All those small wins pile up to form a mountain of money.

This means the casino business is one of the only industries on the planet that has a business model based on mathematical certainty.

As long as they follow their own rules, casinos know they are 100% guaranteed to earn money because the odds are always in their favor.

Take the iconic Vegas game roulette.

There are 36 numbers on a roulette wheel plus a green zero. Depending on the country, there may also be a double zero, but we'll stick with just the one zero for simplicity.

When the roulette wheel is spinning, the ball can stop on any one of the 36 numbers or the zero. That's 37 possible stops.

This means the mathematical odds of a player picking one of those potential stops is 1 in 37.

Even though the roulette wheel offers 37 possible winning numbers, a player will receive a payout of 35 to 1 for a bet on a single number.

For winning a bet of 1 unit, the casino will pay the player 35 units plus the initial bet (36 units in total). For a straight-up bet, the probability of success is 1 out of 37, but the player will receive 36 units in the case of a win.

The difference of 1 unit (37 minus 36) is the house edge.

In this case, it's about 2.7%.

There's a very small chance that a player will win and the house has to pay them. But when the house does have to pay up, it pays 2.7% less than what the 1/37 odds would merit.

It's a small percentage, but applied over and over millions of times per year, it adds up.

You may not realize it, but playing casino games and investing in the financial markets are very similar.

It's no coincidence that many of the world's best investors and traders are avid poker players.

After all, success in both playing cards and playing the market is a matter of consistently stacking the odds in your favor, knowing how to balance risk and reward, and knowing when to play and when not to play.

The real secret to making a fortune on the Las Vegas Strip and on Wall Street is finding and applying AN EDGE... over and over again.

But note, nobody can predict the future with 100% accuracy. No software program can even do that. The only absolute certainty is that we can't predict the future with absolute certainty. As for markets, as in life, only a fool believes you can be right 100% of the time.

The purpose of this newsletter (as well as the *Tradesmith Daily*) is to provide you useful and hopefully interesting information that is not provided by mainstream sources. But it's not to tout any particular investment vehicle or project. That is for you to decide.

But just note, there are techniques and software programs such as those offered by established investment advisory services (of course for a price) that can measurably reduce the risk and thereby provide an edge.

And with an edge, over time, one will be able to generate a very reasonable and fair profit.

ummoning demons has never been so fun! That blurb from A Children's Book of Demons is an apt description of the world we live in. Outright demonism is cool, trendy, even glamorous.

"After-school Satan clubs" are available at a handful of elementary schools. They even have a theme song: "Satan's not an evil guy, he wants you to learn and question why." Young witches post videos on how to get into paganism on TikTok. People with "multiple personalities" get likes for switching between different minds in front of the camera.

Two transgender men dominated world headlines by dressing as Satan for the Grammy Awards. One up-and-coming singer, also transgender, has the name of his favorite demon tattooed on his forehead. One rapper released a music video that showed him descending to hell and giving Satan a lap dance. It was previewed in a Super Bowl commercial—and followed up by "Satan Shoes"—a collaboration with Nike that allowed people to buy the trainers Satan was shown wearing, which contain actual human blood.

Movies and video games involving demonic themes have been around for years but are getting worse and worse—and more and more accepted.

And this begs the questionWhat are the dangers of Demonism?

To answer that I present an article by Richard Palmer that appeared in the April edition of the *Philadelphia Trumpet*. It provides a conservative Christian perspective on the threat Demonism brings today to our society.

As a Christian myself, I found it informative but disturbing. Even non-Christians may find this at the least a bit un-settling.

Are Demons Real?

Satan and demonism have become a part of our news cycle. The rise of all these demonic themes has led many to ask, Are demons real?

America's Christians are split on whether or not Satan exists. Polls generally put the split at around 50/50. That's not too surprising; American Christians are similarly split over whether or not God exists. One study reached the bizarre conclusion that more American Christians believe in Satan than in God.

What does the Bible say?

The Gospels record Jesus Christ regularly being confronted by and casting out demons (Matthew 4:24; 8:16; Mark 1:32, 34, 39; Luke 4:41). He delegated similar authority to His disciples (Matthew 10:8; Mark 3:15; 6:13; Mark 16:17; Luke 10:17). Demon-influenced people are encountered regularly in the book of Acts.

Some demons are violent and aggressive (Matthew 8:28; Mark 5:1-5; Luke 8:27-29). Others are annoying (Acts 16:16-18). Some people possessed with demons suffer seizures and loss of control (Matthew 17:14-16); some deliberately cut, mutilate or otherwise hurt themselves (Mark 5:5; Luke 9:42). They often make loud cries and screams (Luke 4:33-35). Some cause physical disabilities (Matthew 9:32-33; 12:22; Luke 11:14). Multiple demons can possess the same person (Luke 8:30; Mark 16:9).

If you believe the Bible is accurate in its record of the life of Jesus Christ, you have to believe that demons are real.

The Bible shows that these spirit beings have a profound influence on this world. Often that influence is invisible. But as it grows stronger, it is becoming plainer.

2 Corinthians 4:4 says Satan is "the god of this world." He subtly influences everyone in it (Ephesians 2:2). This has been the case throughout mankind's history—but the book of Revelation says things get much worse at the end of that history. Revelation 12:12 describes a time when Satan "knoweth that he hath but a short time."

Satan's time as god of this world is almost over. After a "war in heaven" (verse 7), which Satan lost, "the great dragon was cast out, that old serpent, called the Devil, and Satan, which deceiveth the whole world: he was cast out into the earth, and his angels were cast out with him" (verse 9).

God warns, "... Woe to the inhabiters of the earth and of the sea! for the devil is come down unto you, having great wrath ..." (verse 12).

"This verse tells us that Satan and the fallen angels—millions of demons—were driven out of heaven and cast down to Earth and are now confined here!" writes Trumpet editor in chief Gerald Flurry in his free book America Under Attack. "Never before has this world been so infested with demons. Look around: The evil proliferating in

every direction has a source, and this prophecy exposes it."

This is the spiritual reality behind the shocking news and modern trends.

It's important to know that something does not have to look obviously evil to be evil. Satan can come as an angel of light (2 Corinthians 11:14). Something can appear wholesome, even appear as though it is from God, yet be from the devil.

But as society is driven further from God, there is less reason to hide or disguise the evil. This is why outright Satanism is now clearly on display.

Multiple Personalities

Perhaps the most naked display of demonism comes from the "multiplicity" movement. Vice described the concept in a May 2015 article "Are Multiple Personalities Always a Disorder?" with an introduction through the lens of Falah Liang, who had sensed the presence of a birdlike man in her mind since she was 5. This presence was joined by others as she grew older.

Vice writes: "A 'multiplicity system' refers to the group within the body itself (i.e. 'I'm part of a multiplicity system'). The system might consist of two people, or it might consist of 200. ... The multiplicity community insists on being seen as healthy—even normal. This is our reality, they argue. Why are you imposing your reality onto us? Dissociative Identity Disorder (did)—and its controversial precursor, Multiple Personality Disorder—are terms roundly rejected by the community, and most of them don't feel that they belong in the Diagnostic and Statistical Manual (dsm) at all."

"With did, it's more like a person's body is a boardinghouse filled with many guests, and you're not quite sure who will come to the door when you knock," states a March 2019 Vice article.

Some of these "multiplicity systems" are so large they think of themselves as a city rather than a person. Others push for more "rights" for other "multiplicity systems" through groups like "Plural Activism."

Those who embrace did so strongly are rare, but the Diagnostic and Statistical Manual of Mental Disorders published by the American Psychiatric Association in 2013 estimates that 1.5 percent of Americans experience it each year. Other estimates say that between 0.01 and 1 percent of the population are affected.

Some have gone on to create a following for themselves on TikTok or YouTube. The most prominent has over 1 million followers. The hashtag #DiD—which will bring up videos of people openly influenced by demons—has 2.5 billion views. One video of a "system" switching between personalities, and the follow-up discussion, got 100 million views. "I get so many comments from people saying, 'Why does everyone have did all of a sudden?" said one "host" of

"a did system of 12."

Since did became a TikTok phenomenon, "all of a sudden, all of my adolescent patients think that they have this," psychologist Naomi Torres-Mackie told Teen Vogue last year.

The TikTok videos make these multiple personalities seem cool and glamorous. The reality, as Teen Vogue admits, is "truly scary"—ranging from amnesia to fits and seizures. Over 70 percent of outpatients being treated for did have attempted suicide.

Letting in a bunch of demons makes a person very miserable.

Witchcraft and Paganism

The Bible links witchcraft, wizardry and the occult with demonism. Some modern witches would make this connection themselves; others consider themselves the worshipers of nature.

When God commanded ancient Israel to avoid those who get into magic and the occult, He also warned against those who "have familiar spirits" (Leviticus 19:31; 20:6)—who talk to demons. In the most detailed example of witchcraft, the witch of Endor in 1 Samuel 28, King Saul went to a woman who had a "familiar spirit." This woman claimed to be putting Saul in contact with the dead Prophet Samuel (verses 11-15). The Bible establishes that the dead do not know anything (Ecclesiastes 9:5, 10). He could not have been talking to Samuel: Instead, a demon was impersonating him.

In the New Testament, the Apostle Paul stated that pagan religions directly worship devils (1 Corinthians 10:20).

Early surveys estimated that in 1990 about 8,000 Americans identified themselves as Wiccans—a form of witchcraft. The 2014 Pew Religious Landscape Study estimated that 1 to 1.5 million were Wiccan or pagan. That's around the same number as attend the Presbyterian church (1.4 million). Even this may undercount. Wicca is quickly becoming yesterday's movement; modern witches are more likely to call themselves "eclectic witches," picking and choosing for As Herbert W. Armstrong explained in his book The Missing Dithemselves what crafts they practice.

Pagan beliefs are even more common. More than 60 percent of U.S. adults hold at least one of the following "new age" spiritualist be-

- that spiritual energy can be located in physical things
- in psychics
- in reincarnation
- in astrology

The "psychic services industry," which "includes astrology, aura reading, mediumship, tarot-card reading, palmistry, among other metaphysical services," is estimated to be worth over \$2 billion annually. Celebrities like the singer Adele have said they use healing crystals. Witchcraft accessories like Tarot cards or supposedly magical symbols can be bought in mainstream stores.

Modern witchcraft, Wicca and neo-paganism are all forms of demon worship. And they are on the rise.

Even practices as obviously occult as using mediums are becoming mainstream. Prince Harry said he contacted a medium to try to contact his dead mother. He is not alone—1 in 5 Americans say they have contacted a psychic or medium. About the same proportion believe that mediums have the ability to contact the dead.

But this movement is also receiving a glamorous online following. "WitchTok" has become a major phenomenon on the TikTok videosharing platform. Videos with tags like #WitchTok have amassed 30 billion views. That's more than tags such as #Biden (8.5 billion) and equal with #Kardashians. Other tags like #babywitch—helping people get into witchcraft—have picked up hundreds of millions.

The Transgender Movement

Perhaps the most blatant evidence of demonism is seen in the rapidly rising transgender movement.

In 1 Timothy 4:1-3 Paul warns of many departing from the faith, listening to "doctrines of devils [demons]." What are these doctrines? Included in his list is "forbidding to marry."

The Bible reveals that demons are fallen angles. They left their first

estate (Jude 6) and rebelled against God. In some passages, demons are referred to as the devil's angels (Matthew 25:41; Revelation 12:9). Like the righteous angels, the demons are sexless and genderless (Matthew 22:30; Mark 12:25).

mension in Sex (request your free copy), God created marriage and family for human beings for a profound purpose—to teach us wonderful truths about our potential to be born as sons of God. The demons have neither this potential nor the ability to reproduce themselves, and so they hate it.

For centuries they have influenced religions to believe that sex is shameful, that being single is better than being married, and that priests should be celibate—none of which is taught in the Bible. Now this hatred is manifested more clearly than ever, with people mutilating their own bodies and taking on "gender neutral" pronouns—imitating the genderless demons.

One in four LGBT youth use gender-neutral pronouns. This movement is even inventing new pronouns. One of the most popular is "fae, faer, faeself." Fae is essentially a pagan word for a demon or spirit. These transgender people want others to refer to them as demons. In fact, pagans are even complaining about the LGBT movement appropriating their word.

Even more closely related to demons is the "two spirit" movement. Billed as a native American version of the LGBT movement, they believe that having two spirits in them is the cause of their homosexual or transgender behavior. The two-spirit movement now has its own flag and is taught in schools in California and Canada.

More extreme still is the otherkin or fictionkin movements, where people identify as animals or fictitious creatures, like dragons, vampires or elves. The Bible shows that many angels—and therefore demons—look like animals (Ezekiel 1:10). Satan himself is described as a dragon. Some will even get extreme tattoos or piercings to look more like the animal they believe they are. Some will even call themselves "demonkin"—identifying as demons.

LGBT individuals, especially transgender ones, are heavily represented in other open manifestations of demonism. Those with multiple personalities are often transgender. A scroll through #WitchTok videos shows they are overwhelmingly from the "LGBT community." A 2015 Pew survey found that LGBT people were twice as likely to have a non-Christian religion—including paganism and Wicca.

Gateways to Demonism

There is a spiritual reality behind the rise of demonism. But there are other, direct causes. Certain behaviors open up the mind to demons, and these are on rise.

"Under normal circumstances ..., no one need fear a demon may

take possession" of their minds, wrote Mr. Armstrong. Generally it can only happen if "you open your mind by letting it be blank, or under control of another, or you lose your mind in an emotional angry rage" (Worldwide News, December 1980).

Certain religious rituals are designed to let the mind go blank and allow a demon to take control. But far more common today are mind -altering drugs that break down the mind's defenses and can allow in demons. In 2021, over 100,000 people died of drug overdoses in the United States. The 2017 National Survey on Drug Use and Health estimated that 20 million Americans age 12 and over had a substance disorder. There have been some well-publicized examples of addicts having their whole personality change—and they have gone on to violently attack others. One such individual videoed himself attacking and then eating his homosexual partner. "There is such things as monsters, demons and ghosts," he wrote on his Facebook page. "They live inside of us, and sometimes they win."

Dabbling in the occult is another way to invite in demons. God admonishes us to "have no fellowship with the unfruitful works of darkness, but rather reprove them" (Ephesians 5:11). Today, it's mass entertainment. Harry Potter opened the mainstream floodgates. Half of Americans ages 18 to 34 have read at least one of these books; 61 percent of Americans have watched one of the movies. Books and movies about zombies, werewolves, vampires and witches are common.

Video games can also prove a potent gateway—they are highly addictive and often coupled with violent or demonic themes.

The Bible reveals that music has a powerful connection to the spirit world. Uplifting music from David could cause demons to leave (1 Samuel 16:14-18). On the other hand, the Bible says Lucifer was created with musical pipes—innate musical ability (Ezekiel 28:13).

He is the real author of depraved music, and an evil musical environment can open up one to demonic influence (article, page 7).

Pornography and perverted sex can be another gateway, with the demons' hatred of godly principles of marriage and family (article, page 35).

1 Timothy 4:3 also labels vegetarianism—forbidding to eat the meats that God has proclaimed fit for human consumption—as a "doctrine of [demons]." The Internet alone does \$10 billion to \$13 billion worth of business in pornography every year just in America! It is the most profitable online business. We also sacrifice our children to demoniacal music, drugs and greed. In the nations of Israel, this is done even before our youth are taught to use their minds!" Sadly, these trends have reached such extremes that today, some children have become possessed.

A God More Powerful Than Demons



A digital dollar that would give them complete control of your money. Unlike the current dollar, this new digital dollar would not exist in physical form. You wouldn't be able to go to a bank or ATM and withdraw it. It's a digital currency, but it's very different from bitcoin.

Cryptocurrencies like bitcoin operate on blockchain technology, which is *decentralized* by design.

Digital U.S. dollars, on the other hand, would be *centralized*, completely traceable and programmable by the Puppet Masters.




