WHAT THE MEDIA DON'T TELL ABOUT THE MAUI FIRE – TAKE TWO



n the September issue I presented "What the Media Don't Tell About the Maui Fire Part 1". That article contained the writer's (ReallyGracedul) insinuations and insights into the possible motives and methods that led to the Maui fire.

That article revealed that the Maui Police check whose name is John Pelletier



is also the coroner of Maui. In most jurisdictions, the coroner and the chief of police are considered "incompatible" offices that cannot be held by the same individual. This is because the roles of law enforcement officers and coroners are slightly different at a death scene. Law enforcement officers are concerned with whether a crime has occurred, while coroners are responsible for determining the cause of death.

However, in Hawaii, (it is reported) that the chief of police or his authorized subordinate can act as the coroner for his respective county. This is unlike most states.

It would be worthwhile to repeat here that the same John Pelletier was the Incident Commander at the 2017 Las Vegas country music mass shooting. It's also unusual that Pelletier graduated from the FBI Academy (even though he served in local law enforcement in Las Vegas and Maui county) and that he graduated a certain course of training at the FBI Academy in Quantico at which the FBI Director Christopher Wray personally attended the ceremony. Obviously, Mr. Pelletier is well connected. It may be advisable to look more closely into his involvement in the Maui tragedy.

Is THIS the reason why blue cars, blue umbrellas and other blue things didn't burn in the Maui fires?



Inquisitive minds are not buying the official story that the fires in Maui were a natural and unexpected event – and certainly not one that is the product of some mythical concept like "climate change" or "global warming."

Like the recent fires in California and Australia, the Hawaii fires are "unlike anything we've ever seen before," to quote Greg Reese of Infowars, who put together the following informational video about what many believe really happened in West Maui.

They are being called 'forest fires' and 'wildfires,' but they are clearly something very different."

"These fires are burning homes into a white powdery ash footprint while often leaving the surrounding green trees and shrubs practically untouched. In extreme cases, forest fires can reach temperatures of up to 1500 degrees Fahrenheit, and the melting point of aluminum is 1220 degrees Fahrenheit, so it is possible for an extreme forest fire to melt aluminum."

"But there are cars with puddles of melted aluminum that were clearly not in the wildfire area, and melted glass, which has a melting point of around 2500 degrees F. These are unexplained anomalies."

As was also the case with the 2018 California fires, objects such as cars and homes burned to a crisp and basically collapsed into their own footprint, leaving behind nothing but white ash.

Greg Reese of Infowars stated "We've seen these same anomalies in New York City on Sept. 11, 2001 – cars completely burned out with no explanation,"

Disturbingly, the Maui fires were highly selective in what they burned. Poor and middle-class folks had their entire homes and livelihoods reduced to ash while the lavish estates of rich people like Oprah and Jeff Bezos remained unscathed.

"In Maui, these unnatural fires spared the homes of the rich while burning the native homes of the working class," Reese explains. "With precision, these fires destroyed the most envied, high-valued areas of Maui."

It is fast becoming common knowledge that the government has at its disposal directed energy weapons, or DEW technology, that utilizes lasers and light to target certain objects and places for destruction while leaving the surrounding area alone.

"For decades, directed energy weapons have been classified, but they have been on the public record for several years now," Reese says. "Directed energy weapons, known as DEWs, have the ability to burn homes with this sort of precision – but in order to be this precise, the area would have to be mapped out."

It turns out that, back in January, many local residents of Hawaii observed strange green laser lights in the sky. Reese says these lasers are proof-positive evidence that the government was mapping the terrain in advance using a geospatial array.

After the fires destroyed Lahaina, many blue-colored objects were observed to have not burned even though everything else around them was burned.

"We have seen that among the ashy ruins, there are blue-colored objects that have somehow survived the devastation: blue cars, blue umbrellas, a blue boat, blue planters," Reese says.



"Videos online are going viral that show how lasers can easily burn through certain-colored objects, but objects that are colored blue remain unharmed." DEWs include not only lasers but also millimeter waves and microwaves, both of which are used in the naked body scanners at American airports.

"They are all based on light frequencies, and different wavelengths of light affect colors differently," Reese says. "For example, in laser tattoo removal, different wavelengths are used for removing different colors. And this is because color is a quality of light. Each color has its own frequency."

The color blue, which was unharmed in the Maui fires, has a frequency of 6.66

That's interesting.

On August 8th, almost one month ago, a wildfire raged through the Hawaiian town of Lahaina on the island of Maui. This has been one of the worst disasters in US History. Although it has been a month, the mainstream media is still not covering this story. So we're going to cover it here this week on Wolves and Finance.

I'm going to start by showing you some images of the aftermath. The town is completely destroyed. Two thousand, two hundred structures were destroyed on 2,170 acres.



One of the things that made this fire so bad is that many of these buildings had propane tanks that exploded. The fire burned so hot that everything burned up. There is nothing left.

Let us start with the conspiracy theory. People have been claiming that the fire was set intentionally. They claim that evil billionaires

wanted to steal the land from Native Hawaiians. People like Oprah and Jeff Bezos are well known for their attempts to buy land on Maui.



The theory claims that the billionaires are working together with the CIA and started the fire using space lasers.



These same billionaires also have houses with blue roofs.



The strange color of blue is set to stop the electromagnetic effects of the space lasers. The goal is to implement the plans of the World Economic Forum to rebuild Lahaina as a 15-Minute Smart City.



This would be a new type of city that does not allow residents to go more than 15 minutes away. It is powered by infrastructure like facial recognition cameras, 5G cell towers and roadblocks. It is all run by artificial intelligence that would lock the citizens inside as prisoners under the justification of climate change.

Meanwhile, a global crisis would cause massive depopulation around the world. Millions would die through war and famine, and the global elite would live through the chaos on their massive estates on Hawaii while the local population would be locked away in the 15 Minute City. To accomplish all of this, they just had to get rid of Lahaina.

Now, I don't believe this conspiracy theory, but it is resonating with people because some of it has already come true. The governor issued an emergency proclamation on August 19th that no one could make unsolicited offers to buy land in the affected ZIP codes in order to allow residents time to recover. But rich developers have simply been ignoring the law. Authorities have received 8 complaints of developers trying to buy the land. The governor himself has offered to buy up the land. He said "I'm already thinking of ways for the state to acquire that land so that we can put it into workforce housing to put it back into families or make it open spaces in perpetuity as a memorial to the people who were lost." Why is everyone trying to take this land? I have to say, it is a little strange to paint the roof of your house blue. Why would you do that? My roof isn't blue. Is yours?

The reason I don't believe this conspiracy theory is because I think there is a more likely explanation. It is possible that the government officials were just incompetent. The fire could have started and the officials froze like a deer in the headlight. They didn't know what to do, and were too afraid to do anything because it might make matters worse. So, they just stood there and watched the town burn down. I think this is the most likely explanation because we saw a similar thing happen before during the disaster of Hurricane Katrina. Do you remember that?

A hurricane broke the levee surrounding New Orleans and flooded the city. It killed 1,836 people. Tens of thousands of people were left stranded with little food, water or shelter. People were living in the Superdome for a week. There were dead bodies scattered on the ground. Many people blamed the incompetence of the head of FE-MA Michael Brown who was appointed by George W Bush. Michael Brown's prior work experience was as the head of the Arabian Horse Association. It is unclear what made him qualified to run FE-MA. Kanye West went on national TV and said George Bush doesn't care about black people. I think what Hurricane Katrina showed us is Los Angeles. This was a nationwide effort by the FBI to target Caththat sometimes the government is not good at handling disasters. These are the things that have never happened before. Sometimes government employees are incompetent. Sometimes they make bad decisions. I think the same thing happened in Lahaina. It was a horrible disaster and the government was just not good at handling the disaster.

The biggest example of this is that almost a month later, we still do not have a definitive death count. After a month, we have no idea how many people died. That's pretty incompetent. As of last week, 115 people are confirmed dead. The FBI is helping with the investigation and has announced that 385 people are still missing. Now, if someone has been missing for a month at this point, most likely they're dead. Part of the problem is that there's no bodies. Normally you could walk around after a disaster and count the bodies. But in this case, the bodies were burned up, so there are no bodies to count.

What has created a lot of controversy is that the death toll keeps changing. I explained that the FBI said that 385 people are missing. But two weeks ago, on August 21st, the Hawaii Department of Education released a statement saying that 2,025 children were still missing. The local school in Lahaina had burned down in the fire. So all the children who went to that school had to be reassigned to other districts. As of August 21st, 2,025 children had either not reported or the school district had been unable to locate them. Where are the missing children?

The FBI is controlling the missing persons list. How is the FBI's getting their names of missing people? Have they checked on the 2,025 missing kids or are they ignoring them? Let's think about this. What do we know about the FBI? We know that they are liars. They have lied to the American people multiple times now to protect the Biden administration. Just as an example, the head of the FBI, Christopher Wray just went in front of Congress and lied under oath about a memo the FBI wrote about targeting Catholics as terrorists. Do you remember this? He apologized and claimed that the memo was a single product by a single field office out of Richmond. Well, after his testimony, a new version of the memo surfaced that showed the memo was a product of multiple field offices, including Portland and olics. Christopher Wray lied about it in front of Congress and committed perjury. I think it is a possibility that the FBI is lying again They could be hiding the number of dead kids so Joe Biden doesn't look bad. Can we at least get an explanation of why two government agencies are telling us vastly different numbers? I think it's likely that the death count is going to be a lot higher than their reporting and a lot of the deaths are going to be from children. Just like George W Bush was criticized for Katrina. Joe Biden has been criticized for Lahaina.

So how did this happen? There are still going to be investigations, but we do know that there are a number of things that went wrong. There were issues with the power lines. It is important to understand that there were two fires. There was a fire in the morning and then a fire later in the day that would burn down the town. The power company has admitted that they started the first fire. There were strong winds that blew down power lines and the sparks started the fire. Firefighters arrived and put out the first fire and then left. People do not know what started the second fire. The power company did turn the power back on to the lines which were still down so that could have sparked more fires. But the power company blames the fire-

fighters for leaving before the fire was fully put out. The firefighters blame the power company. The power company has not explained yet why they would turn the power back on if they knew the lines were still down. However the 2^{nd} fire started, it resulted in the town burning down.

Next, the children had been let out of school. This is what made the fire so devastating. Because so many children were involved. It was normal to send the children home because there were extremely high winds which had already knocked down the power lines and shut the power off. So many of the parents were away at work and the children were sitting at home while the fire burned. That is why so many children died.

The alarm warning system did not go off. The town has sirens that they test once per month. These were installed mainly in case of a tsunami, but they are used for other disasters as well. When the sirens go off, the residents know to go out of their homes because they may need to run for their lives. It turns out that a decision was made to not sound the alarm. Maui County's Emergency Management Administrator says he did not sound the alarm because he did not want people to get confused and run towards the fire. The problem was that if you were a kid and you're at home from school playing video games in your house, you're not going to know a fire is raging all around you. If the alarms had gone off, the people would have at least come outside their houses and figured out what was going on.

What is so infuriating is that this is still a problem. Since Lahaina there have been other wildfires in other parts of Maui. Those fires were not as devastating, but more buildings have burned down. And once again they decided not to sound the alarms. Why are they doing this? If a town is burning down, sound the alarms! We know it would have saved lives, so I don't understand why they're not doing it other than to try and justify their actions in Lahaina. But it is continuing to put more people's lives at risk.

Next, the fire hydrants did not work. So the firefighters showed up, but they could not get any water out of the hydrants. So far, we don't know the reason why. But we do know that the firefighters did not

do anything to try and stop the fire because they had no water. We also know that officials refused to release water to fight the fire. The deputy director of the Hawaii Commission for Water Resource Management received the request for more water to fight the fire. He initially refused the request in order to check if users downstream would be affected by the diversion. So rather than just release the water, this guy had to check to make sure it would be equitable for everyone. Meanwhile, people were dying. Permission was eventually granted 5 hours too late.

What made matters worse is that the police were blocking the roads out of town, trapping everyone inside. At least one account said that one road was blocked with chains keeping people from leaving. It is unclear who gave these orders and why. But there were people who were sitting in their cars trying to get out of town and the police were telling them to wait inside their cars. Everyone who waited in their cars was burned alive. Some of the people left their cars in the road, jumped in the ocean and survived. In this situation, all the people who complied with what the government was telling them to do died. The people who did not listen to the cops, stayed alive. All of these things together made this disaster so bad. The investigations are still ongoing and more information will likely be uncovered.

There's something else that I wanna highlight that I don't hear anybody else talking about. So, I've looked at a lot of these photographs of the ruins of Lahaina. And I noticed something interesting. Do you notice anything about this photograph?




There is one large major building that was not destroyed by the fires. This is the Lahaina Shores Beach Resort and it's owned by Hyatt Hotels. It is a giant hotel that is in the middle of Lahaina right on the

beach. And so it's curious to me that when the rest of the entire town burned down this building remains standing. How is that possible? You know, when we think about how the water in the hydrants had no pressure you have to wonder were the hydrants around this hotel working? And it could be the case (now I don't know this for sure), but it could be the case that water was routed to this hotel first before the rest of the town. And the water system could be designed this way. The water system could be designed to give favoritism to the big beach resorts. Maybe even the beach resorts paid for this. So it could just be something inherent to how the social structure of that city was developed where these big tourist hotspots would take all the water resources and not leave anything for the residents. Well, what would result would be this photograph where the rest of the town is devastated and this hotel remains standing.



I think this photograph is evidence of what's actually going on in Lahaina. And it doesn't even have to be anything suspicious. It's just that the hotels get preferential treatment and the residents get screwed.

Joe Biden continues to receive criticism for the fires. This time it is for the lack of support during the recovery process. The survivors of the fire are going to receive a one-time government check for \$700.00. That doesn't even cover one month's rent for people. Investor sentiment often dictates key market moves...

To understand market dislocations, you have to be able to recognize market patterns...

To get the most out of Marks' investment approach, though, we need to consider the broader market outlook ...

Several macro signals are pointing to an "irrational" market...

In our monthly newsletter Timetable Investor, we summarize macro market signals and explain how they can help position investors for the next three to 24 months.

Two of those key signals involve credit and corporate investments...

Credit has us worried right now because it is continuing to tighten, and that could lead to a credit crunch by early next year.

Corporate investments show us whether companies are putting capital to work and help us project future earnings. Right now, earnings are forecast to shrink this year... and that's not great for the overall economy.

Knowing this context, we can use Marks' framework to figure out if investors are currently too bullish or too bearish and adjust our investment strategy accordingly ...

With these two negative macro signals in play, it makes sense for investors to maintain a bearish outlook.

And that's what investors are doing right now...

We can illustrate this point by using the National Association of Active Investment Managers ("NAAIM") Exposure Index...


This index draws data from a weekly survey that tracks the proportion of assets members invest in equities. Results tend to fall between 0% and 100%... They can be lower than 0% if investors are shorting stocks or higher than 100% if investors are using leverage to buy assets.

The long-term average allocation falls between 60% and 65%. That means active investors in an average market have 60% to 65% of their assets in stocks.

After all, investors seem overly optimistic at a time when key fundamental markers give us reasons to be more pessimistic.

Marks' framework also suggests that today's overall market is "irrational," meaning there's a clear dislocation between fundamentals and investor sentiment.


And when the market gets overly bullish, that means a negative correction could be coming soon. (We still think we're heading for a sideways market.)

However, I do differ with his opinion that China offers a good alternative as a place to work compared to Japan. At this time, I don't agree with that. With Japan's population aging, many policymakers are considering diversity as the final option for Japan to open up and save its finances, potentially preventing a collapse in the 2040s. Japanese politi-

cians have finally realized that the country needs workers, but the question remains: does the workforce truly need Japan? While in the past, people may have been interested in moving to Japan, over the years, the Japanese economy appears to be weakening steadily, with no clear signs of improvement.

Several factors contribute to this situation. We can start with issues like wages, taxes, and the work culture in Japan, which hinder the nation's ability to attract workers, particularly from Southeast Asia. However, here I will highlight key points that indicate why Japan may struggle to attract global talent, especially when compared to places like Hong Kong or Singapore, which have the capacity to draw in foreign workers.

Weak currency



So the police interviewed the lady who dropped off the forms. She explained that she was dropping off the forms as part of her job. She was paid \$1,150 per week. Her job was to find unregistered voters. Also strange, she explained that she was paid by pre-paid cash cards. I am not sure that's legal with the IRS. How are they paying their payroll taxes? So the police raided the offices of the company. They found a voter registration operation going on. There was a table covered with voter registration applications, computers, semi-automatic rifles and pistols. What? Why does a voter registration company need semi-automatic weapons? It should have been impossible to wreck San Francisco.

It is the world's most naturally beautiful city, with perhaps the most ideal bay, harbor, and ports of any coastal metropolis.

San Francisco is America's premier window on the East. It serves as the natural conduit of commercial and cultural exchanges with the rising wealth of Asia and its dynamic economies in China, Japan, South Korea, and Taiwan. During World War II, the Bay Area was the shipping point of supply to the Pacific Theater. The same role was true of the Korean and Vietnam wars, and could be again if China were to invade Taiwan.

The weather is mild year long. Mountains and shoreline are side-byside. It is the gateway to the wine country of Napa, Mendocino, and Sonoma counties.

A mere decade ago, San Francisco downtown commercial property was among the most coveted and high-priced in the nation.

Prior generations had left behind once state-of-the-art clean and efficient mass transit. They built five majestic bridges across the 1,600 square mile sprawling bay and estuaries that connected the city and its environs to millions of suburbanites.

The city has access to the state's main freeways that head out eastward, northward, and southward. Our ancestors long ago solved San Francisco's water problems by importing vast amounts of potable water in aqueducts from the distant Hetch Hetchy and California Water Project mountain reservoirs. some of its trillions of dollars in market capitalization. Not long ago, some of the nation's major corporations were based in the city itself, including Craigslist, the Gap, Levi Strauss, Lyft, PG&E, Charles Schwab, Salesforce, Twitter, Uber, and Wells Fargo.

Two great universities—UC Berkeley and Stanford—bookended the city. Both from their top-ranked graduate and professional schools turned out yearly scores of Bay-Area topflight engineers, computer scientists, doctors, lawyers, and business leaders.

Four Bay-Area California State University campuses—in San Francisco, Vallejo, Hayward, and San Jose—graduated thousands of teachers, nurses, businesspeople, and vocational professionals. The Bay Area Community College Consortium claims 24 of the state's best junior colleges in the greater Bay Area region.

In other words, San Franciscans inherited one of the most successful, multi-tiered, private and public higher education system in the nation.

San Francisco was of course also famous for its role in sparking social change from the Haight-Ashbury/Winterland days to the Gay liberation movement to the Green/Sierra Club/Planet Earth days. At one time, the city's cable cars, Golden Gate Park, Zoo, Palace of Fine Arts, Fisherman's Wharf, Ghirardelli Square, and Pier 39 drew in over 25 million tourists each year. Hollywood saw San Francisco as one of its favorite film sites.

It is that majestic inheritance that an arrogant, ignorant, and incompetent current generation of San Franciscans destroyed. The present hubristic elite took their inherited wonderland and, in a decade, finally turned it into a moonscape. And it was such a dystopia that many who created it soon wanted no part of it, and so headed off to Texas, Florida, Tennessee, and Idaho where they sought a pristine city to work their magic of destruction all over again.

The current elite certainly did not deserve the beautiful and functional city that they inherited from far better generations—only in their utopian egotism systematically to ruin it, rendering it now more unlivable than a Detroit.

Watch any on-site, live shots from films of the last seven decades, from the 1950s onward until the last decade—Vertigo (1958) to Bullitt (1968) to even Blue Jasmine (2013). And the incidental city shots reveal little trash on the streets. No blocks of empty windows appear on screen. Hordes are not seen living in filth in the sidewalks. Passersby seems normal and even well dressed.

Of course, film crews of those eras were not subject to serial smashand-grab car break-ins, the swarming of stores, exempted and routine shoplifting, unpunished carjacking, and no-bail, same-day release of arrested violent offenders.

Silicon Valley had slowly crept into San Francisco, suppling it with

So what happened?

In a word, too much astounding wealth and too much abject poverty created a medieval keep surrounded by a village of peasantry outside the high walls.

California in general, and in particular the Bay Area, ushered in the greatest concentration of wealth in civilizational history, with some nine-trillion dollars of market capitalization from Silicon Valley.

An eight-billion-person world increasingly all had an iPhone or Mac and ran Google searches or Facebooked or Tweeted—and their money ended up from Union Square to Sunnyvale.

As a consequence, twenty- to forty-somethings believed their astounding riches were proof of their astounding morality, genius, and deserved entitlement.

Their utopian legacy was a bankrupt high-speed rail system that will take a half-century and \$300 billion to travel quickly from Bakersfield to Merced. They gave us a fantasy world where the more a criminal steals, maims, and kills with impunity, the more the exempted lawbreaker will view such enlightened magnanimity by reciprocating with proper and civilized behavior.

Green religion has all but destroyed the once rich California timber, mining, and gas and oil industries and explains much of the strangulation of the middle class.

Bay Area voters and legislators ensured that in times of draught millions of precious acre feet of water flowed out to sea rather than were stored in reservoirs or used to grow food for a hungry state.

Only in California and only with the prompt of a Bay Area radical chic, would a state use \$500 billion, in part from a "water bond" designed to increase water storage, to blow up four dams and reser-

voirs that provided clean hydroelectric power, stored precious water in times of draught, ensured flood control during dangerously wet years, and offered recreation to thousands of the despised middle class.

On the opposite socio-economic scale came an influx of immigrants from south of the border and Asia. Over a fourth of the state's current residents was not born in America.

California hosted the largest number of unaudited and illegal aliens in the nation. It greeted them with the greatest sanctuary city and county protection racket in America. The state's schools and culture indoctrinated the newcomers with the paradox that their escape from poverty, violence, racism, and corruption was ironically to a nation and state supposedly even worse than where they came.

How odd that many of those who escaped violence and racism, and entered the U.S. illegally, arrived with demands on their hosts for previous bad treatment—on the prompt of the wealthy who had done so well in America.

The result of all this chaos is that the state and especially the Bay Area have the greatest number of billionaires in the nation, the most numerous rich zip codes and congressional districts, the highest cost of living, the most expensive homes, gas and power and food that are unaffordable—to accommodate the largest number of homeless people of any state, the greatest number of people who live under the poverty line, and the most numerous welfare recipients in the country.

Translated into the streets of San Francisco that means laws, regulations, and rules do not apply to the underclass since the sheer extent of noncompliance and illegality makes statutes unenforceable. But in financial and psychological recompense, all this statutory cargo most certainly does apply to the middle class who are harried, talked down to, and despised by the elite as a way of squaring the circle of their impotence through harassing the innocent, given they are unable to regulate, tax, and sermonize to the underclass.

Add the people, policies, and politicians up, and conclude that if one did not have a current San Francisco, California, one would have to invent it—given the present disaster is the logical and ultimate expression of the classical hubris of excessive pride and arrogance leading to atê of out of control behavior, culminating in nemesis, the inevitable divine retribution that brings warranted punishment for such haughty and arrogant egoists.

The final, the surreal paradox?

Gavin Newsom may well be the Democratic presidential nominee, edging easily out another San Francisco failure, Kamala Harris.

Newsom may well run on the campaign pledge that he wants to replicate for the United States what he did to San Francisco and Califor-

The Storm before the Calm



am writing this article in August in the midst of Hurricane Hillary bringing a storm to Southern California. So the timing is appropriate for writing an article entitled *The Coming Storm*. The storm I am referring to is the coming economic, political and social storm that has been envisioned by the renowned geopolitical analyst and commentator George Friedman in his book *The Storm Before the Calm* published in February 2020. I am taking my notes on this book from an article written by a friend of Friedman, John Maulding who is himself a renowned economic commentator and whose publications I subscribe to.

Mauldin writes that everything about human life has a rhythm. It is literally built into our bodies: Your heart beats in a repeating pattern that keeps you alive. Your breath is another pattern. Repetition is natural for all of us individually and for the societies we create together. Every society has its own rhythms and traditions.

But there are larger, less formal patterns as well. Mauldin has reviewed Neil Howe's new book about the *Fourth Turning*. Mauldin's friend Friedman also wrote a book entitled *The Calm Before the Storm* about the geopolitical realm. Friedman's view of how patterns shape countries is different but not inconsistent with Neil's generational cycles.

The remarkable part in Mauldin's opinion, is how both point to a severe crisis later this decade or in the early 2030s. When these thoughtful people independently send the same kind of warning signal from different disciplines, perhaps we should be paying a great deal of attention. And planning for our own individual/family/ company and even national responses.

The events predicted in *The Storm Before the Calm* are unfolding rapidly now, and the pace will only quicken as the crisis approaches.

Here is a short analytical synopsis of The Storm Before the Calm.

An Invented Country


Let's begin with a distinction Friedman considers critically important: The United States isn't like other countries. Its uniquely powerful role in the world relates directly to its unique origins.

Other great powers can trace their "nationhood" back much further. France, for example, already had a distinct culture, language, religion, and national identity centuries before Europeans began settling in America and the New World. The European explorers found here a vast continent, populated by indigenous peoples who were eventually overwhelmed, either by force or by foreign diseases to which they had no immunity. It wasn't the prettiest of pictures. The various European groups along with slaves from Africa, some Asians, and the remaining Native Americans blended into something entirely new in a relatively short time. Two hundred years isn't that long in the major nation building process.

This is important because it makes comparisons fail. No large nation in terms of population has ever developed like the US has or with the kind of geography the US has. The US is truly unique in geopolitical terms, making its path through history unique as well.

Examining US history since independence, Friedman observed two repeating patterns: an 80-year institutional cycle and a 50-year socioeconomic cycle. Each cycle peaked with a defining crisis, and we are approaching a point in which both waves will crest at about the same time.

This is why Friedman sees a rough period coming. For the first time, we will have an institutional crisis and a socioeconomic crisis together.



Incidentally, this is a key difference in Neil Howe's demographic theory in *The* 4^{th} *Turning*, which emerges from the human life cycle.

The Turnings happen everywhere, though not every country is on the same timetable. The institutional and socioeconomic cycles Friedman describes are US-specific. They have global importance, however, because the US is so large and influential.

Two Kinds of Crises

In the book Friedman describes how US history unfolded through these cycles. As a history buff Mauldin found that part fascinating. As an investor and citizen, though, Mauldin wants to know what they mean for the near future.

It helps to compare the current cycle crests with their previous iterations. Let's start with the 50-year socioeconomic cycle. Friedman pegs the last peak in 1980, meaning the 1970s were the critical period.

What was happening?

On the social side, Friedman points to what we now (rather quaintly) call the "Sexual Revolution" as key. Changes in sex-related attitudes, marriage, no-fault divorce, abortion, birth control, women's rights, all combined into a huge social change.

Economically, the country faced inflation but also instability in what had been a national treasure, the automotive industry. Remember the Chrysler bailout? That was 1979, and it helped produce Reagan's 1980 win and begin a new cycle.

Now roll forward 50 years. Sex and gender issues are again leading the national discourse. The court ruling (Roe v. Wade, 1973) that helped launch the previous cycle has been reversed, leading to great controversy with political effects. Economically, we are seeing the crown jewel technology industry lose much of its shine. It will survive, just as the auto makers survived, but may never regain its previous exalted position. (Technology is always changing, of course. Railroads and electricity were once the cutting edge. Communications of all types changed our culture. But then while they remain important, they are no longer the dominant new thing.)

All that means the country is in social and economic turmoil at the same time as yet another cycle—the institutional cycle—is peaking, too. Friedman says this cycle runs about 80 years, beginning with the Constitution's passage. The first crisis came 78 years later with a highly destructive Civil War that settled not just the slavery issue, but also the federal government's supremacy over the states.

The second institutional crisis, again about 80 years later, was World War II. Combined with the various Great Depression programs, it redefined the federal government's role in the economy. With Bretton Woods it also reordered the global financial system, giving the US undisputed leadership—at least for a few decades.

This period produced "government by experts." FDR and then Truman (understandably, given the magnitude of their challenges) gave unprecedented authority and influence to those thought to have special abilities. This persisted after the war, seen most recently when Presidents Trump and Biden both turned over COVID crisis management to experts who, while well qualified in their specific narrow fields, couldn't provide the kind of cohesive leadership the country really needed.


That failure may prove key to what lies ahead.

Failing Experts

As Friedman notes, we haven't seen the two cycles intersect in this way before. This makes anticipating events even more difficult but it seems likely we will face social crisis, economic breakdown, and structural political change—all at the same time. What will that look like? We should know soon.

Friedman points to one fundamental, overarching problem that encompasses both cycles. In the last 50–80 years we Americans have lengthened our lifespans while also reducing reproduction. This is wonderful in some ways but is also causing serious problems socially, economically, and politically.

The economic part you probably know. The demographic changes produced a growing excess of retirement-age Americans, who (unless they keep working) are no longer productive but continue consuming goods and services. Here's a chart showing the ratio between elderly (65+) and working-age (15-64) Americans.



In 1980, the peak of the last socioeconomic cycle, the US had 5.9 working-age residents for each elderly person. That ratio will have dropped almost in half (to 3.1) by 2030. This is why Social Security and Medicare are unsustainable as presently structured. Something will have to change in the next 5–10 years, and any way we do it will produce a lot of anger.

Could this mark the socioeconomic crisis Friedman projects for this same period? Maybe. Or, if we're lucky, advanced biotechnology might solve some of the health challenges surrounding old age, reducing healthcare costs and enabling older people to stay in the workforce if they so choose. In that event, we would still have a crisis but for different reasons.

In fact, Friedman summarized this view in his recent Friday morning essay:

"When I was young, the Armageddon that people feared was a population explosion that would overwhelm food supplies. No one at the time could have predicted the effects of birth control and the shift in gender roles. Reproduction became an elective project, and universities were filled with earnest students committed to reducing the population without mass murder.... How then does this end? I will stay with my original forecast that it will be solved by researchers developing solutions that keep the elderly productive until they die. If this happens, then the workforce can stabilize, and society doesn't have to choose between well-being and barbarism [of abandoning the elderly]. I foresee a solution; the population will not eat us out of house and home. But until then there will be unrest. The solution to that problem has created a vast new problem that will end in a new crisis. People don't act until the fear of the devil is placed on them and another crisis threatens everyone. Only the evil fail to see it."

The institutional crisis is clearer, in Friedman's view. He believes, as in the pre-Civil War period and the Great Depression, people will have a sense of catastrophe, a belief everything is failing—even the government itself.

In a recent conversation Friedman told Mauldin that COVID showed, again, how our government has problems dealing with emergencies. That's not a partisan thing; it's more a feature of our constitutional system. The Framers designed the government to be slow and inefficient. This has advantages but also leaves us vulnerable when something unexpected happens. We respond slowly.

Trying Everything Else

Now, combine this with the whole "experts" problem. COVID is only the most recent example. It also goes back to the War on Terror, the 1990s financial crises, Vietnam and McNamara's Pentagon "whiz kids." The 2008 financial crisis, too. Something bad happens and presidents call in the experts who tell them what to do. Their ideas don't work, we try others, and eventually get it right.

Cue the Churchill quote: "You can always count on the Americans to do the right thing after they have tried everything else."

But meanwhile as we try everything else, things get worse.

The Federal Reserve is a similar case. In 1913, after decades of severe banking and financial crises, it was decided we should have a central bank led by a panel of eminent, non-political experts. The sentiment wasn't wrong; giving control of the money supply to Congress would have its own problems. But the experts are hardly infallible. This is now becoming obvious in many different ways.

And that non-political goal? It is morphing into an elitist, paternalistic (in the true meaning of that word) organization whose leaders wrongly believe they are wise enough to fine tune and control a large free market economy of 330 million people, let alone shape the global world around them. And whose views and philosophies are

increasingly, patently problematic. As an example, why is the obviously flawed Phillips curve still even mentioned in polite society? Any business that tried to adopt such an obviously flawed—if not failed—philosophy would soon go out of business. Yet we cede even more power to these "experts." In the US, in our drive to "try everything else" first, typically the currently "easy" solution, which gives someone else the power to solve the problem, we do seem to make everything worse.

Friedman very recently wrote an epilogue to *The Storm Before the Calm.* It is a fascinating analysis of where we are today in Friedman's typically blunt manner. Quoting a few paragraphs from the end:

"For this to happen, the federal government must be restructured. The post-World War II model of a deep interlocking of private life with a federal government helmed by experts, poorly overseen and managed by those who can't see the unintended consequences of expertise, has been outstripped by reality. It is not the size of government that matters but its claim to authority....

"The first institutional cycle [the Revolutionary War] did not define the relationship between federal and state governments. The second [the Civil War] established the primacy of the federal government but did not set its limits. The third [WW2] created almost complete [federal] domination of the states. All were in their time what was needed.

"It follows that the next cycle will be one that accepts the federal government's primacy but will necessarily require the creation and institutionalization of a new level of expert—the generalist—to make certain that the area experts are both effective and non-contradictory.

"The deeper problem is citizens' access to the government. Here, I expect that the core relationship of government to states will remain, albeit with two notable changes. First, the states will have at least an informal role in federal decision-making. Second, the states, much closer and more sensitive to their citizens' interests, will become a channel for allowing citizens to petition their government. This will, in turn, result in curbing unilateral federal authority over states, and shift the World War II model to one that is collaborative or adversarial, both of which achieve the same end."

To Mauldin this is an important insight and one we should pay attention to as we try to navigate the rest of this decade. What we lack, in Friedman's view, are "generalists" to weigh the competing interests and make decisions for the public good. They can and should get expert advice, but we have to separate that authority/expertise from decision-making over the breadth of society. The decisions should be made by someone responsible to the whole country and selected by the whole country—the president, in other words.

Friedman expects the president whom we elect (or reelect, if it's Biden) next year to have a very difficult term, dealing with one crisis after another. The 2028 election, if he is right, will then bring a dramatic shift that clears out the system. He expects turbulence but then smoother sailing. Hence his book title, the "storm" before the

"calm."

Is all this necessary? No, but it's seemingly how we do it here. Friedman thinks the US is as wealthy and powerful as we are because we have these crises. Periodically we remove incompetent leaders and flush out the system, which lets us start over. And every time we start over it's from a higher base.

Here, we are only scratching the surface of Friedman's book. We should all read it (and his epilogue) to get the full wisdom.

Time will tell if Friedman is correct in his prognostications. Sufficient time always reveals the truth.

Fasten your seatbelts. Take a look at the courses taught by Harvard Law School.

Critical Race Theory is a mandatory course at all elite law schools. Harvard is known as the People's Temple of Critical Race Theory. They believed that any power, including statutes, should be viewed with a focus on America's original racist sins. Harvard's course catalog:

Critical race scholars emerged in the 1980s and made a number of controversial claims regarding law and legal education. They claimed that race and racial equality permeated American law and society. They also said that structural subordination was endemic and that both critical and liberal legal theories marginalized racial minority voices.

Harvard Law students also study monkeys, or the values that humans can learn from apes. The Bonobo Sisterhood at Harvard Law is a one-credit course where future legal elites study:

The power and potential for female alliances to undermine patriarchal systems. We ask, through a legal and political lens, as well as a social, cultural, economic, and cultural one, what lessons bonobos, our close primate relatives with whom we share 98.7% DNA, can teach humans about creating a society that is free from male sexual coercion.

The textbook is The Bonobo Sisterhood: Revolution Through Female Alliances. Ashley Judd begins the forward to the textbook with:

This book offers you a vivid vision and a detailed strategy for forming revolutionary alliances with women, such as the ones typified by the Bonobos, the least-known of the great apes. . . . I've seized the Bonobo Call for myself.

Diane Rosenfeld, both as the instructor and the author of the textbook, is the professor of this class. Rosenfeld also teaches "Feminist Utopias," a course that will teach future lawyers practical courtroom skills.

What impact will feminist governance have on society? What is more effective, reforming the current system or imagining – and building – an alternate one? Students will be able to create their own utopian ideas for a society with equal rights for men and women.

This description illustrates something Hans and I have repeatedly

found in this series, namely that law is no longer taught at these schools in an effective way. Harvard and Yale are producing lawyers that don't understand how to be attorneys.

Recently, I asked a student from an elite school whether they understood the difference between a past memory recorded and a present memory refreshed. Most people are unaware of this, but lawyers use these rules to win or lose cases. Graduates of law schools such as the University of South Carolina or West Virginia University will be able to tell the difference. The student at the elite school had never heard of this topic.

This is the issue with elite law schools. It's no longer about graduating attorneys with basic skills that can help clients. They are intentionally graduating bad attorneys who are capable of fundamentally transforming the country towards progressive policies.

Why do they have such a strong brand? Another day, another question. The Harvard course catalog proves my point.

Take "Reforming the American Constitution" a course taught – to my mind – by Sanford Levinson, a true insurrectionist. You can call him the domestic enemy of Constitution. His works attack both the essence of the Constitution and its functional provisions such as the "undemocratic veto" power of the president. The course description is:

In 2006 I wrote a book called Our Undemocratic Constitution that focused on structural features that were not able to be justified by any 21st-century theory of democracy.... I served as the chair of a group that was brought together in 2020-21 under the auspices the journal Democracy to draft a new Constitution for the United States.

These people exist and teach Harvard Law students.

There are classes where Harvard Law students can relax if things get too intense. The course: "Thinking Like Yourself: Law, Poetry, and Social Justice." Berets are optional. The course:

The course will use poetry to explore and explode our understanding of fundamental concepts such as equity and governance. We'll also look at substantive areas, like criminal justice, emerging technologies, and how we see ourselves as advocates and lawyers.

This is not The Babylon Bee. This is the real deal.

If Harvard Law Students grow tired of reading poetry by a convicted carjacker for the "Thinking Like Yourself," class, they could move to Virginia Woolf's "Individuality?" and take that course. Virginia Woolf and Social Justice and Law.

Woolf's Mrs. Dalloway, and To The Lighthouse were both published nearly a century before. Each meeting will cover approximately 70 pages. In both novels, Woolf gives a magnificent portrayal of the female protagonists as well as a multitude supporting actors. Both novels are dominated by male dominance, war, and social class. What can we say about this, as lawyers who are used to thinking of large groups and forces in our day and age? Can individuality as a value or experience survive?

There is also a course that is worth one credit called, "What should we believe?" It is taught by Professor Deborah Hellman. According to her Harvard faculty page:

Hellman's writings are divided into two major strands. The first is a focus on equal protection and its philosophical basis. She is the coauthor of When Is Discrimination Wrong? . . The second part of Hellman's work is devoted to the relationship between money, legal rights and campaign finance laws. It also includes articles about bribery, corruption and bribery law. Hellman challenges and explores the normative justification for current doctrine in this work. Her article, "A Theory of Bribery", won the 2019 Fred Berger Memorial Prize for Philosophy of Law from the American Philosophical Association.

Harvard Law School teaches "Art of Social Change."

This course examines different strategies for systemic reform of law and policy, with a focus on education, child welfare, (abuse, neglect, foster care and adoption) and juvenile delinquency/law-enforcement.

It is not the case that the professors are teaching the law, but what they wish it would be. It's called the utopian pedagogy, which is prevalent in elite law schools. This is a system built on arrogance, selfishness and egoism. They do not want to produce lawyers who are able to help clients with actual problems. Instead, they want to produce lawyers with a theoretical foundation to overturn the law. Harvard has more examples:

The course is entitled "Theoretical Issues in Anti-Discrimination Law" and instead of focusing solely on what the law actually is, you will be given credit for what it should be. This seminar will examine anti-discrimination laws from a philosophical perspective. After considering foundational issues about the nature of discrimination and its legal regulation in general, we will turn to a variety of more specific controversies—potentially including the proper role of disparate impact in establishing discrimination." In November of 2021, the Pew Research Center issued a report citing the things that people around the world saw as good (and not so good) about America. The Center noted that the United States' global reputation has shifted dramatically over the past two decades, often improving or declining depending on who is in the White House and the foreign policies they pursue. At the same time, they said many other factors have continued to shape how people see the U.S., including its vast cultural reach, its economic model and its divisive politics. A survey of 17 advanced economies highlights the complexity of America's international image. People in other publics find much to admire about the U.S., but they see many problems as well. Americans, for their part, also see both strengths and weaknesses in their society.

The Remaking of America

It's evident that the most positive elements of America's image are tied to some of its most famous exports, with the U.S. receiving considerable praise for its technology and popular culture. When asked to compare American technological innovations with those of other developed nations, the respondents gave the home of Silicon Valley favorable reviews. Across the 16 publics polled outside of the U.S., a median of 72% say U.S. technology is the best or above average. The U.S. is, of course, also home to Hollywood, and most of those surveyed give the U.S. high marks for its entertainment, such as movies, music and television. A median of 71% think American entertainment is the best or above average.

But with the global public view as a contextual background, it is interesting to see what a world renowned American historian and conservative professor and scholar has to say about the problems now affecting America. The following recent article by Victor Davis Hanson reveals his views on the aspects of American life and culture that are now under assault. I think it's very informative and so I present it here for your own reading consideration.

D. Miyoshi

We are in the midst of one of the most radical revolutions in American history. It is as far-reaching and dangerous as the turbulent years of the 1850s and 1860s or the 1930s. Every aspect of American life and culture is under assault, including the very processes by which we govern ourselves, and the manner in which we live.

The Revolution began under the Obama administration that sought to divide Americans into oppressed and oppressors, and then substitute race for class victimization. It was empowered by the bicoastal wealth accrued from globalization, and honed during the COVID lockdown, quarantine-fed economic downturn, and the George Floyd riots and their aftermath. The Revolution was boosted by fanatic opposition to the presidency of Donald Trump. And the result is an America that is unrecognizable from what it was a mere decade ago.

Here are 10 upheavals that the Left has successfully wrought.

Free expression. In large swatches of American society—particularly the corporation, the media, the government, the public schools, and the university it is suddenly dangerous to speak freely. At a DEI workshop, politely object that "whiteness" does not account for all the challenges of "marginalized peoples," and you will become either ostracized, reprimanded, or perhaps fired.

Suggest to a class that man-made climate change and

the state remedies for it, are still under debate—and your career and livelihood are endangered. In 2020, state that Covid lockdowns would do more eventual damage than the virus—and your career was through. Express doubt that there are more than two biological sexes, and if an athlete or high school principal you will be shunned or rendered professionally inert.

The government, in league with social media, censors the news. "Liberal" universities often first require McCarthy-era type "diversity" statements for one to be hired. Commissars review syllabi to spot incorrect or improper speech or insufficient DEI zeal.

The Left now seeks to modify the First Amendment, and its empowerment of "hate speech," defined as most anything impeding the progressive project. The state and the universities properly issue word lists of approved vocabularies.

The old ACLU or Sen. Church Committee would now probably be deemed rightwing. The methodologies of Joseph McCarthy and J. Edgar Hoover are the preferred models, once they were rebooted to the right cause.

The Weaponization of Justice. Administrations and their efforts to stock the justice department with supporters come and go. But in the last decade the Left has viewed the Department of Justice as a political extension of the party—whose unchecked power must properly be directed to hurt enemies and help friends. No wonder Eric Holder described himself as Obama's "wingman" and became the first Attorney General to be held in contempt for ignoring a congressional subpoena.

Never in U.S. history have the Department of Justice and sympathetic state and local prosecutors indicted a leading opposition candidate and likely nominee of one of the two major parties, and at the beginning of a presidential campaign. Donald Trump is currently charged with nearly 100 felonies by at least two

prosecutors. He likely eventually will be hit with more than- 500 indictments, from four prosecutors, every one of the latter with a long record of either leftwing associations or Democratic service.

The mass murderer Charles Manson faced less legal exposure. No one believes Trump would have been indicted on such counts—most of them involving allegations from years past—were he not running for President.

One count that Donald Trump is not charged with is bribery, or taking money while in office, a crime cited as impeachable in the Constitution and germane to the accusations that Joe Biden and his family raked in millions from foreign governments due to the improper use of his prior Vice Presidency. For what reason did Joe Biden lie that he never discussed his son's business? Why did Hunter complain to his daughter that Joe demanded half of his own grifting income? Why would a Vice President serially call disreputable American grifters and foreign corrupt oligarchs? Can Joe's lifestyle ever be reconciled with his reported income?

Given such asymmetry in the application of the laws, conservative or even apolitical Americans are apprehensive that any political prominence will draw the attention of government in effort to either indict or bankrupt them with legal expenses.

The last four FBI Directors have either admitted they lied under oath, or preposterously under oath claimed ignorance or amnesia about events directly under their control. Or they simply stonewalled subpoenas and testimonies about alleged FBI crimes.

The former CIA Director admitted to lying twice under oath. The FBI hired social media corporations to suppress election-cycle news deemed unhelpful to the Left. The agency, along with Democratic operatives, helped hatch the election-cycle conspiracy of the 2015-2016 Russian-Collusion hoax, and the 2020 Russian disinformation laptop hoax. The FBI played a central role in many of the 2024 indictments. In

other words, the FBI along with the DOJ, has sought and when he goes out in public. to warp three presidential elections in a row.

On the prompt of a Joe Biden campaign official (and now Secretary of State) and a former interim CIA director, 50 former intelligence officials lied to the electorate that an authentic but incriminating Biden computer was a likely Russian plant-a fact known to be lie but not disclosed as such by the FBI.

The Attack on the Supreme Court. Once the Court achieved a more or less predictable conservative majority, the Left sought to diminish it in a variety of ways. It has called for packing the Court with leftist jurists to create a new 15-justice bench. Leftist law professors in the Ivy League, in neo-Confederate nullification and insurrectionary style, call for the nation to ignore Court rulings on abortion and affirmative action.

The Senate minority leader led a throng to the doors of the court, threatening justices by name: "You have released the whirlwind, and you will pay the price. You won't know what hit you if you go forward with these awful decisions."

Protestors now mob the homes of individual justices hoping to intimidate them and alter their upcoming opinions—confident that the Department of Justice will exempt them from any legal consequences of such felonious behavior.

The media routinely accuses conservative justices of improper or illegal behavior, without worry about the emptiness of the charges. A traditionalist justice now accepts that a controversial ruling can result in media charges that he is corrupt, in shrieking protestors mobbing his home, in a mob assembling at the doors of the Court, in disruptions during Court hearings, in politicians issuing threats to his person, in congressional calls to alter the century-and-a-half make-up of the Court, and in Ivy League law professors urging the country to ignore majority decisions.

In sum, a conservative jurist must be careful where

F) Trump is the first major candidate and politician who allegedly overvalued his real assets to obtain a loan that he repaid: the first to have concluded non-disclosure agreements with potential embarrassing liaisons; the first ex-president to remove sensitive files to his personal residence; and the first to phone a state official to whine about the integrity of the vote count. G) He is the first losing presidential candidate or major politician to question an election result or to seek redress through government agencies to rectify the purported corruption of the balloting.

In sum, for the first time in American history, nearly all the major communication and journalistic networks have been fused with a political party. They believe the new role of the media is to advance a shared progressive cause, oppose and even defame common opponents, and feed their audiences things that are not, and cannot possibly be, true.

The Destruction of Common Law. By defunding the police in major cities, and by showering leftwing district attorney candidates with millions of dollars in campaign funding, the Left systematically eroded the law as we know it in our major cities.

As a result, downtowns are after-dark, no-go zones, as once great metropolises resemble veritable combat theaters. Cities are becoming depopulated as consumers and businesses no longer find it safe to conduct commerce. Criminals and homeless now routinely break the law with impunity. Public violence, defecation, urination, fornication, and injection do not even rate as misdemeanors.

The Left has redefined violent crime to such an extent that shoplifting is no longer actionable. Flash mobs that take over streets and swarm to loot stores are rarely if ever arrested. Security officers who apprehend thieves or intervene to stop violence are more likely to be prosecuted than criminals themselves. There is no longer any immigration law; it has been utterly destroyed by Joe Biden. Sevenmillion illegal entrants flood into the U.S. and, along with the Mexican government, make demands on their hosts to accommodate their illegality.

In sum, in blue states and at the federal level, leftwing prosecutors and justices decide to enforce or ignore statutes, pile up or reduce indictments, increase or decrease punishments not on what the law entails, or evidence directs, but on the race, class, or ideology of the perpetrator, usually in connection with the particular status of his victims. If asymmetry in race, class, or ideology is suggested, then the law must modulate in redistributive fashion to contextualize the crime and criminal as a victim raThe Erosion of the Military. Rarely has the American people polled so little confidence in the U.S. military. It perceives the Pentagon mission largely one to greenlight social change through the rapidity of the chain of command, not necessarily to maintain deterrence, much less to win all its wars.

The Left has ensured that our armed forces are underfunded, short on munitions and weapons, and military officers are used to promote progressive social agendas. Officers expect to be promoted or stalled on the basis of their views on race and gender.

Those who traditionally died at twice their numbers in the general population in combat in Iraq and Afghanistan are ostracized and in near record numbers leaving, while their friends and relatives are no longer enlisting in the military.

Former Pentagon four-star officers violated the Code of Uniform Military Justice in attacking a sitting president with the harshest invective, invoking comparisons to Hitler and Mussolini, again predictably from a leftwing point of view.

The public expects the Joint Chiefs to be both appointed on ideological considerations, and from time to time even to free-lance to contact enemy counterparts should they feel a conservative president is dangerous to world peace.

There is no longer any social stigma or legal jeopardy for retired officers in working as defense contractor lobbyists or board members, after revolving from or soon back to the Pentagon.

Sexes. The heterosexual male and female, marriage, and the nuclear family are all to be suspect. There are three sexes or perhaps still more. English language pronouns are inadequate to reflect sexual di-

versity.

So adherence to such ossified languages is career endangering. An epidemic of childlessness, singlehood, and collapsing fertility rates are either of no national importance or illustrate the preferred nonnuclear family model. Powerful hormonal drug regimens and permanent radical sex-change surgery should be the choices of minors alone who know best when they choose to transition to another sex. Graphic sex manuals and drag queen shows with simulated sex acts can perhaps acculturate preteens to the dangers of growing up in an oppressive "normative" binary society.

Sex, but not race, is constructed, and thus a matter not of biology but of individual choice.

Race, Not Class. Racial inequality and lack of parity are due to "whiteness." Racial quotas, segregated dorms, graduations, workshops, and safe spaces are exempt from civil rights statutes given they are necessary to achieve equity. Integration and assimilation are the opiates of the masses. Apartheid and segregation are misunderstood modalities, and thus, if enlightened, sometimes necessary corrective measures.

Reparations are to supersede ineffective affirmative action. Wokeness liberates us to see how race explains everything in America, past and present. At universities and in popular culture "proportional representation" of various ethnicities and races is no longer sufficient remedy.

Instead reparatory hiring and admissions are required to atone for prior generations of discrimination. It is taboo to suggest that cultural conditions not just race accounts for inequality. Everything from meritocracy to promptness to physical fitness is racist in nature, requiring DEI experts to expose and inform about the systemic nature of American racism.

Debt is a Construct. Modern monetary theory proved that annual deficits and national debt are just

a state accounting challenge. So printing more money is an act that properly diminishes the value of existing capital improperly horded by parasitic profiteers. Spreading the ensuing cash wealth to the more deserving and victimized is long overdue social justice.

At any time, the national "debt" can be deconstructed by renouncing usurious bond obligations, appropriating private retirement accounts, or further inflating the currency—if governments are committed enough to social justice.

Universities. It is now heresy that universities should be places of disinterested inquiry and inductive investigation. They can properly instead become a valuable tool in ridding society of racist and sexist forces, platitudes about free speech and equality under the law, and the tyranny of private property, capitalist profiteering, and white, male heterosexual Christian oppression.

So the role of a university is to create a brief safe space in which graduates can leave with proper training about the terrible history of the United States and the ways in which it must be dismantled and then be rebuilt by the properly trained experts from the ground up. Counterrevolutionaries or deluded liberals and their quaint adherence to a racist and archaic Bill of Rights have no place on these islands of progressive resistance.

None of the above was true at the millennium; all are now—with more still to come.




