HURRICANE HELENE

Tallahassee, the state capital, was expecting devastation, but Perry, to the southeast, took the hit.


US Ability to Control the Weather and Lithium


We have had the technology to create, control and steer hurricanes for decades.



Project Cirrus is the first official attempt to modify a hurricane.



It was run by General Electric with the support of the US military. The official theory was that by changing the temperature outside the eyewall of a hurricane, which they did by seeding the clouds with various compounds such as silver iodide, a decrease in strong winds will result. On October 13th, 1947 Project Cirrus targeted a hurricane, heading out to sea. Approximately 180 lbs of dry ice was dropped into the clouds. The crew then reported a pronounced modification of the cloud deck and the hurricane abruptly changed direction and made landfall near Savannah, GA.

The public blamed the government. Irving Langmuir, who pioneered General Electric's Atmospheric Research Department and admitted that the project was about learning how to weaponize the weather also claimed the reversal of the hurricane had been caused by Project Cirrus.




But the government denied it for 12 years. After a short delay, the project officially continued and in 1965 Project Stormfury had targeted Hurricane Betsy for seeding.



On that day, the storm immediately changed direction and made landfall in southern Florida. Congress blamed it on Project Storm Fury, but the government claimed that the hurricane shifted before they ever had a chance to seed it. And, after two months of congressional hearings, the project was allowed to continue.

In 1997, US Defense Secretary William Cohen admitted we have the technology to control the weather, including earthquakes and volcanoes.




The US government had placed gag orders on employees of the National Weather Service. In October of 2012, after Hurricane Sandy weakened to a tropical storm, microwave imagery shows a thick red beam immediately followed by Sandy growing into a category one hurricane and taking an unexplained left turn into New Jersey.

Kings Mountain is believed to have one of the largest resources in the world. But the biggest problem is that people live there and they don't want their quiet towns turned into lithium mines.






A Land Grab

This flooding in North Carolina does not sit well with me. I think something's going on, so I decided to do some digging.




So the first thing I find out is North Carolina has the richest deposits of lithium in the entire world.

In 1953, the President of the United States launched the Advisory Committee on weather control. 
By the way, very specific areas. It's possible that we are seeing modern day weather warfare.

Weather announcer: All right, let's take a look at Florida and already it's looking like a disco party is going on. A lot of different radar activity going on.






A method of seeding the stratosphere with particles that can help reflect the sun's heat, and much the same way that volcanic eruptions do. An SAI program could limit global temperature increases, reducing some risks associated with higher temperatures and providing the world economy additional time to transition from fossil fuels. This process is also relatively inexpensive. The National Research Research Council estimates that a fully deployed SAI program would cost about \$10 billion yearly.

The Voting Issue

Election officials in Georgia, North Carolina, Florida work to secure early voting amid Hurricane Helene fallout

Election officials in Georgia, North Carolina, Florida work right now amid hurricane Helene fallout to ensure voters can still securely cast early ballots despite the devastating storm impacts of Hurricane Helene that have in some cases left them without power, water and cell service.

Potential solutions in the affecting counties of the three states which could determine the White House could include extra polling places, extended early voting and making it easier to drop off mail ballots. We have no power, we have no water, Cell service is limited, so right now the concern is a delay in getting the absentee ballots mailed out. A delay in receiving the mail. The executive director of Augusta Richmond County Board of Elections in Georgia told CNN's Don said some of the counties 43 polling locations could be unable to be used. And that's just putting it conservatively. Just in Georgia, not to mention the dozens upon dozens in North Carolina which are unusable and have been destroyed. Where are these people going to vote? 1. The Department of Defense (DoD) is the largest employer in the U.S. There are more than 1.4 million active-duty personnel, 1.1 million National Guard and Reserve personnel and 700,000 civilians working for the DoD.
2. Thirty-One of the 44 presidents have served in the military. President Teddy Roosevelt earned the Medal of Honor, the highest honor in the military. The only enlisted President who didn't become an officer was James Buchanan.
3. The U.S. Military is one of the largest providers of international aid and disaster relief. Ships called Marine Expeditionary Units patrol the oceans watching for signs of danger and can reach the shoreline of nearly any location on Earth within 48 hours.
4. The DoD owns nearly 30 million acres of land worldwide. In the U.S., it is the single largest consumer of energy.
5. Only 28 percent of Americans ages 17-23 are eligible for military service. Nearly 1.4 million Americans, or .4 percent of the U.S. population, are active military personnel.
6. Military members are more highly educated than the general population. Those who enlist are required to have a high school diploma or a GED. That means that 99 percent of the military has a high school education. On the other hand, only 60 percent of the general population has a high school education.
7. The Lewis and Clark Expedition that mapped out the west would not have happened without the U.S. Army. We may remember them only as explorers, but the members of the expedition were actually a small Army unit.
8. The U.S. military began to desegregate long before civilian institutions. Schools and other public institutions were ordered to desegregate in 1954, but many lagged behind into the 1980s. The Army, on the other hand, had the first desegregated troops during WWI.
9. The first time women were allowed to enlist in a non-nursing role was during WWI. The first women in the military worked in clerical roles and as Signal Corps operators. This allowed more men to take on combat roles.
10. In 1948, President Harry Truman signed an anti-discrimination bill. This attempted to put an end to racial discrimination in the military, but also discrimination against women joining the military. This bill allowed women to enlist in times of peace, rather than just war time.

Gadzooks! A Brief History of Curse Words



Well, shoot: Curse words have been through a lot of doggone stages to get to where they are today. Mark Twain once said that “under certain circumstances, profanity provides a relief denied even to prayer,” and people have been swearing as long as they’ve been praying. What is considered “cursing” or “swearing” has always depended on what was taboo at that point in time, whether it be blasphemous or simply crude. These off-limits words and topics have shifted over time, too. Here’s a brief look at the history of cursing, from A to Z... or “arse” to “zounds!”

The Original Curse

Why do we call forbidden terms “curse” or “swear” words? It’s likely the English terms evolved from the Bible, where “swearing” was sometimes used to refer to false promises or lies, such as when someone claims to do something that is not possible. These were considered vain oaths, and this “swearing” would sometimes be made in God’s name. Some of the earliest expletives were phrases referencing religion, such as “by God’s bones,” “God’s nails,” or really anything to do with God that wasn’t a literal and sincere oath.





A History of Curse Words

Frequently, curse words originated from the combination of two or more taboo words pushed together in a way that obscured the literal meaning, creating a new slang term in the process. For instance, “gadzooks” was a curse used in place of “God’s hooks,” and by the 1600s, the word “zounds” — a shortening of “God’s wounds” — appeared in William Shakespeare’s *Othello* and *King John*. In the 19th century, people in Ireland used “bejabbers” as a way to get around saying “by Jesus.”

The Rise of the Four-Letter Word

The phrase “four-letter word” was first used as a euphemism for swear words in the 1920s, and for good reason: Of the approximately 84 commonly used American English swear words, 29 of them have four letters, including some of the most popular. “Damn,” for instance, appeared as a verb as early as the 13th century, meaning “to condemn,” and was used as an exclamation starting in the 17th century.

The “F-word,” meanwhile, was preceded by a different four-letter word in the 10th century: “sard,” which described the same intimate act. The common myth that today’s F-word derived from an acronym, either “fornication under consent of the king” or “for unlawful carnal knowledge,” is untrue. Instead, the expletive may come from the Middle Dutch “fokken,” Norwegian “fukka,” or Swedish “focka,” all of which mean several things, including “to copulate.” Another theory supported by the *Dictionary of Slang and Unconventional English* and *The Roots of English: A Reader’s Handbook of Word Origin* tracks the word back to the Indo-European term “peuk,” meaning “to prick.” According to the *Oxford English Dictionary*, the first recorded use of the modern F-bomb was in 1503, in a Scottish poem, though the word was likely used even earlier. In 1965, the F-word became an official part of the English lexicon when it was included in *The Penguin Dictionary*.



Sh*t

The four-letter word beginning with “sh” has had several meanings through the years. According to the *Old English Dictionary*, it was used to mean “an obnoxious person” starting in 1508, although the early version of the word wasn’t four letters; it began as the Old English curse “scite.” In Latin, “scite” means a very different thing: shrewdly, cleverly, or skillfully. By 1934, when it was used in Henry Miller’s novel *Tropic of Cancer*, the modern, four-letter version of the word had evolved to essentially mean “stuff,” regardless of quality.

Swearing Goes to Hollywood

By the 20th century, the explosion of mass media brought curse words to the mainstream. Filmmakers even had to fight to get the now-classic line “Frankly, my dear, I don’t give a damn” into *Gone With the Wind*. Producer David O. Selznick told regulators, “This word as used in the picture is not an oath or a curse. The worst that could be said of it is that it’s a vulgarism.”





Can They Control Earthquakes as Well?

Comedian Lenny Bruce was arrested multiple times in the 1960s for “obsenity” for using explicit language, and in 1972, George Carlin was arrested for performing his “Seven Dirty Words You Can’t Say on Television” act, even though he wasn’t on television at the time (he was performing at Summerfest in Milwaukee, Wisconsin). A year later, Carlin’s routine was played on the radio, which led to a series of court cases about what language should be banned from broadcast radio and TV. In 1999, the CBS series Chicago Hope brought the first scripted curse word to network TV when actor Mark Harmon said “sh** happens.” (Prior to this, swearing on TV was limited to cable television.) Today, the film industry’s Classification and Rating Administration decides just how many of those naughty words it takes to add up to an R-rating.

So I had a chance to speak with Eric, but we specifically talked about the weather modification tools. And so here I want to play a little bit of this interview for you with Eric Hecker.

Transcript of previous Redacted interview of Eric Hecker: Let's talk about the weather piece of this. So we're seeing the weather manipulation, we've covered this extensively here on the show. The NEXRAD radar systems that have been used into to direct and move these storms in a path of destruction.



The control of these storms is unbelievable. And I think most Americans were kind of silent and didn't realize that this was actually happening. I think the cat is out of the bag on all of this now. I'm curious what the South Pole station does, is and when you worked there, how it actually is able to be used as an earthquake generating machine. What else it's doing there and maybe how this is tied to the current weather events and all of the things that we're seeing right now across the United States. Can you give our audience more of an overview of that?

Hecker: Absolutely the South Pole station has a system known as the Ice Cube neutrino detector.



It is currently the world's largest phased array transmitter. This is basically Nicolai Tesla technology. I'm sure a lot of the audience is familiar with systems like the High Frequency Active Auroral Research Program (HAARP) which is effectively built on the surface of the Earth and it has a 2D situation, it has length and width as far as the phased array goes. The South Pole station differs in this so far as it also goes down deep into the ice, giving it a third dimension,

length, width and height. So it has exponential more I guess you would say capabilities targeting the discharge of power. It's like HAARP on steroids basically. So yes, it generated the earthquakes that occurred in Christchurch, New Zealand in February of 2011.

Redacted: When you and I chat on the phone a few weeks ago, you mentioned, I don't know if you can say this now or if I'm speaking out of telling tales out of school here, but you were peaking to a source that you worked with at the South Pole station since you left there who said the technology has gotten so advanced now with these generation of earthquakes that it's like an autopilot system in an aircraft. I think you described it that it's so advanced now, it would blow your mind at how targeted these earthquakes are that they can use from this South Pole station.

Hecker: Yeah, yeah, basically the trick of it all one of one of the things that I learned when I went to this event in Alamosa, Colorado, I spoke to the gentleman by the name of Doctor Simeon Hine. And he was doing a presentation on ball lightning. And one of the things that he discussed was how there are reports when earthquakes occur that all lightning, I guess you'd say is ejected, manufactured by the earthquake. So I engaged him in a dialogue and I said, well, doc, you know, wouldn't there be some sort of symmetry there that if an earthquake can discharge ball lightning, wouldn't we be able to deliver ball lightning to generate an earthquake and he agreed that it's just simply the matter of being able to deliver said energy, which for all practical purposes think of it having an explosive capacity to it. So if you can wirelessly transmit energy from a power supply somewhere on Earth, deliver it to another location, the end result is quite simply an earthquake. Wireless transmission of energy is something that Nikola Tesla has brought up, you know, what 100 some odd years ago now. So this is the state of the Union, is that Nikola Tesla discovered this stuff. The powers that be absconded his information, they cordoned it off away from the mass population and have been monopolizing the use of these types of technologies for many decades now. We the people are suffering under this monopoly of technology by our oppressor. It's literally just that simple and that would be the motive for them to have agents, for lack of a better term, flooding the disclosure community with BS to muddy the waters and confuse us, we the people, so that we can continue to be wholly oppressed and well managed.

Redacted: When you were at the South Pole station, you witnessed this ice cube neutrino machine in action. So it goes deep and it's much larger than HAARP. And I guess just walk us through what they would be using this for, how would they have been manipulating the weather. How would they be manipulating and targeting earthquakes around the world? Why would they be doing this and who is in control of the South Pole station at this point? Is the United States government you were a contractor with Raytheon when you were there? Is it a private enterprise who is controlling it?

Hecker: Great questions. First and foremost, one of the things that the former crew members had emphasized to me to try to get people to understand as I'm trying to get this information out there is that you, you have to understand, it's just very easy now to deliver that energy anywhere on the planet. It's not challenging.

Redacted: Like they can pick a spot in Iran and they can just put it in, dial it in on the computer and launch an earthquake?

Hecker: Yeah. Deliver the energy that instigates it. The term that people should become familiar with is earthquake induction or earthquake inducing. So similar to like when you go on the Internet and you Google chemtrails right, you are going to get a whole lot of baloney that says chemtrails are garbage blah, blah, blah. But if you Google the term stratospheric aerosol injection, you'll start to find all of the science of what's really going on when they crisscross our skies. So if you look up inducing earthquakes or earthquake induction, you will become privy to a sea of information and science that supports the existence of this technology. It's just that available. People just need to start paying attention to what's going on in the world around them and this disparity in technology.

As far as who's running this facility, I'm not 100% sure. This was part of that conversation that I had in Washington, DC is because it seems like these, you know, these unacknowledged special access programs USAP, which anybody who's paying close attention USAP is the actual title of the Antarctic program. It's the United States Antarctic program USAP. It is a USAP program by definition. So they are being very deceptive as to what the secondary and tertiary capacities are for this massive phase array system, and they're just pumping it out to the general population as if it's operating under the auspices of science. Of course, things like that have to be secreted away. They're not going to be running around saying we have the world's largest directed energy weapons system at the South Pole station in Antarctica, because first and foremost, it would breach the Antarctic Treaties and people would say, ah, well, they would never do that. Of course, a lot of discussion about HAARP and how all of this plays into it, if you talked about the South Pole station, the ice cube neutrino machine basically being HAARP on steroids, how would it or likely be used with Hurricane Milton, Hurricane Helene in the United States?

Hecker: I believe it would just be simple delivery of energy. It is that simple. These systems themselves, we're just observing Mother Nature and the flow of her energies. We call it a storm, we call it a hurricane. It's just a matter of practice through the application and delivery from systems like this that have copious amounts of power available to deliver. It's just a matter of playing around and learning the targeting and reaction. Musk admitted to Tucker that he personally knew many of these folks, which isn’t too surprising since he worked in Silicon Valley.

On its website, Blackstone proudly describes itself as the world's largest alternative asset manager with more than \$1 trillion in assets under management and it in its portfolio it owns 12,500 real estate assets, which is actually a conservative estimate. Blackstone owns and manages over 300,000 units of rental housing in the US making it the largest landlord in the country. The British newspaper *The Guardian* noted that Blackstone is the largest commercial landlord in history. In the past two decades, the Wall Street firm has quietly taken control of entire apartment blocks, care homes, student housing, railway arches, film studios, offices, hotels, logistics, warehouses, and data centers. And as the *Guardian* wrote, Blackstone doesn't just own real estate it owns everything, including Donald

Trump, because when these Wall Street firms fund politicians they are investing in the politician like they invest in real estate or stocks or bonds. They know that if they fund the campaign of a politician, that politician will give them favors when they enter office. This is essentially legalized bribery, but in the US, it's entirely commonplace among candidates from both major political parties.

And let's be clear Joe Biden is also funded by Wall Street. They're both funded and owned by Wall Street. In fact, the irony is that while Donald Trump's campaign is being funded by the CEO of Blackstone, many of the top economic and financial officials in the Biden Administration are from Black Rock.



So here we can see that these two competing Wall Street terms are each closely allied with the major political parties. Blackstone and its billionaire founder and CEO, Stephen Schwarzman, are some of the top contributors to the Republican Party funding Donald Trump and his allies, whereas Black Rock is more closely affiliated with the Democrats and Joe Biden.

Now, for people who might be confused, what is the difference between Blackstone and Black Rock? Their names are similar, but they're not the same firm. However, they both are investment management companies based in New York City. While Blackstone concentrates its wealth in real estate (like Donald Trump), BlackRock is a more traditional asset manager.



What BlackRock does is it manages the assets of the rich around the world and of institutional investors like for instance, pension funds and sovereign wealth funds. So essentially, if you are very, very wealthy, what do you do with all of your money? Well, you invest that in assets to increase your wealth. But who does that? Many of these oligarchs, these rich capitalists, are so wealthy that they invest their wealth in investment funds. And they're overseen by asset management firms and they hire entire teams of people to invest the money of the rich in assets that bring yields, so they can get wealthier and wealthier. Black Rock is the world's largest investment company, but its investments tend to be more traditional things like stocks which is partial ownership in a company or bonds, which is a form of debt like government bonds or corporate bonds which are IOU's from those institutions. So Black Rock tends to invest the wealth of the rich around the world in different institutional investors in those assets to make them wealthier. Blackstone is very similar. However, Blackstone is the world's largest alternative investment company, which means that it tends to invest the money of the rich in assets that are not stocks and bonds, things like real estate and veterinary offices and doctors offices and retirement homes and hospitals. So, Blackstone has become the world's largest landlord, and Blackstone also runs one of the world's largest private equity funds.

A poll from this past January found that the wealthiest 10% of Americans own 93% of stocks.

The wealthiest 10% of Americans own 93% of stocks even with market participation at a record high



And the poll noted that this is the highest level ever recorded. And meanwhile, the bottom 50% of Americans hold just 1% of stocks.

The Federal Reserve Bank of Saint Louis published similar data looking at US wealth inequality this May. And keep in mind that these are conservative statistics. They noted the top 10% of US households hold 67% of total wealth, 2/3 of wealth held by the top 10% of households. Meanwhile, the poorest 50% of households, the poorest half of the country, hold 2.5% of total household wealth.

Eric Ross Weinstein is an American investor and financial executive. From 2013 to 2022, he was a managing director for the American venture capital firm Thiel Capital. Weinstein coined the term "intellectual dark web" and has proposed a theory of everything called "Geometric Unity" that has largely been met with skepticism in the scientific community. Weinstein received a Ph.D. in mathematical physics from Harvard University in 1992 under the supervision of Raoul Bott.

Weinstein

Williamson: When we spoke at the start of the year. I said it was way too close to November to switch anybody out. Turns out that was wrong.

Weinstein: Beginner's luck.

Williamson: You said. What are the odds that Joe Biden has a debilitating event between now and November, including death. So he runs a one in 20 chance of dying in any given year or above that I don't think you know whether he's even going to make it to November. Debilitating event could have been a debilitating public event.

Weinstein: I purposely left it vague and I didn't say the other part of it which I now feel comfortable saying, which is, I don't know whether Donald Trump will be allowed to become president.

Williamson: What do you mean by that?

Weinstein: I think that there's a remarkable story and we're in a funny game which is are we allowed to say what that story is because to say it, to analyze it, to name it, is to bring it into view. I think we don't understand why the censorship is behaving the way it is. We don't understand why it's in the shadows. We don't understand why our news is acting in a bizarre fashion. So let's just set the stage, given that that was in February. There is something that I think Mike Benz has just referred to as the “rules-based international order.” It's an interlocking series of agreements, tacit understandings, explicit understandings, clandestine understandings about how the most important structures keep the world free of war and keep markets open. And there has been a system in place whether understood explicitly or behind the scenes, or implicitly. It says that the purpose of the two American parties is to prune the field of populist candidates so that whatever two candidates exist in a face-off are both acceptable to that world order. So, what you're trying to do from the point of view of let's say the State Department, the intelligence community, the Defense Department and major corporations that have to do with international issues, from arms trade to food,

they have a series of agreements that are fragile and could be overturned if a president entered the Oval Office who didn't agree with them and the mood of the country was why do we pay taxes into these structures? Why are we hamstrung? Why aren't we a free people? So, what the two parties would do is they would run primaries. You have populist candidates, and you'd pre-commit the populist candidates to support the candidates who won the primaries. As long as that took place and you had two candidates that were both acceptable to the international order, that is, that they aren't going to rethink NAFTA or NATO or what have you. We called that democracy and so democracy is the illusion of choice. This is called magician's choice, where the choice is not actually, you know, pick a card, any card, but somehow the magician makes sure that the card that you pick is the one that he knows. In that situation, you have magician's choice in the primaries. And then you'd have the duopoly field of two candidates, either of which was acceptable. In that case you could actually afford to hold an election and the populace would vote. And that way the international order wasn't put at risk every four years because you can't have alliances that are subject to the whim of the people in plebiscites. So, under that structure everything was going fine until 2016 and then the first candidate ever to not hold any position in the military nor position in government in the history of the Republic to be in the Oval Office. Donald Trump broke through the primary structure, so then there was a full-court press. OK, now we only have one candidate that's acceptable to the international order. Donald Trump will be under constant pressure that he's a loser, he's a wild man, he's an idiot and he's under control of the Russians. And then he was going to be, you know, a 20 to 1 underdog and then he wins. And there was no precedent for this. They learned their lesson. You cannot afford to have candidates who are not acceptable to the international order and continue to have these alliances. This is an unsolved problem. I don't have a particular dog in this fight. I want to believe in democracy. I also believe in international agreements. And it is the job of the State Department, the intelligence community and the Defense Department to bring this problem in front of the American people and say we have a problem. You don't know everything that's going on, and if you start voting in populist candidates, you're going to end up knocking out load bearing walls that you don't understand.

Williamson: But Trump was in office for four years. Did he turn the entire table upside down?

Weinstein: He risked doing that.

Williamson: Say more.

Weinstein: You remember that there was this uncomfortable accommodation given to the Central Intelligence Agency at the beginning of Trump's actual term. I have a very different point of view than most of my friends who are also, you know, at least nominally Democrats, which is it was a very immoral thing that was done to Trump. Trump was asked the question will you pre-commit that you will accept the results of an election. Now if you were going to rig the election, you would ask somebody that to begin with, and that's part of the game. And Trump says, well, you know, we'll see. So, you have this very strange thing going on where democracy is the greatest threat to democracy. Now, how can that be? It's two different concepts of democracy. One concept of democracy is the will of the people. You hold plebiscites and even if you do it with an Electoral College or political parties the idea is that the people are allowed, you know, by of and for the people. The other idea of democracy is that democracy is about institutions that sprang from democracy once upon a time, and that those institutions have to be kept strong. Those are two completely different concepts that are overloaded to the same word. Under that circumstance, we have a paradox, which is how do we keep the type A electorate from overturning the type B democracy and that's the unsolved problem that they will not bring in front of the people. So, what you have is a situation in which I believe there are many people in Washington, DC who think that Donald Trump cannot become president because he can now go for broke. He's also not going to try to run for reelection. He's relatively unconstrained. He's wealthy. He's learned how to play a lot of these games

Williamson: And maybe got a little bit of an axe to grind as well after the last six years.

Weinstein: No kidding. And he's a wild card. You

know that there are three people who are doing amazing versions of the drunken boxing game. Kanye, who's probably the first one to really fail, Elon and Donald Trump. And all three of them tried to do something where you couldn't pin them down. You couldn't figure out what they were going to do next. And that's what the order keeps trying to do like will you commit to this? will you say this? will you mouth these words? And none of these people would play the game. I find this all fascinating. You ever see Emmanuel Augustus this boxer who actually, I think Floyd Mayweather said it was his toughest opponent because he just wouldn't fight in the style that anyone could recognize. Probably the most unpredictable and yeah, the most entertaining boxer I've ever seen in my life. I mean just check out any highlight reel, you won't even believe this is real. It doesn't seem possible. So, that's what Donald Trump is. He's a guy who's got formulas that confuse people like Sam Harris. You know Sam and I have been debating this for years. I think that Trump is an incredibly intelligent man and that there's an incredible method in his tweets. You could put them into a data set and you say that there are 5 or 6 different types of tweets and then the left falls for every one of them every time. So, in this situation, you have a question. How is it that Donald Trump and RFK Jr cannot possibly reach the Oval Office and we have to have a candidate who is subscribed to perpetuating these institutions, these agreements and these orders. And there's only one out of three who has that character, and that person is not won a primary. Right now we have no idea who's running the United States of America. I just came here in a Tesla, and I did not steer once, and I would say America is in full self-driving mode, and we don't know what the AI is that's running the Oval Office. And that's really bizarre given that we have something like 6 minutes to make a decision about nuclear launches. We have no idea what the United States government in the executive branch actually is. But it can't be Joe Biden.

Williamson: Every time it seems that an election has happened over the last decade or so it's always been this one is different, this is the most important. Is there something different about the one that we're about to go into? How should we think about this election?

Weinstein: As World War 2 unraveling. The order that has produced the illusion of peace for this length of time, imagine that you were, let's say in the 2000s that you had this thing called the Great Moderation. There was a story that we had finally banished volatility from the markets. None of that was true. What you were doing was you were going farther and farther into a regime without understanding that sooner or later the Jenga tower has to collapse. The order that was put in place at the end of World War II, none of its architects are still alive. Very few pieces of information were passed down about what it actually is or how it functions because it's secret.
