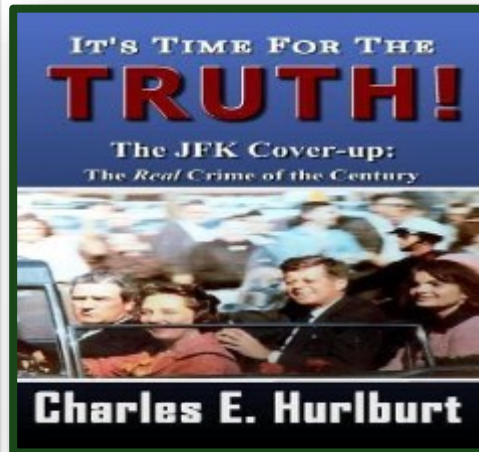

Disclosing a Cover Up



This executive order aims to shed light on three of the most consequential and contested tragedies in American history, more than half a century after they occurred.

Trump stated that the continued redaction and withholding of information from records about the assassination of President John F. Kennedy is not consistent with the public interest, and the release of these records is long overdue. The executive order mandates the full release of all remaining classified records related to the assassinations. 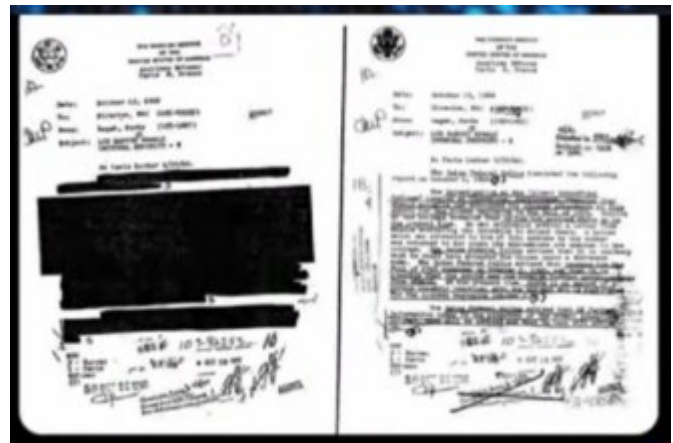
But what will be the ultimate consequences of these disclosures?

Interestingly, just prior to Trump’s signing the executive order, a video recording suddenly emerged in which Clifton C. Carter,



Franchi says the disclosures will cause panic in specific sectors of the government intelligence agencies, including the CIA and FBI.

During President Trump’s first term, Mike Pompeo, head of the CIA and later Secretary of State under Trump, begged Trump not to release the files. Trump did not release the files.

However, immediately into his second term as president, Trump signed an executive order releasing the JFK files and promptly revoked Pompeo’s Secret Service protection. Ostensibly, there is bad blood between them.

In the times that we've had in Texas and the embarrassment that Lyndon has gotten from Kennedy, I guess it wasn't anything else to do but what he did.”

Franchi points out that Roger Stone has a book out that implicates LBJ in the assassination.

Franchi also points out that in the famous photo of LBJ being sworn in as president aboard Air Force One



the man in the background in the bow tie (in another photo taken at the same time), is seen giving a wink to LBJ like in a sign saying “well done, you are the man now”

Perhaps no other president in American history has ever provided as much transparency as Trump. Remember Barak Obama saying he would make transparency the hallmark of his administration? Well, he was as “Deep State” as you can get.

In the coming days, weeks, and months, we will see what effects the assassination disclosures will have on and against the American people and the government.

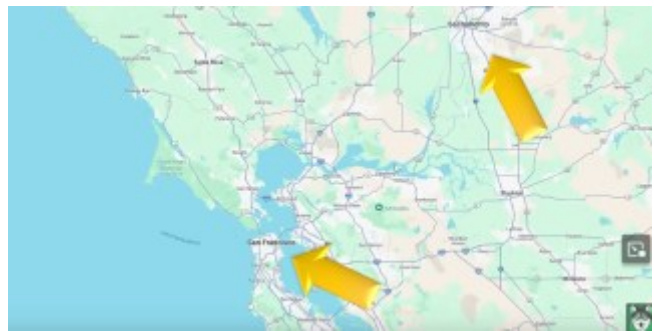
Did you know that the state of California pumps water directly into the Pacific Ocean? This is not covered by the regular news.

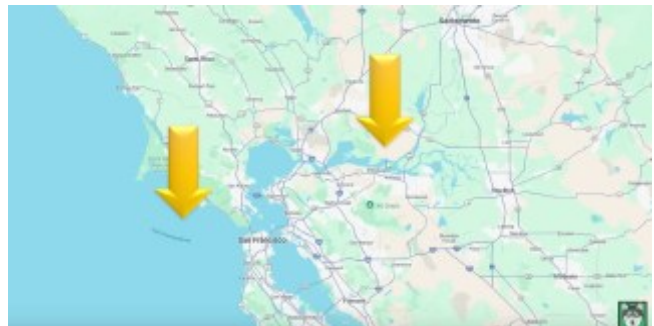


Putting more water into the ecosystem is going to be better for this fish. But this is at the expense of the people of California.

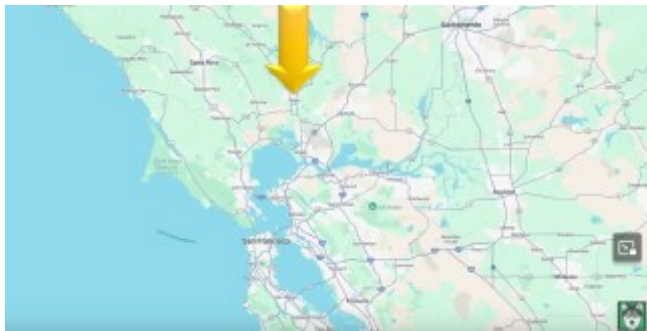
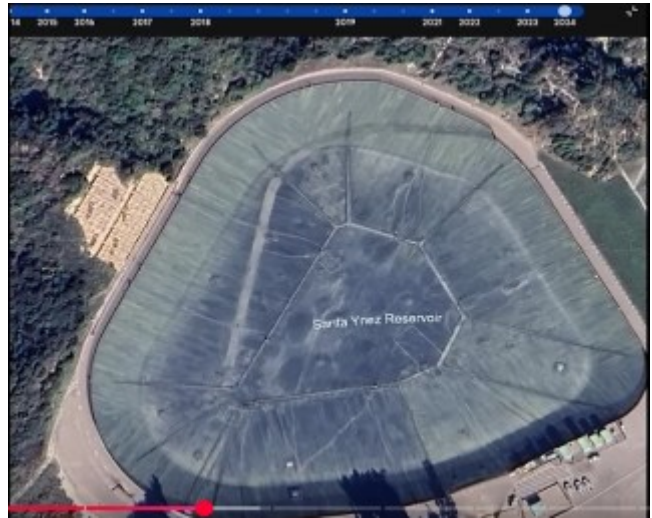

Newsom has never run out of water at this winery.

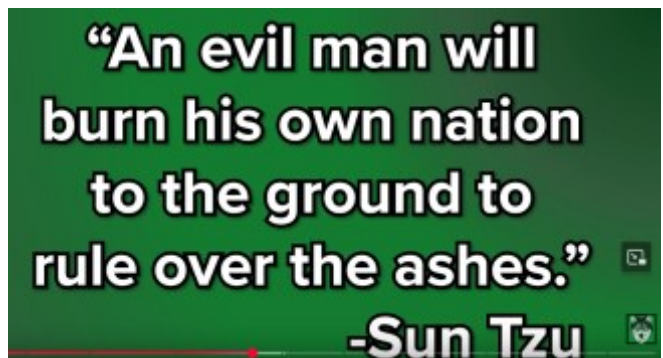


But the Santa Ynez reservoir in Los Angeles has run out of water and is empty.

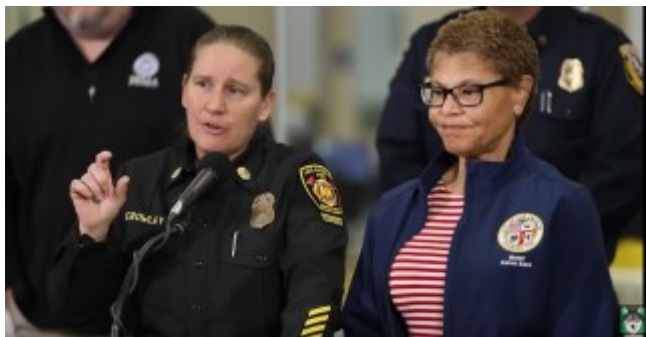

All they have to do is get rid of people's private property.



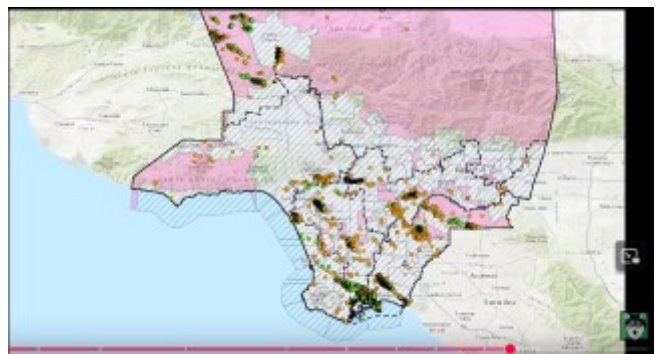
I think you are being naïve.

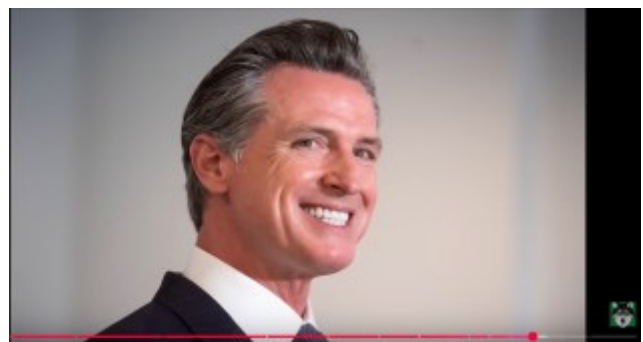
So here is the question. How did these insurance companies know that a fire was going to start but these politicians somehow did not know there was going to be a fire?

I wonder who he is talking with about rebuilding the city. He is talking with his rich buddies about the Smart LA 2028 Plan.

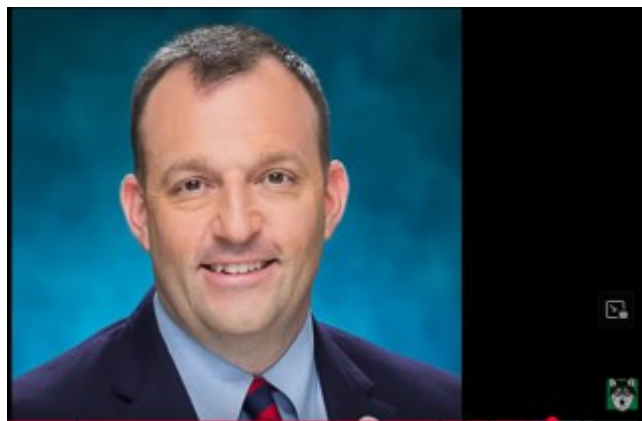

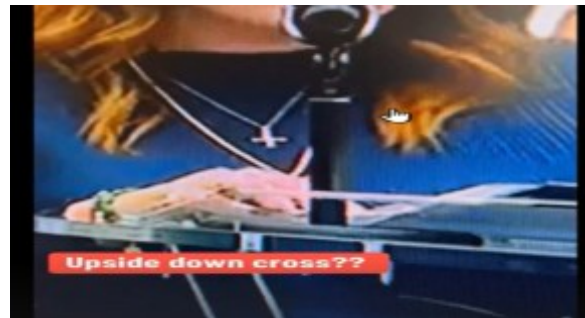

After the fires destroyed Lahaina, many blue-colored objects were observed to have not burned even though everything else around them was burned.

"We have seen that among the ashy ruins, there are blue-colored objects that have somehow survived the devastation: blue cars, blue umbrellas, a blue boat, blue planters," Reese says.

"Videos online are going viral that show how lasers can easily burn through certain-colored objects, but objects that are colored blue remain unharmed."

Directed Energy Weapons (DEWs) include not only lasers but also millimeter waves and microwaves, both of which are used in the naked body scanners at American airports.

"They are all based on light frequencies, and different wavelengths of light affect colors differently," Reese says. "For example, in laser tattoo removal, different wavelengths are used for removing different colors. And this is because color is a quality of light. Each color has its own frequency."

The color blue, which was unharmed in the Maui fires, has a frequency of 6.66

A Bumpy Road Ahead to Trump 2.0

The Good, the Bad and the Ugly

The Good

Trump will pursue a twenty-first-century version of what was originally known as the American System. This system relied on the following policies:

1. High tariffs to support manufacturing and high-paying jobs
2. Infrastructure investment (public and private) to support productivity
3. A strong army and navy to protect the U.S. but not to fight foreign wars

4. A central bank with limited powers to provide liquidity to commerce

To the extent there was government spending, it was for productive projects such as canal and road building and later to support railroads. To the extent that early central banks existed, they were for secure lending to sound entities (including the U.S. government) and not for purposes such as printing money, fixing interest rates or “stimulus.”

The entire system could be summarized as sound money, smart investment and a strong military in the service of high-paying American jobs.

The American System prevailed from 1790 to 1962 with occasional periods of agrarian ascendancy and some disruptions such as the Civil War. Beginning after World War I, the neo-liberal movement of Austrian economists and libertarians began to promote globalist policies of open borders, open capital accounts and free trade.

Of course, free trade is a myth because of subsidies and non-tariff barriers. Comparative advantage is obsolete because the factors of production are highly mobile. Taiwan had no comparative advantage in semiconductors in 1979, but today they dominate global production. They made that happen through a Taiwanese version of the American System.

In contrast, the neo-liberals were living an ideological fantasy in which globalism was to displace sovereignty. At a minimum, their goal was encasement of sovereigns in a larger orb of multilateral institutions such as the IMF, World Bank, WTO and the United Nations.

Beginning with the Trade Expansion Act of 1962, the Trade Act of 1974 and successive rounds under the General Agreement on Tariffs and Trade (today the WTO), the U.S. embraced the neo-liberal consensus including drastic tariff cuts. As jobs moved offshore to take advantage of cheap labor, capital followed as direct foreign investment.

The result was the hollowing-out of U.S. manufacturing, wage stagnation, slower growth, greater debt and a succession of failed wars. The open border policy of Biden-Harris is consistent with neo-liberal views on the end of sovereignty but is a death-knell for American jobs and social cohesion.

Trump and his economic team will return the United States to the pre-1962 glory days with the revival of the American System. Foreign companies will be free to sell goods to Americans but only if they are manufactured in the U.S.

This will lead to a wave on inbound investment in the U.S., a reduction in U.S. trade deficits, a stronger dollar (as the world demands dollars to invest here), and higher wages for U.S. workers. Higher wages will raise real incomes, stimulate consumption, decrease income inequality and expand the tax base to help reduce deficits without raising tax rates.

It's a win for American manufacturing and a win for the American people.

The Bad

But before we get there, expect a tough economic (and market) environment in the beginning of Trump's term. Administrations matter, personnel matters, policy matters, but there's something bigger than

Trump in the White House. It's called the economy. The economy goes its own way. Business cycles have not been erased. The transition from Biden to Trump will bring economic pain as Trump inherits Joe Biden's mess.

There are ample signs that the economy is headed for a recession (or may already be in one) including higher unemployment, lower interest rates (low rates are not "stimulus;" they are associated with recessions and depressions), flattening yield curves, negative swap spreads, collateral shortages in Eurodollar markets, reductions in China's reserve positions (not a sign of "dumping" Treasuries but a sign of a dollar shortage and a need to provide liquidity to banks), declining oil prices (despite output reductions), and others.

The emerging recession will cause a stock market drawdown as earnings are revised downward, consumer confidence crumbles, consumer discretionary spending hits a wall and precautionary savings rise. The world will not bail-out the U.S. economy because China, Japan, Germany and the UK are all slowing economically at the same time or already in contraction.

The U.S. economy (in contrast to economists) does not pay that much attention to elections or new administrations. It's too big and moves to its own complex tempo. Investors may cheer the Trump policies and his reelection, but it will be a very bumpy ride in the first year of Trump 2.0.

The Ugly

Don't underestimate "The Resistance". Because it's out there and can do a lot of damage in a couple of months before Inauguration Day. And it has. Biden and company have been trying to Trump-proof the presidency by signing contracts. Let me explain.

Remember the famous Inflation Reduction Act? Despite its name, the act actually increased inflation by being the Green New Scam in disguise. There was about \$850 billion for garbage like windmills, solar modules, and green initiatives. A lot of the money went to the Democrat's favorite contractors and electric vehicle makers. That passed in August of 2022, but guess what?

Most of the money hasn't been spent yet.

So, now there is a mad scramble to sign contracts. You actually can't spend the money that fast, but you can sign a contract with a five-year life or three-year life saying you'll spend it over three years. And the idea is signing the contract now so that even when Trump becomes president, even though the money hasn't been spent, it has been appropriated and it's contractually bound.

And that's the key. Bind the spending in contractual form so Trump can't do anything about it. There's a lot of wasteful government spending that's in the pipeline. The Democrats are also going to try to tie up as much federal land as they can to take it out of circulation to stall oil and natural gas production as well as mining.

The Resistance will try to get as much money to Ukraine as they can. They will try to appoint as many judges as they can. The Republicans can gum up the works a little bit, but the Resistance can continue to cause havoc after Trump takes office. It won't be a pretty picture for markets with so many companies impacted by their actions on top of a recession.

Bottom Line

After taking office, Trump's agenda will incentivize billions of dollars of investments in U.S. energy and manufacturing jobs. He will make domestic oil drilling and refining a top priority which will provide America with energy independence. This will also benefit companies (and provide more jobs) in the energy sector.

But there will be plenty of minefields for markets to deal with in the first year as the transition takes place.

It's a good start to 2025 — just quietly, the money is exiting the Monster Banker Climate Cartel. Citigroup leaves climate coalition

Citigroup Inc and Bank of America Corp said they are leaving a global climate-banking group, becoming the latest Wall Street

lenders to exit the coalition in the past month.

In a statement, Citigroup said while it remains committed to achieving net zero emissions, it is exiting the Net-Zero Banking Alliance (NZBA). Bank of America said separately on Tuesday that it is also leaving NZBA, adding that it would continue to work with clients on reducing greenhouse gas emissions. The bankers just want to save the world — and sell green bonds...

Citigroup has been the world's No. 4 underwriter of green bonds since the start of the decade, trailing BNP Paribas SA, JPMorgan Chase & Co and Credit Agricole SA, according to data compiled by Bloomberg. Bank of America ranks eighth.

As I've explained — these banker bullies can force first world economies to pick up Net Zero policies, even when their voters don't want it, but their power hinges on a bluff made with other people's money which the US Republican's have called them on. The Bank of NZ is also a fully fledged member. For Canadians, like Australians, seemingly every bank is a Bank of the UN — the CIBC, the BMO, Coast Capital, NBC, RBC, Scotiabank, TD Bank and Vancity too. (Forgive me if I screwed up the acronyms.)

The UK bankers include too many to name, but Lloyds, Barclays, HSBC, NatWest, PBS, TSB, Standard Chartered, and Virgin Money for starters.

While the US has the well known "anti-trust" laws which the Republicans are using to frighten the bankers, the rest of the West has fiduciary duty rules, and regulations that prohibit anti-

Da Vinci: Remember when I said California's financials are just insane to understand. According to statistics here's a breakdown



California makes \$220 billion in tax revenue. The next biggest is New York at \$125 billion, about 100 billion less. Texas, which is really profitable, a well run state has no income tax. As a result, they only collect \$86 billion. So we have \$220 billion each and every year. So California is by far and away the largest tax collector in America. Now let's contextualize it one step further and compare that with the entire GDP, that every dollar a country makes. Now here's a list of the top countries by GDP.

There are only 56 countries on earth with a GDP higher than California's tax income from taxes. The rest of these countries all have a lower GDP than what California makes in income tax, not from GDP. California is in the trillions just from taxes. So when I hear that we have to cut, we don't have money for \$130,000 to repair a liner in a reservoir, and we don't have \$17,000,000 for firefighters, I have to tell you, as a long-term California resident, I am completely fed up with this. I think our financial state is absolutely insane. A lot of countries, a lot of states, don't have

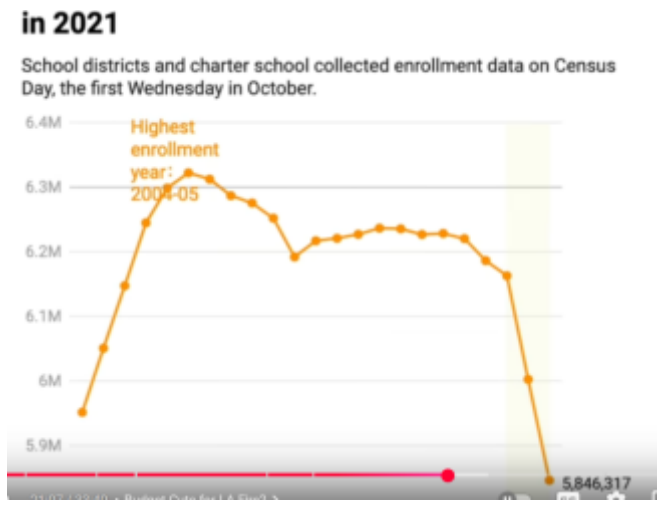
the kind of money to take on large infrastructure or to fix all their problems. That's not the case in California. \$220 billion goes a long way.

So what do we actually spend it on? I'm going to put how insane \$220 billion spent every year is in context. But first, we have to talk about how are we spending this. How is California in a budget deficit. It's absolutely madding. So I pulled up the data. What I wanted to know is how is it changing over time. So here on the left is the 2017 and 2018 numbers and on the right is last year's 2023-2024 numbers.

There is no report I've ever seen that shows California somehow has some of the greatest schools in the nation. That is not the case at all. So this has to do with administrative bloat. So that salaries are being paid to non-teaching positions. I am a huge advocate of public schools. I believe that's the great equalizer. If you want to give people equal opportunities, invest in great schools across the board, not only in rich neighborhoods but everywhere. But what we have done is hired administrators and there's a level of bloat that's really prevalent, especially in higher education. The number of nonteaching positions has gotten completely out of control, and we have to fix this. We cannot spend that much money per student, which is way more than any other really great country spends. I think that's something that has to be made better.

I wanted to just show the difference in growth. If we look over here, the largest growth sector is a bucket of money called Health and Human Services. The second largest is K through 12 Education. Let's talk about K through 12 education first. We know California is the biggest state in the Union but maybe not for long. Here is a look at enrollment numbers for K through 12.

But as if the general fund wasn't enough, we have special funds, we have bonds.



We can't even stick to our original budgets. And as a result, this is why we run into deficits. But this amount of money we spend for Health and Human services is probably the spending that everyone gives California a hard time over. This is the homelessness problem. This is low income housing.

We hit our peak of over 6.3 million students back in 2004 and we have been on a decline ever since. The latest numbers I could find, it's about 5.8 million. So that means that we now spend 150 per cent more, or \$27 billion more on K through 12 education for less students.

This is all those projects. So that means that K through 12 education and Health and Human services is nearly \$200 billion. Again, we make about \$220 billion. I think this year might be \$230 billion. Well, we'll see after all this. But that's a huge amount of our spending.

Now before I get into how the Health and Human services is performing, here's a general call to reason. We should tell all of elected officials to return to a 2016 budget that was around \$183 billion and enforce that. Because I think we need to have \$40 to \$50 billion of surplus to handle disasters and to have a massive water reclamation and water mitigation project that should span a long time. But when you have this much money coming in, it's more than doable.

So how's the homeless problem going?



California has 188,000 homeless people. That's about 1/4 of all the homeless people in America. And that number grew 3% year over year. And it basically rose every year. The homeless population is growing. Now, does that mean that more people are falling to homelessness or are we attracting homelessness. I mean California has one of the best weather in America all year round. There are places in California you can live outside in a tent all year. Those things I don't know, but I can tell you that these plans are not working, and there are huge levels of unaccounted-for allocations of money not being spent properly and all the rest. But to put that into perspective, that part of the government is eating up \$114 billion. That cannot continue.

If we cut that in half and forced California to reduce over 50 billion, or some number they might actually have better outcomes, because maybe we'd have better people in charge who could do a better job of handling it. By the way, that \$220 billion doesn't include property taxes.

The average per capita property tax that a person in California pays is \$1950 per person. For a population of 39 million people,

that's \$76 billion every year in property taxes. Now that money is encountered to the state because it goes into local coffers. But that's another nearly \$80 billion. Combined that's 300 billion. Now think about that for a moment. Remember earlier when I said Gavin Newsom probably isn't to blame for the dams in the very north of the state.



This is where he definitely is to blame. This is an article that talks about the 42 aging dams in the state that need money for restorations.



About \$50 million in total. Now, apparently there's no money for these dams to fix them.

And as a result, they've had to run at lower than usual capacity. Now I want to put this into context for you. \$50 million, after the numbers that we've just been talking about is less than nothing. Why is this so bad? I live in San Diego. Last winter, a year ago we had really, really good rainfall. We basically get really good rains every couple of years, like every four years, kind of the El Nino cycles. And then kind of dry clear blue skies and no rain. So when I heard stories a year ago that there were dams in San Diego in particular,



and other parts of the state that were so damaged that the dam operators had to open levees to let the water out because if they kept the water back, the pressure from all that water could cause catastrophic failure. So dams were so compromised that they couldn't hold back about 107 billion gallons of capacity of water. That's what was lost by not repairing these dams. So \$17,000,000 to fund the fire department. Out of 0, give them \$170 million and \$50 million, potentially \$100 million because these things cost more than they say \$200 or \$500 million, whatever that number was, we could easily afford to fix it. And if we had 107 billion gallons, that's like having 1,000 Santa Ynez reservoirs 1,000 reservoirs. Picture that. That reservoir that we showed you near the Pacific Palisades, 1,000 of them we could litter across the state, across all the major population centers, northern and Southern California in the event of the next one.

Right. That wasn't done. Over \$50 million and that is where you should be absolutely furious because. I remember that story, and I remember thinking we are letting beautiful, fresh clean water go right back to the Pacific Ocean instead of storing it all because we don't have the political wherewithal or the power of will to get the work that needs to get done, done.

Now the infuriation about this story is multifold for me. Because as an engineer, I always think about how do you design a system with redundancy, with failure and backup, right? The Santa Ynez reservoir should be one of many. There should be other reservoirs, so there's construction or anything happening in one reservoir, you have multiples that come on line. You should have two pumps in operation and two backup pumps that are maintained and checked at all times. If there's a failure of any pump, you're never without water. You should be able to output enough water to maintain a critical fire. These are the exercises that you should go through. Airplanes are built this way. We talked about airplanes in the past with redundant hydraulic systems, multiple

redundancies in terms of motors and engines and pumps. We have to build better and it's all doable. When you make 200 to \$300 billion every year, there's no excuse for why we can't do any of this stuff.

Finally, what does this mean for insurance? Because I mentioned that \$220 billion tax base that's based on really wealthy people paying taxes like, just like in federal income taxes, the upper 50% of earners pay the majority of state and local taxes as well. So if we lose them because we can't insure their homes, we're in trouble. So California's Insurance Commissioner, Ricardo Lara, has already issued a mandatory one year moratorium on non renewals and cancellations to protect Southern California residents affected by recent fires. And they have a list on their website which you can put in the description where you can check to see if you are under that list. That means that if you had no previous notice or anything, they cannot cancel your policy for one year. What happens after that? We'll get to that.

The other thing is that they've also told insurance companies to do the right thing. For any non renewals in the past 90 days before the fires broke out. This is for people who got letters saying we're going to cancel your insurance effective this date. If you got that letter 90 days from when the fires broke out, they're asking these companies to do the right thing. But there's no guarantee. I've had my insurance cancelled on me before. I had Farmers Insurance and they told me we're dropping you. And now I have another company. So I will be honest with you. I don't know what will happen to us in the future. If I'm going to start getting letters as soon as they can to drop us.

Companies have already been pulling out of California and Florida. This is not just a California. Florida has huge devastation, especially last year. And they have similar risk where companies are saying it is just not worth the reward and we're going to drop coverage. Home values in California are especially crazy because of how expensive they are. Average homes in the Pacific Palisades were over \$4 million. And that's why even if the fire is relatively small in the grand scheme of things, the damage has been absolutely insane. About 1600 policies in Pacific Palisades were dropped by State Farm in July. As a result, homeowners in the Pacific Palisades had increasingly shifted to FAIR Plan which is California fair access to insurance requirements plan with roughly 1400 of the towns 9000 homes covered by the plan. That's like one in seven. This is a backup for people who can't get insurance. Not a normal insurance vendor.

Since 2019, more than 100,000 Californians have lost their insurance. These numbers become insane, especially at the very expensive nature of the state, home, labor and everything else to rebuild these homes. Now, climate disasters and climate change are the reason for these companies to abandon California and Florida and other parts of the world. Now, if you believe in climate change or not, the insurance companies and their models sure as heck do. And that is why they're getting out in front of

this thing. They say I don't want to cover it because we'd have to charge these people so much money that it wouldn't even be worth it. And it's really unfortunate for people like me who paid homeowners insurance for 20 years, never used it for a dollar, and when they dropped me, I get nothing back. This is the reality in the post aftermath, even for people not affected by this fire that we will have to face.

And that's why I urge everybody to have some compassion and sympathy for the people involved in this. And if you're able to donate, we'll put a donation charity link in the description that you can give to help people. We will do the same and hopefully we can do better in the future. But I urge you and this is a call for anybody who's watching, because I know my audience. If you're an engineer, a hydrologist, you work in water or you know large water works or you have any kind of high technical engineer, scientist background, I urge you to run for political office because currently politicians are social workers, lawyers and politicians, and they are just not equipped to solve the big problems. If we had more engineers in politics, I'd have a lot more optimism for the future. I'm not quite there. I still have a big mortgage to pay off, maybe in 10 years. So if you're close to that point in your life and you have civil service in you, it'd be an amazing way to help your country, your state and so much more. Because we need smarter people with industry knowledge running things. We can't keep doing things the same way. And we need drastic changes. But the good news is with how much money California makes, it's possible unless we screw this whole thing up, drive all the high earners out of here and drop that tax base. Then we're all screwed. There's no way we can recover. My optimism and my hope only exists if we can fix this problem. But you've heard of people leaving California. Largely now it's lower income people who just can't afford to buy a house. But if we start losing the really rich people with their \$10 million homes and their huge property tax bills and state taxes, and we lose that, we won't even have the resources to dig ourselves out of this, all while running deficits. That's unacceptable. If you have any ideas for what we can do in terms of the citizenry, write to me and leave me a comment. I'll see what I can do. But we have to demand better because I think we have to. There's so much that we need to fix in California and it's doable, and it's worth it. It's a state that I love. And I'm not giving up.

While he was in Ashville North Caroline on Jan 24, 2025, President Trump made an interesting comment about the Los Angeles fires. He said:

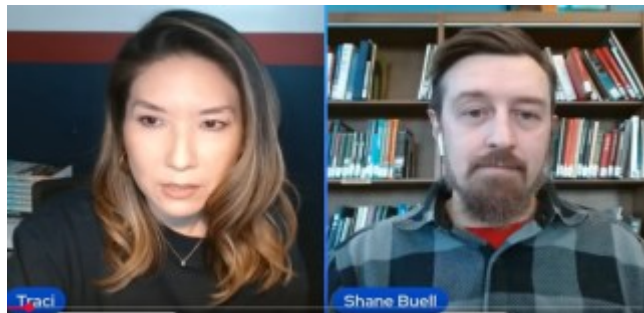

What did Trump mean by something hit it? Was he implying some sort of weapon was used?

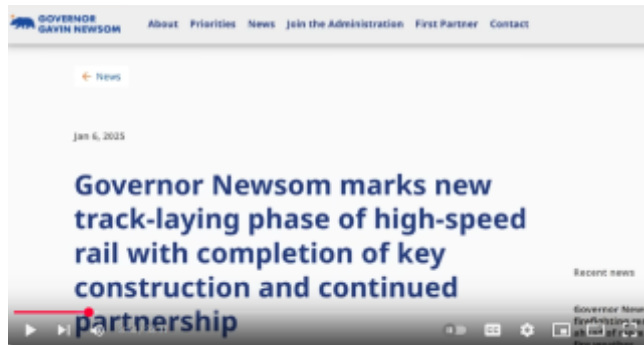

Shane: The Palisades fire started on January 7th of this year and it has grown to over 20,000 acres. But what most people are probably not aware is that the day before, on January 6th, Governor Newsom was joining community leaders and workers in celebrating the beginning of the track-laying phase of the high-speed rail which is part of his plan called Building California, whose motto is “build more faster.” This involves over \$180 billion invested into California's infrastructure, and that includes, broadband for stealing our data and tracking us.



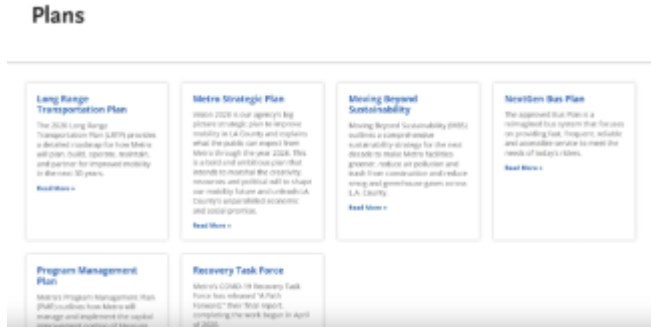
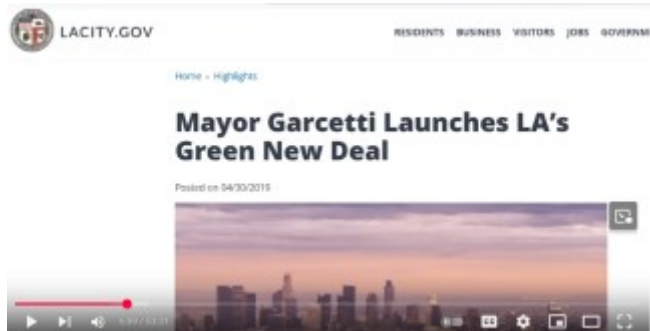

And more expensive forms of energy generation and when it says environmental restoration, they mean kicking people out of the wildland urban interface (WUI). You know semiconductors for 5G tech and smart city tech, streamlined projects to have all these plans done by the time the World Cup and the Olympics come to Los Angeles. Transportation to make it less convenient to drive cars than it would be to take the bus or walk. It involves control over the water supply and zero emission vehicles so that any vehicle you do have will most likely be an EV with zero emissions. We should know that Gavin Newsom is a member of the World Economic Forum (WEF), along with Tulsi Gabbard, Zilenski, Kim Jong Un, Trudeau and Macron from France. That is one heck of a list of World Economic Forum young global leaders. These leaders includes Mayor Garcetti, who was the previous mayor of LA who launched a Green New Deal in 2019 which includes making LA carbon neutral by 2050 as well as making a commitment to uphold the Paris Climate Agreement.

About a year after the Green New Deal, Mayor Garcetti said, “the soul of our recovery, will shape the contours of our city's future for decades to come. We have a blueprint for the city of the future.” Now that blueprint that he was referring to was Smart LA 2028,



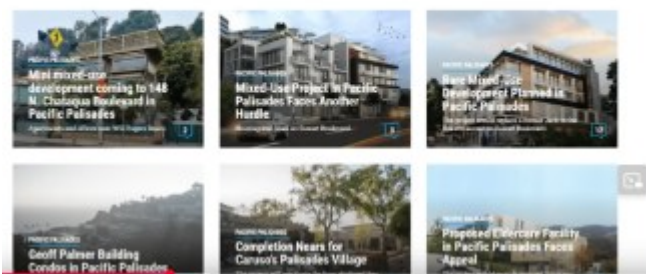
which is the smart city strategy for the city of Los Angeles. And he was allowed to put his name on this, but he didn't come up with it himself. I know he's taking a lot of credit for this, but this is handed down to the mayor's from on high. The UN Sustainable Development Goals for 2030 hand these plans out to every locality and they let the local politicians take as much credit as possible for this.

This is basically an overview for the smart city, which is based on several other plans that were previously made. So there's the 2020 long range transportation plan, the Vision 2028 Metro Strategic Plan, the MBS or Moving Beyond Sustainability plan, among many others, which includes these transit oriented communities.

Now transit oriented development is a theme that we've seen running through pretty much every smart city plan that I've investigated so far and it involves making it more convenient to transit, to take transit, walk or bike than to drive and I interpret that as making it less convenient to drive than the other modalities of transportation. At the bottom, it says one of their policy goals is to stabilize and strengthen communities around the transit areas. Now these are usually known as opportunity zones and usually within 1/4 to half mile of a transit station there's going to be a lot of redevelopment projects such as affordable housing, mixed-use development, and so forth.

Now, I know a lot of people are wondering if there are any plans for the Palisades and there actually are.

Pacific Palisades



So the Palisades has plans for mixed-use multifamily developments. Now what I want to point out is that Palisades has traditionally been zoned for R1 zoning, which is single family zoning, but the fact that these plans have been approved either by Mayor Garcetti or perhaps Karen Bass. Bass probably read into this so she at least knows about it. However, it appears that Palisades is being rezoned for multi-family mixed-use development. So even though Governor Newsom denies having any involvement in the rezoning of Palisades, Palisades is being rezoned, and it's most likely the former or current mayor who had a hand in that. Now, I just wanted to point out the Palisades is not an Olympic venue but it is part of the smart city plans.

So what are the Olympic venues? So these are the Olympic venues that are coming to Los Angeles now.

... the 1984 Summer Olympics, the 2028 Summer Olympics will be hosted at a majority of venues around Greater Los Angeles. The city's bid relied on a majority of existing venues and venues that had already been under construction or were planned regardless of the Games. The majority of venues are divided into clusters known as "sports parks", situated at Downtown Los Angeles, the San Fernando Valley, Carson (at California State University Dominguez Hills), and Long Beach. No new permanent venues are being built specifically for the Games. Like the 1984 Summer Games, the Olympic Village will be situated on the University of California Los Angeles campus, while the University of Southern California will host the Media Village. The Los Angeles Memorial Coliseum and the SoFi Stadium will host athletics and football events, respectively. [29] Both will become the first stadiums to have ever hosted three different Olympics. [30] Crypto.com Arena will host gymnastics, and the Intuit Dome will host basketball. [31] BMO Stadium, which opened in 2018 as the home of Major League Soccer's Los Angeles FC, will host the football final. [32] SoFi Stadium, which opened in 2020 as the home of the NFL's Los Angeles Rams and Los Angeles Chargers, will host swimming events. [33] Riviera Country Club will host golf. [34]

The Coliseum underwent a major renovation and restoration program from 2017 to 2019. [35] A new press box, log boxes, and club seats were installed. [36] Crypto.com Arena underwent renovations scheduled to be completed in 2024. [37]

In January 2017, it was reported that the bid committee had proposed holding the opening and closing ceremonies at both SoFi Stadium and the historic Los Angeles Memorial Coliseum. In an acknowledgement of its size in the 1932 and 1984 Olympics, the plans called the final leg of the torch relay to be ceremonially launched from the Coliseum, a simulcast of the opening ceremony proper at both Stadium for those in attendance, and the ceremonial lighting of the historic Olympic cauldron at the stadium once the cauldron is lit in Inglewood. The closing ceremony would be held in reverse, with opening segments at SoFi Stadium, and the official protocol held at the Coliseum. [38]

To reduce costs and use more pre-existing facilities, LA28 announced changes to its venue plans in June 2024. The temporary aquatic venue that was scheduled to be built at USC's DeBakey Pool was scrapped, in favor of holding swimming at SoFi Stadium, while swimming in Long Beach, and diving at the historic Los Angeles Swim Stadium (which was built for the 1932 Games). With a planned configuration for 38,000 spectators, SoFi Stadium will be the largest swimming venue in Olympic history. Equestrian was moved to Temecula. [39]

The majority of the venues are divided into clusters known as Sports Parks, which will be situated in downtown LA, the San Fernando Valley and Long Beach. The Olympic Village will be situated at UCLA campus, while the University of Southern California will host the media village. The Los Angeles Memorial Coliseum and the Rose Bowl will host athletics and soccer and the crypto.com arena will host gymnastics and the Intuit Dome will host basketball. The BMO Stadium will host the football finals and the So Fi Stadium will host swimming events. The Riviera Country Club will host golf. The Orange County Great Park in Irvine is a potential venue for the cricket competitions. There is going to be, like I said, swimming at the Sofi Stadium and artistic swimming at Long Beach and diving at the historic Los Angeles Swim Stadium. Equestrian was moved to Temecula, CA.

So there's 28 projects seen here, which includes mostly rail and bus transit projects. There's a couple of Interstate projects that involve Expressway lanes, but the one I wanted to point out here was the bus only lanes. They are planning on actually reducing the number of car lanes and increasing the number of bus lanes and bike lanes and even widening the sidewalks for pedestrians. So that's going to increase the other modalities of travel, but decrease the efficiency of travel by private car.

Now of these projects, Mayor Garcetti has given accelerated priority to the projects that are involved for the Olympics. He calls this the 28 by 28 initiative.

Now of these projects, the ones that are in and around the SoFi Stadium in Inglewood, CA are going to be redeveloped even faster at warp speed, so to speak, because there's only about 500 days left until the World Cup kicks off at Sofi Stadium in Inglewood, CA. And even the World Cup page has a section on human rights, and they addressed potential human rights impacts.

Now when it comes to a positive human rights legacy, I don't

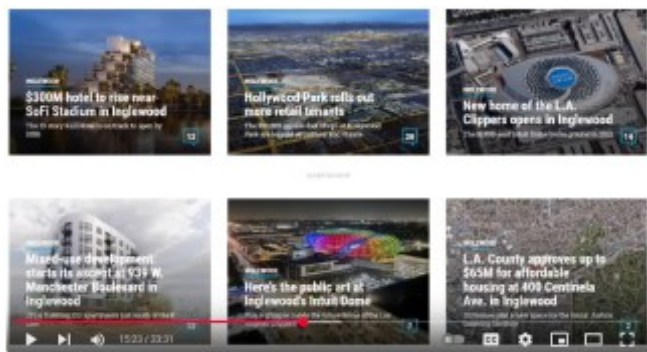

Now, that could be another fire, but now that they have their emergency powers and their eminent domain, they might just invoke eminent domain and say it's for the greater good.

The World Cup is going to be held at Sofi Stadium, which is in Inglewood. And there are various other projects in Inglewood.

And that is going to be warp speeded to be done by 2026 before the Cup kicks off at Sofi in Inglewood. Now this is all part of the Vision 2028 Metro Strategic Plan, which plans to connect all of Los Angeles City, at least in all of the Olympic venues, by rail and by bus, by 2028.

There's going to be a high rise hotel near the Sofi Stadium. And it looks like the Intuit Dome is already completed. And there's also going to be mixed-use development as it may already be zoned that way. There is also a large affordable housing project in Inglewood as well.

Now as Tracy mentioned, you know they have to complete this K line which connects to the Blue Expo line that goes to Santa Monica and it runs through Inglewood and will eventually connect to LAX.

Now, these rail projects actually also dovetail and connect with the high-speed rail network that Gavin Newsom has proposed. You can see the Southwest high speed rail starts in San Diego and connects San Diego to Los Angeles which some are calling San Angeles and it continues all the way up to San Francisco and even to Sacramento.

Now in Sacramento is where it connects to the North Valley Rail project, which is proposed to head north towards Oroville and Chico. And some alternate proposed routes even take it through Paradise CA. As we know, all of those have suffered major fires in recent years.

So now this is part of their plan to make LA no longer the car capital of the world. They plan to get rid of all of the privately driven cars in LA by 2028. that they are going to use proactive technology that identifies fire, violence and other risks to the health and safety of LA residents even before a 911 call. Now that implies the use of biometric cameras and scanners and artificial intelligence with predictive analytics, basically free crime, which I'll get to more of that later. Now, some of the smart city data points that we have here or that they will be using IoT which is Internet of Things that's going to be a network of sensors that's connected to 5G and it details the real time tracking and movements of just about everything, every device.

One of the programs that's involved is called Data Angels which uses a lens of equity, whatever that means, to scrape and mine data, stitch together insights and provide policy recommendations. Now this is all part of their electronic social governance, which is going to be a lot of policy is going to be governed by AI or electronically and I just wanted to show this is part of the plan.

The City of Los Angeles envisions a highly digital and connected city in 2028.

Los Angeles residents will experience an improved quality of life by leveraging technology to meet urban challenges. No longer the "car capital of the world", residents will choose how they wish to get around LA, using a single, digital payment platform, with choices like renovated Metro rail and bus systems or micro transit choices, such as on-demand LAnow shuttles or dockless bicycles. Neighborhoods will again welcome the pedestrian and allow easy access to green space.

There's going to be RFID tags that have been miniaturized and they will be inserted in non electronic devices, even clothing these such as shoes, pants and shirts. These may actually contain these Internet of Things RFID tags that can be tracked everywhere around LA with the sensors that are being put in place. They also talk about Smart City data and tools, practices which include effective cross department government to resident, government to business and machine to machine information sharing and what they left out here was the resident to government information sharing which is going to be sharing all of your data with the government and the corporations they work with. Another thing that they talk about here is smart city connectivity and digital inclusion, which is integrating public and private offerings, which is basically Public-Private partnerships, also known as fascism, to keep track of all of this stuff.

Smart Policing Enables a Safer Los Angeles



CompStat ("Computerized Statistics") is a weekly framework used by LAPD to improve services across all L.A. neighborhoods. CompStat helps police understand where crime is happening and potential reasons for criminal activity, enabling proactive community outreach to prevent future crime. CompStat was integral in reducing

Now this is the predictive analytics that I was talking about in the biometrics that are going to track everyone also through the internet of things. So everyone will be tracked in real time and predictive analytics will be used to predict when you are about to commit a crime. Now, if anyone has seen the Tom Cruise movie Minority Report, this is a very dystopian version of that that is com-

ing to pass.

So now this is based on the I3 Consortium, which along with the City of Los Angeles and other public and private partners, have formed a consortium to develop an open source platform called the Intelligent IoT integrator or I3 and it's going to use real time Internet of Things data streams between device owners and 3rd party applications. This also includes security camera data aggregation, which is going to include biometrics and so forth.



I3 Consortium - Building IoT communities for a more connected society




The USC Marshall School of Business and Viterbi School of Engineering, along with the City of Los Angeles and other public and private partners have formed a consortium to develop an open source platform called the Intelligent IoT Integrator (I3). I3 will serve as a marketplace of real-time IoT data streams between device owners and third-party applications, based on the establishment of suitable incentives and usage agreements.

The idea is to build an open source data aggregator and leverage the university as a "test bed" for participating organizations to explore smart city use cases, such as the return on investment for interactive public kiosks, security camera data

Now one of their timelines here shows that they are currently already an expanded Environmental Center across LA. And this is allegedly to inform remediation of Environmental Quality concerns like noise and air quality. But it's going to be so much more than that. Over the course of the next year, they're going to be building their Internet of Things platform through public-private partnerships, also known as a form of techno fascism. Now, by 2028, their goal is to deploy the smart grid for the continuous monitoring of LA. Not just the power grid, but it also says to empower customers to control and limit their power consumption by 2028, which is kind of ironic that they use that wording empower because it's really empowering customers to disempower themselves which is kind of ironic.

So LA is a founding member of the World Council on City Data, which enables cities to use data to design and measure the performance of city services and quality of life impacts on its communities.

L.A. is a Founding Member of World Council on City Data (ISO 37120)



The World Council on City Data (WCCD) and its development of global standards for City data (ISO 37120) enables cities to use data to design and measure the performance of city services and the quality of life impacts on its communities. As a Founding City and Platinum-Certified member, the City of Los Angeles serves as one of the leaders to set the global agenda for standardized city data, identifying strategic trends for cities, and defining a framework for standardized urban metrics.

So this brings up security and ethical concerns with Smart City infrastructure. The proliferation of Smart City infrastructure has resulted in substantial concerns around cybersecurity.

Security & Ethical Concerns with Smart Infrastructure - The proliferation of Smart City Infrastructure has resulted in substantial concerns around cybersecurity (e.g. securing IoT devices) and potential unethical uses of Smart City Infrastructure to the detriment of our residents (e.g. unauthorized surveillance). Our challenges include:

- Increase in security issues related to the exponential increase in smart devices and data sharing interfaces
- Smart infrastructure (e.g. facial recognition, high-speed connectivity, sensors, etc) can be used to discriminate against specific communities

It goes on to say that the city of Los Angeles serves as one of the leaders to set the global agenda for standardizing city data. So it almost looks like this is going to be a model for the rest of the country, if not the rest of the world.

For example, securing Internet of Things devices and potential unethical uses of Smart City infrastructure for the detriment of residents. So their challenges include increasing security issues related to the exponential increase in smart devices and data sharing interfaces, as well as Smart infrastructure like facial recognition, high speed connectivity sensors, etc. which can be used to discriminate against specific communities such as Truthers and so forth. Now it continues on to say that data privacy concerns as a city of Los Angeles and takes more and more data, whether personal or DE identified, they must be cognizant of resident privacy concerns and take steps to ensure the ethical use of this data. Their challenge includes public concerns about government data, privacy, bias, surveillance and security.

And I wanted to say that is actually one of the main goals, to steal our data and use it to track and predict everything we're going to do. And of course, you know, that does raise privacy concerns as well as you know, security concerns over our data and how it will be used.

Traci: You know as you are going through that, I just kept thinking of all the similarities with Maui again with the pre-crime and how the police chief is trying to roll this out. Something else I just made the connection with Maui. So if you're living in LA, you know that the crime is really out of control, especially theft and the homeless problem. There's a very lackadaisical attitude about prosecuting criminals, and maybe this was let go for a reason to justify this new form of law enforcement. It would be less about the personal interactions with an officer and more about AI. But everyone should be terrified of the idea that AI is going to identify people as someone that is probably going to commit a crime because you can be completely innocent and be considered a potential criminal. But all under the guise of security and safety. You know, we're going to keep you guys safe but in order to do that, we need all your data and we need to track you because the real criminals need to be tracked. But they don't realize they're not going to limit that to certain individuals. And a lot of this, especially recently, I've seen it materialize about the cars, the really quick development of the metros and the taking away of the old LA of neighborhoods with single family homes, a lot of the areas including mine, is rezoned for multifamily use. So I believe one of the bills is now allowing a single plot to hold 4 units or 4 apartments or a four family duplex. And if you're within a certain distance from a transit line, between 1/4 and 1/2 mile from the transit stations, you can put up to 10 units on a single family property. That's really crazy. Because lots in LA are not that big, six or seven thousand square feet. I just can't imagine how the infrastructure is going to support that, especially parking. I mean, parking is already so difficult. And then if you're going to have ten families versus one, I guess you're going to have to build a parking structure.

Shane: Well, they're planning on actually less lanes for private traffic and less parking spaces for private traffic. They are trying to make it prohibitively expensive, and they're also trying to make it take much longer than it already does, at least for the cars. However, the buses are going to have their own lanes. And the bikes will have their own lanes, but it's going to slow down the cars and become progressively more difficult and inconvenient to own a car. They will be adding some express lanes to the interstates. However, I do know that the plan is to reduce the number of car lanes, even though they're adding express lanes. I do believe express lanes are not free to use. And I think the plan is eventually to limit the automobile traffic, at least the privately driven automobile traffic, to these express lanes or high occupancy vehicle lanes, which are charged and so eventually the plan is to have all of the privately driven cars to be charged pretty much by the mile for all of the miles that they travel. At some point, you're not going to be able to drive anywhere without paying for it.

Traci: In the final analysis, it's not just LA, it's many cities. And it's not just in the US. But I hope this helps everyone learn more about the agendas that are being set forth. And I really want to caution people that are in LA, in Southern California, even down to Orange County and San Diego, there's a lot of stuff going down there. So I just wanted to bring awareness to what's going on because I don't know of any other channel or mainstream network that is presenting this information as it is. You know, they always have some spin on it about how wonderful it's going to be, but they don't go into the details of how they're going to get there. And this is how they're going to get there.

So I hope this helps you guys out a lot. So thank you Shane for all that research. You know, I've been in LA for a long time and I didn't know almost any of this. I knew the Sofi Stadium, had football games but I didn't know about the bigger picture and so I hope everyone else gets a better idea of what's going on so that they can prepare and make better decisions for themselves. How Will AI Control the World?



In late January, the Chinese artificial intelligence company DeepSeek launched its DeepSeek-R1 app to the world, much to the consternation of the US technology market. The US tech stocks immediately plunged when the market opened on January 27. The rumors were rife that this new AI app is 20 to 50 times cheaper to use than Open AI and ChatGPT. This performance is considered revolutionary and prompted great concern that the Chinese has gained an almost insurmountable lead in current AI technology.

But apart from the question who leads in AI technology, this latest development prompted the more general question, how will AI be used to control the world and how will the powers that be (and you can guess who they are) use AI to gain control? What will the control mechanism around this be? Will it just be replacing jobs and then providing UBI and then limit how people can spend their money? Based on what Whitney Webb says, it's not. Webb is an influential writer and researcher who writes for *The Last American Vagabond* and hosts an independent podcast called *Unlimited Hangout*. Through her work, Webb aims to highlight under-reported issues and find common ground between people of different political persuasions regarding corruption, government overreach, the lack of accountability for militaries and intelligence agencies, and the military-industrial complex.

Here is a transcript of Whitney Webb addressing on the YouTube program *NCashOfficial-Daily Crypto* how she believes **the elites will create a new class of slaves through AI. Basically, the technocratic wealthy elites believe the world has too many people using its limited resources. Thus, they will use AI to control the masses by making them physically and cognitively dependent on AI to function, thereby preventing them from gaining independence and using up the resources themselves.** Her idea is similar to that depicted in the novel 1984.

Whitney Webb: It's hard to know exactly why, but I

think it's important to say that I at least in my opinion, I think where the powers that be, however, you want to define that, are taking people is essentially leading us to some sort of two-tier society where there is really no need for a middle class and it's really more accurately described as like a neo-feudal style society where you have a large underclass managed by sort of this more elite group that would do the managing. And I think it really falls under what some people have referred to as technocracy as sort of this idea of more of like a scientific dictatorship.

There's actually this prominent figure from the Club of Rome, Dennis Meadows who explains this. The Club of Rome is an entity that has a very intertwined connection with groups that have become infamous over the past several years like the World Economic Forum, for example. But Dennis Meadows essentially said something to the effect that, you know, **for the good of people and the planet and the economy, in his words, it was going to be necessary to either reduce the world's population so that people could have freedom and use resources the way they want or that there would have to be a scientific dictatorship imposed on 8 billion or 7 billion people in order to ensure accurate allocation of resources.**

These are educated, technocratic, scientific elite and there are some thinkers in Silicon Valley like Eric Schmidt, for example, who wrote a book on AI with Henry Kissinger that essentially says there's going to be this sort of **future brought to us by AI where there will be the class of people that understand how AI works that program and maintain it. And then there will be this under class, really, they don't say underclass, but I would say that of people who AI acts upon who can't understand what AI is doing to them, and eventually because of their dependence on AI will become cognitively diminished and mentally unable, essentially to make decisions on their own and for themselves.** Without AI's help, and there's a lot of other indications I would argue whether it's UBI, which again is going to be for not the top oligarchs in Silicon Valley like Bill Gates and Reid Hoffman and Peter Thiel but I think it's intended to be for other people that aren't necessarily in that economic tier.

I think it's very likely you're going to see, if these people succeed in their designs, really more of a two tier society without any sort of need for a middle class. And so I think that's part of why it's been happening and I think you know as to why they might be playing with fire.

I think perhaps they're confident that they have a lot more available to make it much easier to manipulate people now than perhaps in times past. For example, there was a 2014 research study that was funded by the US Air Force that was about how to use social media to control people like drones, which I think is a very disturbing research proposal in and of itself, that basically this idea that you could use social media networks by tailoring what information people see and don't see down to the individual based on data mined about them off of the Internet and then analyzed by various algorithms to basically and essentially mind control people.

Other militaries around the world have spent millions upon millions of dollars over the past decade on researching how to manipulate people on social media platforms, so I think it's very possible they can manage it since a lot of discourse has become increasingly online, and they can really alter how people perceive reality to unprecedented degrees.

And another thing that's brought up in this book by Schmidt and Kissinger, eventually, people won't be able to know what's real and what's not either pointing to things like AI deepfakes and things like that. But you know what? If these deep fakes are wielded by the state to manipulate people and what if we're led to believe that things happened when they didn't happen? A lot of the fear mongering about deep fakes is when it's in the hands of an alleged cyber criminal or someone like that. But you know, there's states around the world that have an arsenal of these digital weapons that are meant to manipulate us in our perception of reality and what's real. If you can use AI or other means to control how people perceive reality you can control their behavior and a lot of other things. So, I think they're confident in that and obviously there's probably other things that I'm leaving out. But that is

what comes to mind. At least at first for me.

American makers of plowshares could, with time and as required, make swords as well. But now we can no longer risk emergency improv-

isation of national defense; we have been compelled to create a permanent armaments industry of vast proportions. . . . This conjunction of an immense military establishment and a large arms industry is new in the American experience. . .

.Yet we must not fail to comprehend its grave implications. . . . In the councils of government, we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the military-industrial complex. The potential for the disastrous rise of misplaced power exists and will persist.”

What did Eisenhower mean by the “disastrous rise of misplaced power”?

During the Iran-Conta Hearings in 1986, Senator Daniel Inouye said: “There exists a shadowy Government with its own Air Force, its own Navy, its own fundraising mechanism, and the ability to pursue its own ideas of the national interest, free from all checks and balances, and free from the law itself.”

What was Senator Inouye referring to?

UFO Anti-Gravity Tech Being Kept Secret



Dr. Steven Greer: "UFO technologies that are being kept secret would instantly change the world"

The initial dialogue begins with the introduction of Dr. Greer and his testimony about his investigation and knowledge over three decades into the secret programs of large companies that are part of the military-industrial complex into secret UFO related ultra technology projects.

Redacted: So why do you think that these secret UFO programs, these reverse engineering programs, these human trafficking programs, whatever they happen to be, are being kept from us?

Greer: I think there are two big agendas here. The twin pillars of this secrecy are (1) the technologies that are being kept secret would instantly fix the global environmental, energy and poverty problems. And you think, well, isn't that a good thing? Well, it's not a good thing if you're part of a global elite, corporate and otherwise, that benefit from the status quo of the system. We're not talking about a few billion dollars here. We're literally talking about hundreds of trillions of dollars. Because if you look at what the Pentagon confirmed a couple years ago and I've spoken to the Navy F18 pilot, a David Fraver about this, when they chased that UFO off the coast of San Diego in 2004, and by the way, we have 3500 pilot accounts like that,

The very bad news is people who are ruthlessly violent and criminal have kept it secret with malice and forethought.

And the second part of the secrecy has to do with, the let's call it, as the CIA director in 1953, Mr. Smith called it, the psychological warfare value of the UFO subject. Now, what am I referring to here? 99.9% of all news coverage, movies, Internet sites on this issue posit and present a threat from outer space that is alien is a non-sense.

but my point is that at that point the Pentagon had to admit that it was a real object, that it was not using jets and rockets. And I told people, every time I go into a meeting with someone in the Congress, look at that object. It is an alternative energy and propulsion device. What does that mean? It means that everything we're using to go into space, rockets, jets, internal combustion engines, power plants using oil, gas, coal, solar, wind, geothermal are and have been obsolete for a century, or part of a century, and for that reason this is one of the biggest existential crises facing the planet and also America, because we're very dependent on oil from dictatorships



and we don't have enough of it for the 3 billion people who don't even have any energy to cook their food with. Or three billion people, by the way, on the earth cutting down rain forests because they have to make charcoal, they don't have gas and electricity like you and I do. So this entire problem is artificial it is a construct of power, and it's not because we don't have the technology. I am a scientist. I believe in scientific solutions to these huge problems and we have them. That's the good news. The very good news everyone should hear is that we have these solutions.

Those civilizations are not a threat. The problem is the covert programs that are staging operations made to look alien that are a threat. Now this gets into a wider assessment of and you have to go down the rabbit hole with me for a second.

Redacted: That's what we love to do on this show, so please.

Greer: OK, so if you've had 80 years and some of the most brilliant scientists I've ever met in my lifetime are in these covert projects working in skiffs than in underground facilities with trillions of dollars that have been

embezzled from U.S. government but also from other sources, drug running etcetera, you have technologies that are 1000 to 5000 years ahead of anything the legal Pentagon guys I meet with have or that the President knows about or that the Congress knows about. Now that is dangerous because it's an unregulated group doing all manner of criminal activities, number 1. But number 2, they are able to stage operations tactically that put everyone seeing it would look like an alien. Let's give an example. Some of the incursions over our own classified airspace, like the ones I just referred to in a restricted zone off the coast of California, those were Lockheed Skunkworks aircraft. Anti gravity craft. Those were not ET, were not extraterrestrial. The people who have been "abducted" and the mutilations associated with this issue, those are all being done by a psychological warfare unit, staging a threat from outer space. Why? They want to unite the world in a militaristic, global sort of totalitarian state against the aliens from another world. That's the 70 year plan that Carol Rosen, who is on my team who is the spokesperson for Werner von Braun, who invented the rocket for Adolph Hitler, that it was clear when she saw that document back in the 70s that this was the plan. And Wernher von Braun said yes, they have to stage a threat from outer space to unite the world around that threat. They had brainwashed Ronald Reagan to say that. If you remember the United Nations he made that comment of "wouldn't our job of creating unity of the world be easier if we face the common alien threat?"



So that narrative, which is completely false, who does that serve? It serves people who are power hungry, trying to accumulate vast power, not just the United States but globally, around a false threat. Now, the reason we know it's a false threat is that I have people on my team who have been on the tactical abduction units using man made anti gravity craft that are made by my uncle's old

company, Northrop Grumman. Raytheon, Lockheed, EG&G. We know who's working on them. We know where their plants are. We know how the devices operate. And so when you have that capability and out of a million people, I don't think you would find one person in a million when they were to see one of these objects and see the creatures they use that are the stagecraft to abduct folks, everyone would think that was an ET or an alien. It isn't.



So now people say this is a crazier story than the UFO story. And I guess I tell people in 1991, a senior intelligence official, reached out to me, I'm a young doctor and he says if you tell the people the truth, it is less believable than the fiction that everyone is believing because it's more bizarre. It's more strange. And I said yes, I know this and this is a big problem because it would be easy to stick with the narrative, that is the false narrative. So you have these twin pillars of the secrecy keeping the technology away from the benefit of we the people. And by the way, this is whether you're a left wing environmentalist, Green Party person or a libertarian, this is your dream that you would have a box like your heat pump or smaller that would run your house or your car, or your factory or your business with zero energy cost pulling energy out of what's called the zero point energy field or quantum vacuum, which by the way, Tesla stumbled across back in the early 20th century.

So I think this is one of the big problems here, is that you have to connect the dots. What I'm trying to do very quickly here at the beginning of what would be the compelling reason for such extreme secrecy that between 1956 and 1960, Dwight Eisenhower lost control oversight of these projects is because in 1954 they broke the code of what's called gravity control, anti gravity. They had these free energy technologies, figured out. The industrial Fascist folks decided globally, we don't want this out and they have more power than the US govern-

ment frankly. Much more and more money in the aggregate. Ending the secrecy surrounding the UFO/ET subject is a laudable goal. It is long overdue. It would transform the world in ways both simple and profound.

you know, false flags happen all the time. We stumbled into the Iraq war because of false information on weapons of mass destruction. We had the Vietnam War greatly expanded because we staged and exaggerated an attack on our vessels, Navy vessels. My dad was in the Navy in the Gulf of Tonkin.



So this kind of manipulation has happened historically. The Big one is coming. The big manipulation and this is what we have to be very careful of because really continued secrecy is preferable to, frankly, war of the worlds, World War 3.

The House has approved from the leadership down, open hearings on this and I'm working with some of those folks.
