Key Moments & Turning Points; In the 3rd inning, Blue Jays' star Bo Bichette blasted a 3-run homer off ( yes ) Shohei Ohtani, giving Toronto an early 3-0 lead; The Dodgers chipped away: they got runs in the 4th and 6th innings to make it 4-2 Blue Jays heading into the later innings;

In the 8th inning, the Dodgers' Max Muncy hit a solo homer to cut the deficit to 4-3;

In the 9th inning, facing elimination, the Dodgers tied it: Miguel Rojas hit a game-tying home run for the first time ever in a Game 7 ninth inning;

Neither team scored in the 10<sup>th</sup>;

In the 11th inning, with two outs, the Dodgers' Will Smith launched a solo home run to put them ahead 5-4. That proved to be the decisive blow.;

Now, the closing act: Yoshinobu Yamamoto—who had started Game 6 the day before—came in relief and got the final outs, including inducing a game-ending double play. He was later named World Series MVP;

**November 1, 2025, The Los Angeles Dodgers win the 2025 World Series in an 11-inning thriller against the Toronto Blue Jays, 5-4, in what many now call the greatest World Series game ever played. This victory marked the Dodgers' second consecutive championship, making them the first team in 25 years to go back-to-back; Experts cite 9 plays in the last two games that affected who won the Series (some of the plays came**

Game 7 in a World Series to go extra innings since ... well, a long time. ESPN called it “one for the ages”; The Blue Jays had several chances—the lead, the home crowd, momentum—but the Dodgers found ways to survive and strike; There were dramatic twists: late-inning heroics, bullpen gambles, legacy-stakes on the line; The Dodgers became the first team since the late 1990s to repeat as champions in MLB.

Here are 10 pivotal plays from game 7—each one could have swung the outcome in an instant.

This game was a rollercoaster of momentum shifts, clutch performances, and missed opportunities. The Dodgers ultimately won 5–4 in 11 innings, but the following moments were true inflection points:

**Bo Bichette’s 3-Run Blast (Top 1st)** Bichette gave Toronto a 3–0 lead with a towering home run. It set the tone early and could’ve been decisive if the Jays had held it

**Shohei Ohtani’s Bases-Loaded Strikeout (Bottom 2nd)** With two outs and the bases loaded, Ohtani struck out Andrés Giménez on a 99 mph fastball. A hit here might’ve broken the game open

**Ernie Clement’s Hitting Streak (Middle Innings)** Clement extended rallies with clutch singles, keeping Toronto’s offense alive. One more RBI could’ve sealed it

**Max Scherzer Escapes a Jam (Top 5th)** With runners on second and third, Scherzer induced a groundout to end the threat. A hit here could’ve put Toronto up by 3

**George Springer’s Diving Catch (Bottom 6th)** Springer robbed Mookie Betts of extra bases with a full-extension grab. If missed, Betts likely scores and shifts momentum

**Vladimir Guerrero Jr.’s Missed Tag at First (Top 8th)** A miscommunication led to a missed tag on a pickoff attempt. The runner later scored, tying the game

**Miguel Rojas’ Game-Tying Homer (Top 9th)** With two outs and the Dodgers trailing 4–3, Rojas launched a solo shot to tie the game. Toronto was one out from the title

**Will Smith’s Go-Ahead Homer (Top 11th)** Smith crushed a solo homer to give the Dodgers a 5–4 lead. It proved to be the game-winner

**Dodgers’ Final Defensive Stand (Bottom 11th)** With two on and one out, the Dodgers turned a double play to end the game. One misstep here, and Toronto could’ve tied or won

**In the bottom of the ninth, Blue Jays pinch runner Isiah Kiner-Falefa was thrown out at home trying to score the winning run—one of the most heartbreaking moments of the 2025 World Series.**

**Here’s how it unfolded:**

**Situation: Bottom of the 9th, score tied 4–4, one out, bases loaded. Kiner-Falefa was on third base, having replaced Bo Bichette as a pinch runner.**

**Batter: Daulton Varsho hit a sharp ground ball to Dodgers second baseman Miguel Rojas.**

**The Play: Rojas fielded the ball cleanly but stumbled slightly as he turned to throw home. Despite the stumble, he delivered a quick, accurate throw to catcher Will Smith.**

**The Tag: Smith applied the tag on Kiner-Falefa, who had hesitated slightly before breaking for home. The timing was razor-thin, but the out was confirmed.**



**Impact:** The Blue Jays went from having an 82% win probability to losing the game in extra innings. That out at home was the final chance to walk off with the championship.

**What Went Wrong?** Lead hesitation: Kiner-Falefa later admitted he didn’t take a big enough lead off third, fearing

a pickoff. Split-second decision: He broke for home on contact but didn't get the jump he needed.

Dodgers execution: Rojas and Smith executed perfectly under pressure, despite Rojas' stumble.

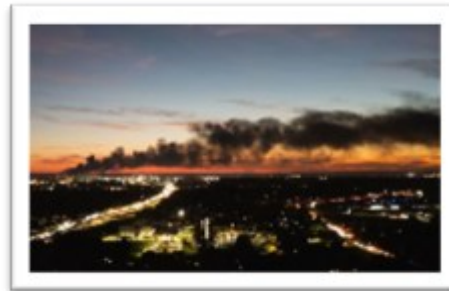
**This play is now etched in World Series lore as one of the most dramatic "what could've been" moments—a single run away from glory, denied by inches**

**These moments weren't just dramatic—they were decisive. Each one carried the weight of a championship, and together they made Game 7 one of the most unforgettable in World Series history.**



**November 4, 2025, Democrats win key races across the country, including governorships and major ballot measures.** Notably, Proposition 50 passed in California, allowing midcycle redistricting to favor Democrats; Key Elec-

tion Winners; New York City Mayor: Zohran Mamdani, a democratic socialist, defeated independent Andrew Cuomo and Republican Curtis Sliwa; Virginia Governor: Abigail Spanberger, a moderate Democrat and former U.S. Representative, won against Republican Lt. Gov. Winsome Earle-Sears; New Jersey Governor: Mikie Sherrill, Democratic U.S. Representative, prevailed over Republican businessman Jack Ciattarelli; These victories were seen as a referendum on President Donald Trump's second-term agenda, with Democrats gaining momentum ahead of the 2026 midterms; Major Ballot Measures That Passed; California Proposition 50 ("Election Rigging Response Act"): Passed by voters, this constitutional amendment overrides California's independent redistricting commission; It allows the legislature to draw new congressional maps starting in 2026, potentially giving Democrats five additional seats through 2030; The measure was introduced in response to Republican redistricting efforts in other states.



**November 4, 2025, a UPS cargo plane crashed in Louisville, Kentucky, killing at least nine people and injuring 11 others.** The crash occurred shortly after take-off from Muham-

mad Ali International Airport. Key facts: Flight: UPS Flight 2976, a McDonnell Douglas MD-11F cargo jet; Destination: Honolulu, Hawaii Time of crash: Around 5:15 p.m. local time, Tuesday; Fatalities: At least nine people confirmed dead: Three crew members aboard the aircraft; Six people on the ground, including workers in nearby businesses; Injuries: At least 11 people injured on the ground, some critically; Missing persons: Search and rescue teams are still looking for 16 missing individuals; Crash Site and Damage; The plane crashed into an industrial corridor near the airport, igniting multiple fires and damaging several buildings; Eyewitnesses and video footage showed the aircraft with flames on one wing before it plunged and exploded into a massive fireball; Debris and smoke were visible for miles, and a shelter-in-place order was issued due to air quality concerns; Operational Disruption; All flights in and out of the airport were suspended temporarily following the crash; UPS Worldport, the company's global air hub located at the airport, was directly impacted; The Federal Aviation Administration (FAA) and National Transportation Safety Board (NTSB) are investigating the cause; Preliminary reports suggest a fire on one wing may have contributed to the crash; This is the deadliest accident in UPS Airlines' history since its founding in 1988.



**November 5, 2025, On this day, the current federal shutdown officially became the longest in U.S. history, surpassing the previous record of 35 days set in 2018–2019.**

Here are the key facts: Start Date: October 1, 2025; Length: 36 days and counting, making it the longest-ever U.S. federal government shutdown; Previous Record: 35

pendent (Angus King) joined Republicans to advance the bill; Notable Democratic supporters: Tim Kaine, Dick Durbin, Maggie Hassan, Jeanne Shaheen, Jacky Rosen, Catherine Cortez Masto, John Fetterman; Only Republican to oppose: Senator Rand Paul of Kentucky; What the Bill Includes; Stopgap funding: Keeps the government open until January 30, 2026; Extended programs: Includes provisions to fund food stamps and veterans' benefits through September; Future vote promise: Guarantees a vote on expiring Affordable Care Act tax credits; Next Steps; House vote pending: The bill must still pass the GOP-controlled House of Representatives; Presidential signature: President Donald Trump would need to sign the bill for it to take effect; Context; This procedural vote followed 14 failed attempts to pass similar measures in the Senate; The shutdown has caused widespread disruption, including furloughs and airport delays; The bipartisan breakthrough came after centrist Democrats negotiated concessions with Republicans and the White House.



**November 6, 2025, Nancy Pelosi announces retirement** The former Speaker of the House declared she will not seek reelection, ending a four-decade career in Congress. Her departure opens a leadership vacuum

in San Francisco politics; Pelosi was first elected in a 1987 special election and has served 38 years in the House; She is the first and only woman to serve as Speaker of the House, holding the position from 2007–2011 and again from 2019–2023.



**November 12, 2025, President Donald Trump signed a funding bill officially ending the longest government shutdown in U.S. history, which lasted 43 days.** The measure reopened

federal agencies, guaranteed back pay for workers, and extended funding through January 30, 2026; Congressional Votes: Senate: Passed earlier in the week, 60–40, with eight Democrats joining Republicans; House: Passed November 12, 2025, by a vote of 222–209, with six Democrats and two Republicans crossing party lines; Impact on Federal Workers: Guaranteed back pay for employees; Workers instructed to return to their jobs the next day; Public Disruptions: Stranded travelers at airports due to disrupted flight operations; Long lines at food banks as workers missed paychecks; SNAP benefits and other services faced delays; Scope of Funding Bill: Funds most of the government until January 30, 2026; Provides full-year funding for Veterans Affairs, parts of the Agriculture Department, and Congress; Political Context: Trump blamed Democrats for the shutdown, framing it as a fight over subsidies and immigration-related spending; He urged voters to “never forget this” and called for ending the Senate filibuster to prevent future shutdowns; Why It Matters; This shutdown surpassed all previous records, highlighting deep partisan divisions in Washington; The bill’s short-term nature means another



**November 9, 2025, The Senate voted 60–40 to advance a bipartisan funding bill that could end the longest government shutdown in U.S. history;** Vote tally: 60 in favor, 40

against — just enough to overcome the filibuster threshold; Break in party lines: Eight Democrats and one Inde-

funding fight looms in late January 2026; Federal workers and the public bore significant hardship, reinforcing debates about the use of shutdowns as a political tactic.



**November 16, 2025, President Trump announced his support for releasing the Epstein files posting on Truth Social urging House Republicans to vote for the release of the Epstein files, saying**

**“we have nothing to hide” and calling the controversy a Democratic distraction.** The following day November 17 in the Oval Office, Trump told reporters “I’m all for it” and confirmed he would sign the bill if it reached his desk; This marked a major reversal from his earlier stance, where he had dismissed the push to release the files as a “hoax” and resisted efforts to make them public; The announcement came just before the House was scheduled to vote on the Epstein Files Transparency Act, which would compel the Justice Department to release all unclassified records related to Jeffrey Epstein; For months, Trump had opposed releasing the files, claiming Democrats were using them to deflect from other issues; His sudden shift was likely influenced by growing pressure within Congress, including a bipartisan discharge petition that forced a vote; Trump emphasized that he had “nothing to do with Epstein” and framed the issue as politically damaging to Democrats rather than Republicans; The announcement is significant because it removes a major obstacle to the files being made public; Legal experts caution, however, that Trump may still have procedural ways to delay or block the release despite his public statements.

the bill almost unanimously; Name of the Law: Epstein Files Transparency Act; Mandate: The Justice Department must release all unclassified records related to Jeffrey Epstein, including files on his sex trafficking investigation and the circumstances of his death in 2019; DOJ has 30 days to make the files public; Redactions Allowed: Personally identifiable information about victims and details that could jeopardize ongoing investigations may be withheld; Attorney General Role: Attorney General Pam Bondi is tasked with overseeing the release; Political Context; Trump’s Initial Resistance: For months, Trump opposed the bill, calling it a Democratic “hoax” and claiming it was meant to distract from Republican victories; Congressional Pressure: The bill passed the House 427–1 (only Rep. Clay Higgins, R-La., voted against) and then cleared the Senate by unanimous consent; Trump’s Reversal: Days before signing, Trump shifted his stance, saying “we have nothing to hide” and announcing on Truth Social that he had signed the bill; Partisan Framing: Trump suggested the files would expose ties between Epstein and prominent Democrats, including Bill Clinton; What Happens Next; Release Deadline: DOJ must publish the files by mid-December 2025; Transparency vs. Protection: While the law emphasizes transparency, it balances this with victim privacy and investigative integrity; Potential Impact: The files could shed light on Epstein’s network, his death in federal custody, and political or social connections that have long fueled speculation.



**November 21, 2025 Marjorie Taylor Greene announced she will resign from Congress on January 5, 2026, following a public and bitter split with President**

**Donald Trump.** She said she wanted to avoid putting her district through a “hurtful and hateful primary” after Trump withdrew his support and backed a challenger against her; Once one of Trump’s strongest allies, Greene clashed with him over policy, including foreign affairs, healthcare, and the release of government files related to Jeffrey Epstein; Trump publicly announced he was “done” with Greene and called her resignation “great news for the country”; Greene accused Congress of being beholden to “Big Pharma, Big Tech, Military Industrial War Complex, foreign leaders, and the elite donor class” instead of everyday Americans; She also cited wanting more time with family



**November 19, 2025 President Donald Trump signed the Epstein Files Transparency Act requiring the Justice Department to release all unclassified records related to Jeffrey Epstein within 30 days.** This marked a re-

versal after months of resistance, with Congress passing

and frustration with the party’s direction; Greene’s Own Words “If I am cast aside by MAGA Inc and replaced by Neocons, Big Pharma, Big Tech, Military Industrial War Complex, foreign leaders, and the elite donor class... then many common Americans have been cast aside and replaced as well.” She added she was “going back to the people I love, to live life to the fullest”; Greene’s departure narrows the Republican majority in the House ahead of the 2026 midterms; Her resignation underscores growing fractures within the GOP, especially between Trump loyalists and those critical of his leadership.



**November 21, 2025, President Donald Trump and New York City Mayor-elect Zohran Mamdani met in the Oval Office and discussed affordability,**

**public safety, and New York City’s future;** Background Trump had repeatedly labeled Mamdani a “communist.”; Mamdani had called Trump a “fascist” and “despot.”; Both exchanged heated rhetoric during the campaign; But contrary to expectations, the meeting was cordial and even chummy, with jokes, pats on the arm, and mutual praise; Main Topics Discussed: Affordability crisis in New York City (housing, cost of living); Public safety and economic security; Shared admiration for New York City despite political differences; Trump predicted Mamdani would be a “really great mayor.”; Mamdani emphasized focusing on solutions for New Yorkers rather than political traps; Both leaders highlighted unexpected areas of agreement and stressed cooperation; Symbolic Importance: It was the first face-to-face between Trump and Mamdani after a contentious election season; Political Stakes: For Mamdani, establishing a working relationship with Trump is crucial since federal funding and cooperation directly affect NYC’s ability to tackle affordability and safety issues; Generational & Cultural Significance: Mamdani’s election marks a milestone for representation, while Trump’s willingness to soften his tone shows the pragmatic side of political negotiation; The meeting showed that even leaders with deep ideological divides can find common ground when the stakes involve the future of a major city. While tensions remain, both Trump and Mamdani signaled a willingness to collaborate, at least publicly, on issues central to New Yorkers’ daily lives.



**November 22, 2025, Candace Owens publicly claimed that the French government, specifically President Emmanuel Macron and his wife Brigitte, were plotting to assassinate her.** She made these alle-

gations in posts on X (formerly Twitter) and repeated them in media appearances. However, there is no evidence or official confirmation of such a plot, and her claims have been widely described as conspiratorial; Owens actually posted that she had been contacted by a “high-ranking employee of the French Government” who allegedly warned her of an assassination plan ordered by the Macrons; She claimed the couple had paid \$1.5 million to fund the plot; Owens also alleged that the plan involved operatives linked to the French Foreign Legion’s 13th Brigade and even suggested Israeli involvement; She stated she had informed the U.S. government and the White House about the supposed threat; Key Context; These claims surfaced amid Owens’ ongoing legal dispute with Brigitte Macron over Owen’s repeated assertions about the French First Lady’s gender identity; Owens framed her allegations as a public warning, saying she wanted the information out in case “something happens” to her; Multiple outlets — including Yahoo News, The Wrap, Times Now, and Jerusalem Post — reported on her statements, but all emphasized that no credible evidence supports her accusations.



**November 24, 2025, the Pentagon announced a “thorough review” of allegations of misconduct against Senator Mark Kelly, who, along with five other Democratic lawmakers, is a military veteran, appeared in a**

**November 2025 video urging U.S. troops and intelligence personnel to refuse unlawful orders.** The Pentagon opened an investigation into Kelly for possible breaches of military law, while legal experts argue that reminding service members of their duty to disobey illegal orders is not itself unlawful; Participants included Sen. Mark Kelly (D-AZ), Sen. Elissa Slotkin (D-MI), Rep. Jason Crow (D-CO), Rep. Chrissy Houlahan (D-PA), Rep. Maggie Goodlander (D-NH), and Rep. Chris Deluzio (D-PA); Their message: service members and intelligence officials must uphold their oath to the Constitution and refuse illegal orders;

Kelly, a retired U.S. Navy captain and former astronaut, stated directly: “You can refuse illegal orders.”; His military background makes the Pentagon’s review significant, since retired officers can legally be recalled to active duty for disciplinary action; Possible outcomes of the investigation include administrative measures or even recall to active duty for court-martial; President Donald Trump reacted angrily, calling the video “seditious behavior” and saying it should be “punishable by death”; Trump labeled the lawmakers “traitors” and demanded they be arrested



**November 26, 2025, Two members of the West Virginia National Guard were shot in downtown Washington, D.C., near the White House:** Initial reports conflicted—

West Virginia Governor Patrick Morrisey first announced both had died, but later clarified they were in critical condition; The attack occurred near Farragut West Metro Station, just two blocks from the White House; Suspect: Authorities identified the shooter as Rahmanullah Lakanwal, a 29-year-old Afghan national who entered the U.S. in 2021 under a special visa program for Afghans who assisted U.S. forces during the war; Motive: The FBI is investigating the incident as a possible act of terrorism. Officials described it as a targeted ambush; The suspect was shot, wounded, and taken into custody; The White House, Treasury Department, and Freedman’s Bank Building were placed on lockdown immediately after the shooting; President Trump was in Palm Beach, Florida, for Thanksgiving at the time; Defense Secretary Pete Hegseth announced deployment of 500 additional National Guard troops to D.C., raising the total to about 2,700.



**November 26, 2025, a massive Hong Kong apartment fire began at the Wang Fuk Court complex in Tai Po, New Territo-**

**ries. It burned for over 43 hours before being fully extinguished on Friday, November 28.** Deaths: At least 128 people; Injuries: More than 80 people injured, including firefighters; Missing: Around 150–200 residents still unaccounted for; Scale of the Disaster; The fire engulfed seven of the complex’s eight towers; The towers housed 4,600–4,800 residents, many elderly; Required 2,300 firefighters to battle the blaze; Cause remains under investigation, but construction materials and bamboo scaffolding used in renovations are suspected to have fueled the flames; Authorities are probing corruption and negligence linked to the renovation work; At least 12 arrests made, including construction company staff and individuals investigated for manslaughter and corruption; This is Hong Kong’s deadliest fire since 1948.



**November 27, 2025 (Thanksgiving Day), after learning that Sarah Beckstrom, one of the two National Guardsmen shot by Rahmanullah Lakanawal, died of**

**her wounds, President Trump declared the incident an "act of terror" and announced sweeping immigration crackdowns.** He vowed to “permanently pause migration from all Third World countries”, halt Afghan immigration applications, re-examine Biden-era admissions, and push for deportations of undocumented immigrants; he ordered deportations of undocumented immigrants and pledged to end federal benefits for non-citizens; promised to denaturalize migrants deemed harmful to U.S. domestic security; Afghan immigration applications were halted indefinitely pending review of vetting protocols; Trump demanded a “re-examination” of all Afghan nationals admitted under Biden’s administration; Treasury officials confirmed moves to block undocumented immigrants from receiving federal tax-based benefits; Lakanwal faces first-degree murder charges and other counts for ambushing the soldiers; Prosecutors emphasized his entry under Biden-era resettlement programs, which Trump blamed for vetting failures; Political Framing: Trump tied the attack directly to immigration policy, using it to justify broad restrictions

beyond Afghanistan; Policy Scope: His measures target both illegal and legal immigration, including asylum cases and naturalized citizens; Uncertainty: Trump did not specify which countries fall under “Third World” nor how “permanent pause” would be implemented; Criticism: Opponents argue these actions conflate one criminal act with entire immigrant communities, raising legal and humanitarian concerns.



**November 28, 2025, on Truth Social, President Trump publicly declared that all executive orders signed by Joe Biden using an**

**autopen are “null and void.” stating that any document signed by Biden through the autopen “is hereby terminated, and of no further force or effect”;** Trump claimed that Biden was not directly involved in the autopen signing process and that those who operated the device did so “illegally.” He even suggested that if Biden insisted he was involved, he could face perjury charges; Trump alleged that approximately 92% of Biden’s executive orders were signed using the autopen; Legal analysts quickly pointed out that autopen signatures are valid. The device has been used by multiple presidents, including Trump himself, to sign official documents. The method of signature does not affect the legitimacy of executive orders; Political Motivation: While Trump’s declaration was dramatic, experts noted that social media statements do not carry the force of law. In the classic song, ‘It’s Only a Paper Moon,’ one of the most telling lines is ‘It’s a Barnum and Bailey World, Just as Phony as it Can be.’

That likely does not come as any great surprise to the reader, and sometimes phony isn’t a cause for concern, sometimes it is merely laughable.

However, there are times when phony can be downright dangerous.

We would like our speedometers and fuel gauges to be accurate. We would like the ingredients labels on our food to be complete. Our journey, our health may depend on it.

In the world of academic degrees, especially the important ones like J.D. and M.D. we are depending upon the (hopeful) fact that these are genuine, and not just fancy engraving on a worthless piece of paper.

Our lives, our freedom may depend on it.

For those who are religious, we would hope that the credentials of our chosen theologians were meaningful, as our ‘souls’ may depend upon it.

But, credentials aren’t always credible, and aren’t always deserving of credit, and for those seeking the imprimatur of an advanced degree without putting in the work, there are diploma mills.

Those scam educational institutions where a sheepskin may be had for a requisite number of shekels, are definitely participants and citizens of that ‘Barnum and Bailey World.’

Let’s take a look under the rock, and see what creatures wearing caps and gowns are crawling around...

Degree mills aren’t exactly new. One can call them a tradition, of sorts. *‘The first documented reference to degree mills was in 1876.’*

So, we are told to determine if the degree granting ‘institution’ is accredited. Therein lies another problem, for *‘it is common for the degree mills to advertise they are accredited, but many of these so called accreditors are actually creations of the degree mills themselves.’* [\[1\]](#)

While a legitimate degree, (even in this day and age) can mean more income for the possessor, the granting of phony degrees is more than profitable. There are older (early 2000s) *‘estimates that half a billion dollars a year are paid to degree mills.’* [\[2\]](#)

In a February 2023 article in *The Watchdog*, (from Bellevue College), it was reported *‘Some estimates suggest that up to 30% of job applicants have falsified their educational credentials, and the problem is particularly acute in certain industries, such as healthcare and education.’*

The article further stated ‘About [500,000](#) Americans currently hold fake degrees.’<sup>[3]</sup>

Take a look at those two statements together. Healthcare and education are the areas where fake degrees are ‘particularly acute.’ There are half of a million fake diplomas in America, according to the 2023 estimates.

Healthcare can often be a life or death field, and if the provider is providing a credential that is not ‘healthy’ we could die from the advice and treatment offered. The field of education which grants supposedly real degrees may be infested with teachers that are bearers of fake degrees.

To say that this gives one pause would be an understatement. But it isn’t just *people* possessing phony degrees.

While many of us are pet lovers, perhaps we would draw the line when a *cat* is awarded a Master’s Degree in Business Administration for \$299.00, as had been granted by a Texas diploma mill.<sup>[4]</sup>

But it’s no laughing matter. ‘*Unqualified doctors have fatally misdiagnosed patients, unqualified forensic specialists and psychologists have wrongly sent people to jail after being called upon as expert witnesses, and companies have lost million dollar lawsuits after their staff’s qualifications turned out to be fake.*’<sup>[5]</sup>

It is assumed that those lawsuits were conducted by lawyers with legitimate degrees.

In a 2017 report from CBS, it was stated ‘*A recent search of LinkedIn found 745 people, including public-safety workers, lawyers, engineers, educators and federal government employees, holding degrees from Corllins.*’

Now, if you aren’t familiar with that institution of higher learning; fear not for the United States Department of Education never heard of it either.<sup>[6]</sup>

Look at that statement again, we aren’t talking English Lit or Byzantine History degrees, which even if they are legitimate, aren’t really important in the scheme of things, (sorry), but we are talking about public safety workers, lawyers, engineers and federal government employees. That can be downright disastrous for our health, safety and welfare.

That same report referenced a 2006 paper from *Hofstra University* (fun fact: the alma mater law school of your author under his real name), that estimated that *the ‘National Council for Accreditation of Teacher Education that one of six education doctorates are fraudulent.’*

That is a frightening report card, especially when one realizes that higher education often costs six figures.

We hire a home improvement contractor and we want him to be licensed and insured, if our state requires it. We take our car to a mechanic, and we want to know he has a legitimate repair license from the Department of Motor Vehicles.

Because these types of certifications are government issued, there is less of a chance that the certificates are fuzzy.

Now, let's look at our teachers, our doctors, our engineers and lawyers; people who we depend upon in fields wherein mistakes can be costly — or deadly.

Yet these are the fields that are most likely to be populated with those bearing phony degrees, who have not undergone the requisite studies, but merely paid a fee, and perhaps submitted a 'life experience' portfolio for credit.

The obvious solution is for license granting agencies and employers to actually take the time and verify that the degree holders have legitimate degrees from legitimately accredited institutions.

We as everyday citizens are not in a position to determine the bona fides of a degree, we depend on our governments — federal, state and local — to confirm legitimacy before they confer authority.

They must do their job, and make sure that those bearing professional degrees can actually perform theirs.

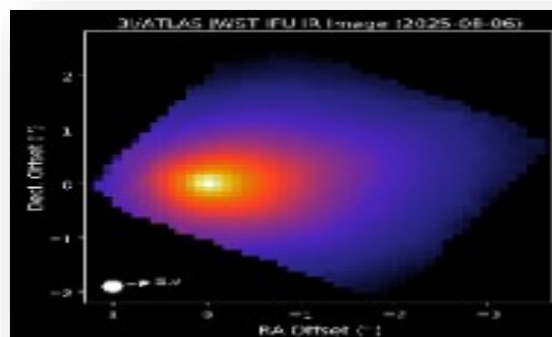

COMET 3I/ATLAS

*Imagine the island of Manhattan flying at 134,000 miles through space, that's what is out there right now...*

We get hit with stuff from space constantly.

More than you might think. Somewhere around 20,000 meteors larger than a softball hit Earth every year.

A few hundred are big enough to recover and catalog. Why aren't they more of a big deal?

So far, every single one has been from our own solar system, mostly from an asteroid belt between Mars and Jupiter, some from the Moon or Mars after they're hit by other meteors.

So, there's not much new to be learned by these objects.

We're just glad they aren't the size of buses, and they mostly disappear into our oceans.

It's extremely rare anything enters our solar system from outside its boundaries. Astronomers call these objects 'interstellar'.

They know immediately when an object has arrived from interstellar space: its trajectory and velocity can't be explained by gravitational interactions within our solar system.

Meaning, it's not orbiting the sun or any other object. It's literally passing through. And it's moving much faster than your average meteoroid.

When they do show up, it's a rare opportunity to learn just what is out there. These objects form in star systems not our own, so they carry valuable data.

But it's no exaggeration to call it rare. Before this year, interstellar objects have entered our solar system twice.

An interstellar object called Oumuamua passed through in 2017. It moved at a staggering 58,000 miles an hour, far faster than any object knocked from the asteroid belt at the edge of our solar system.

Then in 2019, an object called Borisov arrived, with a bright coma and tail, consistent with your typical comet. But again, its speed set it apart. It was moving at over 71,000 miles an hour, faster than any comet in our solar system.

On July 1st of this year, the southern ATLAS telescope at Cerro Tololo in Chile discovered a third.

The telescope is part of three positioned around the globe to detect near-Earth objects that pose a collision risk. This new object was in no danger of hitting Earth. But it did cause concern.

First, it's the fastest interstellar object ever observed, moving at 134,000 miles an hour. And -- unlike its two predecessors -- its path is exceptionally straight.

The good news is, the speed and trajectory confirm it is just passing through our solar system. But something traveling so fast and so straight begs another question: what the heck is it?

Well, it's large, maybe the largest interstellar object observed to date.

Estimates suggest a size as large as 12 miles long. Imagine the island of Manhattan flying at 134,000 miles through space, that's what is out there right now.

And it's ancient. It's the oldest object ever seen by humanity.

We know this because its path indicates it originated from the Milky Way's thick disk of stars, a region high above and below the part of the galaxy we're in, where stars are 8-12 billion years older than our sun.

This interstellar object -- officially called 3I/ATLAS -- is older than our own solar system, by billions of years.

It comes from somewhere formed in the early Galaxy -- places we weren't even sure existed. If it was designed by ancient aliens, it was made to survive across light-years.

And there's something unusual flying off of it, being re-

leased in staggering quantities: water.

It's another first for interstellar objects. The Swift Space Telescope used ultraviolet images of 3I/ATLAS to spot it. It's releasing water at a rate of about 88 pounds per second. It's hard to comprehend that much water -- it's all the rain on Earth in a single day, but released every second.

Is it an ancient alien probe, sent eons ago to scout us?

Well, it's the first thing astronomers attempt to rule out. Because most likely, 3I/ATLAS is a natural comet.

First, they examine the trajectory. If it is moving too fast, on an odd incoming angle (not lining up with the galactic plane where most stars orbit), it indicates it might have been sent intentionally rather than wandering naturally.

And, disturbingly, 3I/ATLAS checks this box. It is, indeed, coming in at an odd angle and at tremendous speed. But this alone isn't enough to call it intentional. In fact, the angle would be consistent with an object originating in the Milky Way's 'thick disk'.

The other key indicator an object might be alien is a change in speed, independent of the objects around it -- astronomers call this non-gravitational acceleration. It suggests some kind of ship, with hidden engines, able to navigate independently.

The thing is, a detailed analysis estimates that 3I/ATLAS is experiencing non-gravitational acceleration. But it's extremely slight, and could be attributed to dust particles ejected, exerting recoil forces. Slight or not, it's another box checked in favor of 3I/ATLAS being, well, unnatural.

Of course, a comet has one major trait that's easy to identi-

fy. It's called a coma, a gas and dust cloud that surrounds it as it gets warmed by the sun. And 3I/ATLAS does exhibit an active coma -- but with unusual characteristics, different than your typical comet.

When comets warm and develop a visible coma, they show cyanide gas first. But 3I/ATLAS showed water first, with the cyanide gas appearing later. This indicates the object has sources of ice on board, outside its nucleus.

In fact, before the cyanide gas appeared, a spectroscopy detected atomic nickel emissions in the coma. Again, this is highly unusual, and not found in the majority of comets.

Add to this, the carbon dioxide levels of 3I/ATLAS are unusually high. Astronomers figure this means the object formed in a very cold region of the Milky Way, far from its parent star. Wherever it was made, it was in deep space more extreme than typical comets.

Lastly, the coma has an unusual red hue, indicating its composition differs from typical comets.

But despite the unusual water trail, high CO<sub>2</sub> levels, odd nickel emissions, and the mysterious red-tinted coma that make 3I/ATLAS chemically and physically different from most comets, NASA is confident the object is, in fact, a comet. NASA's official website calls it "Comet 3I/ATLAS".

Let's hope they're right. If it is an ancient alien probe that just confirmed to its creators Earth is here, we may not want to know what happens next.

*A drug that's more deadly than fentanyl? Standard doses*

*of Narcan often had no effect at all on victims. Toxicology showed only trace amounts of fentanyl -- too little to explain the deaths. Something stronger was in play...*

In 2013, emergency responders in the U.S. became aware of a powerful drug on the market that was gaining popularity over heroin.

Because, from a user's perspective, it was much better. It was fifty times stronger.

Once it became widely available on the street, there was no stopping its popularity.

It's called fentanyl, named by the chemists who first synthesized it in 1959.

The name refers to its chemical components, phenyl and aniline (a basic building block in chemical dyes, plastics and pain killers).

Its name indicates the second big advantage fentanyl had over heroin: this new drug was made in a lab, not manufactured from plants.

Drug cartels could make a virtually unlimited supply. No more worrying about poppy crops needed in heroin production, grown on the other side of the world in countries like Afghanistan.

This made it much cheaper to produce fentanyl, as much as 99% less per dose. And because its potency was so much higher, cartels could charge more. The margins were ridiculous. And the new product sold like crazy.

The tragic part is how we know it was so popular...

In 2016, fentanyl surpassed heroin in overdose deaths nationwide. By 2022, fentanyl was the leading cause of overdose death in the U.S., surpassing heroin, oxycodone, and all other opioids combined.

So how potent is fentanyl?

If you picture a packet of sugar from a diner, that's about a gram of sugar. That much heroin could kill a few people. Fentanyl is in another league.

Just a few grains from that packet are enough to end someone's life. Image a few sugar crystals mixed in a pill, how easy it would be to take one -- and how badly you'd want the next one. If you lived long enough.

Back in 2013, if users thought they were taking heroin but it was laced with fentanyl, they'd be ingesting the equivalent of 25 doses of heroin in one sitting, and never know it.

EMT's arriving at the scene of a typical fentanyl overdose found that the usual single hit of Narcan (medicine that blocks effects of opioids) didn't revive the victim. It took up to eight doses to get someone breathing again. If it worked at all.

It was by far the deadliest drug on the street. Until now.

In 2020, Tennessee saw a cluster of ten overdoses that baffled investigators. The victims collapsed within minutes.

Standard doses of Narcan barely made a dent, and sometimes had no effect at all. Toxicology showed only trace amounts of fentanyl -- too little to explain the deaths. Something stronger was in play.

Initial toxicology reports showed small traces of fentanyl or heroin, but clearly not enough to kill. There was a stronger, undetected opioid in the mix.

Knox County's Regional Forensic Center sent blood samples to the DEA for secondary testing. They found what everyone suspected: there was a new lab-created opioid in the mix. They found the presence of nitazenes.

Researchers from Vanderbilt University Medical Center and the University of Pittsburg Medical Center published a paper last month (Sept '25) in the journal *Pain Medicine*

detailing how the highly potent synthetic opioid nitazene is rapidly emerging as the driver for a new national overdose crisis.

Like fentanyl, it was created in a lab as a synthetic pain reliever in the late 1950's. But unlike fentanyl, nitazene was never approved for medical use in humans. It's way too strong.

According to the Vanderbilt study, one variant of nitazene was 20 times as potent as fentanyl, and a staggering 100 times more potent than morphine. A tiny fraction of a milligram can be fatal.

Fentanyl is already deadly in micrograms, but nitazenes take this to another level. Just a few micrograms -- less than a grain of salt -- can kill. Overdoses happen fast, killing before first responders have a chance to arrive.

And nitazene is being mixed into common street heroin and counterfeit pills, turning ordinary looking drugs into lethal bombs.

The strange thing is, nitazene is often hidden, sold under fake names or disguised as OxyContin or Subutex. The makers and distributors are actively spreading the potent opioid into the population completely under the radar.

So, who is behind this invasion?

DEA and European partners compared seized samples and found they were chemically consistent across batches. The uniformity pointed to a single manufacturer, or a group of coordinated labs.

U.S. Customs began intercepting powders and precursor chemicals -- the stuff needed to make nitazene -- shipped in

small parcels, many labeled as "research chemicals." The packages consistently originated in China, often routed through transit hubs like Hong Kong or Singapore.

Finally, darknet markets saw Chinese chemical suppliers advertising nitazene-class opioids as legal fentanyl alternatives after China made fentanyl illegal in 2019. These vendors explicitly marketed nitazenes as "new, unscheduled, stronger than fentanyl."

Turns out, nitazenes are being manufactured in Chinese labs that pivoted from fentanyl once Beijing banned fentanyl-class compounds.

The supply then enters the U.S. through international mail and freight, often sold wholesale to domestic traffickers who press it into fake oxycodone or mixed it into heroin.

China has found a way to invade U.S. shores without firing a shot.

### City Lights (1931)

You can't tell the story of cinema without Charlie Chaplin, whose Little Tramp remains one of the most enduring silver-screen characters ever created. A bittersweet romp in which the Tramp falls in love with a blind woman who works at a flower shop, it's best remembered for what

Perhaps no country takes cinema more seriously than France, which has produced countless masterpieces since George Méliès and the Lumière brothers helped innovate the “seventh art” in the 1890s. At the top of that mountain of movies would have to be Jean Renoir’s *The Rules of the Game*, a tragicomic parable for the inevitable-in-hindsight leadup to World War II.

No other movie has snagged a spot in the top 10 of Sight and Sound’s decennial poll of the greatest movies in history for all of its six editions: 1952, 1962, 1972, 1982, 1992, 2002, and 2012. It’s also been named the greatest French film ever made by Time Out, which, while accurate, is also somehow limiting — like the global conflict it presaged, *The Rules of the Game* transcends boundaries.

## Citizen Kane (1941)

“Seeing it,” film critic Archer Winsten wrote of *Citizen Kane* when it was first released, “it’s as if you never really saw a movie before.” More than 80 years later, Orson Welles’ all-timer has lost none of its power.

A true before-and-after moment in cinema, *Citizen Kane* marked the arrival of one of the most skilled, idiosyncratic filmmakers in Hollywood history: Welles produced, directed, co-wrote, and starred in his debut feature, which famously did not win Best Picture but has since gone on to be named the greatest movie ever made on countless occasions. You have to see it to believe the hype.

### Seven Samurai (1954)

Many people's initial reaction to a black-and-white Japanese movie from the 1950s with a runtime of 207 minutes may be that it sounds like a chore, but in this case, nothing could be further from the truth. Akira Kurosawa's Seven Samurai is an epic in the truest sense of the word, a thrillingly melancholy exploration of honor, duty, and a bygone way of life that has proved one of Japanese cinema's most enduring backdrops. (It also invented the assembling-the-team trope that has since been endlessly repeated ever since.)

You could populate an entire best-of list just with Kurosawa pictures alone, but Seven Samurai remains his most expansive, fully realized work — hence why it's been hailed as everything from the greatest foreign-language film to the greatest action movie of all time.

Most scenes consist of little more than the title character, a widowed housewife played by Delphine Seyrig in an era-defining performance, completing household tasks in real time until finally erupting in a shocking act of violence.

It’s among the first feminist films as well as a “slow cinema” forerunner, and many would refer to it as a cult classic that’s finally begun to get its flowers on a larger scale. It’s a must-see for anyone willing to expand their conception of what a movie can do.

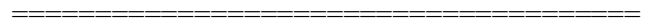

### Land Ownership

The Pacific Railway Act of 1862 granted 174 million acres to railroad companies, highlighting how land grants could influence politics.

The Credit Mobilier scandal exposed corruption involving discounted shares given to congressmen in exchange for favorable legislation.

Today, mega landlords still wield significant power. Private owners control about 60% (1.3 billion acres) of US land.

Examples include the Emerson family, John Malone, and even Bill Gates, who owns significant farmland.

Concerns arise over potential tax exemptions for large landholdings, which could negatively impact local communities.

Landowners control tax revenue, voting districts, and resource allocation.

### The Power of Credit and Central Banking

But is there a more desirable target? It could be. A Russian FSB document (FSB is the new Russian KGB), has identi-

fied China as their number one threat. Isn't that interesting? Putin and president XI, have appeared like good friends in public and acted as though America was their main threat. They seemed to have a powerful alliance, but it was merely a paper alliance. Russia knows what's coming. And they're hoping they can stall it off because they are supplying China with very cheap oil. Russia only has two customers for their oil, India and China. And when the demand for oil is that low, the only customers India and China can set their own price. And China is benefiting.

So is there a place China could attack and offset that loss of cheap oil? The answer is yes. Where do you think it would be? We know it's not Taiwan. We gave you the reasons why China is not going to attack Taiwan first.

Here is the answer. China is going to attack Siberia before it attacks Taiwan. This is not in the leaked Russian FSB document that reported China is the main threat to Russia. But this has got to be why Russia looks at China as the number one threat. The reported threat to Russia is not NATO, it's not the United States, it's China. And if China attacks Siberia, Japan may not interfere in this. It's not likely the United States is going to interfere in this because this attack will significantly weaken Russia. Siberia belongs to Russia. The problem for Russia is Putin has had to strip his Siberian military defenses and put them into the battle in Ukraine. North Korea is in a strategic position to help China and provide troop support to the Vladivostok area. And so long as China does not threaten the Sea of Japan, Japan will probably stay out of it.

There is no way that with Russia tied up with Ukraine Russian can adequately defend against this invasion by China into Siberia. China will station its best military in the northern part, and this is why I believe China's new military leader Xu Xisheng has reorganized the Chinese military with emphasis on the Northern District. So this is where the next war is going to be. It's going to be in Siberia.

But hold on. What do we know about Chinese military and strategic planning? American planning tends to be about the next quarter, the next three months. We have some military planners that go the long route, but they're limited because money's allocated on a quarterly basis, often, sometimes yearly. On the other hand, the Chinese plan five, ten, fifteen, or fifty years out. And this has huge implications for the United States. There will be no interven-

## WHY HAVE WE BECOME WOKE?



Recently, *The Daily Signal Politics* Editor Bradley Devlin had a conversation with Helen Andrews on “The Signal Sitdown” on why we have become Woke. This conversation is reported below:

Conservative academics have wrestled with the origins of woke for decades. Some call it cultural Marxism repackaged. Some argue it started in academics with postmodernism rejecting objective truth and weaponizing culture. Waked is the ideology of the new managerial elite in late-stage neo-liberalism, hence it may have come from global businesses.

Maybe “woke” and “cancel culture” sprang from “The Great Feminization.” Helen Andrews, author of “Boomers: The Men and Women Who Promised Freedom and Delivered Disaster,” published “The Great Feminization,” a term stolen from J. Stone, on how “woke” is “an epiphenomenon of demographic feminization.” She discusses on “The Signal Sitdown” this week.

Andrews, like many conservative thinkers, seeks woke. Other wokeness origin theories failed. Andrews added, “All of those theories have merit to them,” but “in most cases, something about the mechanism didn’t seem to be entirely clear to me.”

As with the argument that wokeness is rebranded cultural Marxism. “There are some people who see an ideological genealogy of wokeness,” Andrews told *The Daily Signal*. They claim it's cultural Marxism, which spreads via colleges and infects everyone, causing wokeness everywhere at once.

Andrews said, “the weakness of the ‘wokeness is cultural Marxism’ theory for me is that I saw wokeness erupt in areas of our society that are not remotely Marxist, like big business Fortune 500 companies.” “Wokeness appeared in unexpected places.”

“I think the moment I knew wokeness was different than [political correctness] or any of the old iterations was when people started getting fired from NFL teams or NASCAR,” Andrews said. Why does NASCAR show wokeness? It seems unlikely to be found there—or in Wall Street firms.”

“These are not hotbeds of wokeness,” Andrews said. Nothing ideological seemed to be going on. The trend was feminization.”

“The Great Feminization” theory states that female representation at numerous institutions has reached a critical mass that has changed how these organizations and society work.

“We fought feminism in the 1970s over whether women could be lawyers. We agreed they could, which is excellent, Andrews said. “But it took a long time to go from token representation of the kind achieved in second-wave feminism to what we have now.”

Second-wave feminism has penetrated our institutions, resulting in what we have. “Why the Great Feminization thesis resonates with me so strongly is because just the timing fits,” Andrews said.

Many of the organizations influenced by “The Great Feminization” began hiring women in the 1960s and 1970s, but now women make up growing majorities.

“Law schools became majority female in 2016,” Andrews remarked. Professors at universities? I believed it would have been earlier, too, but it only tipped over in the last five years. Females dominated medical colleges in the last five years. Most American college-educated white-collar workers are women.

Andrews later stated, “There has never been a society in the history of planet Earth where women have been a majority of lawyers, doctors, or managers in management positions in businesses and nonprofits.” Everyone, including those who despise me and think I'm a hater, must admit that we're in unknown ground, regardless of whether feminization is a problem. The tremendous feminization will bring new problems and changes to society that we have never seen before—not in our country or any other.”

It coincides with wokeness and cancel culture.

Andrews called Wokeness a rejection of rational argument. Wokeness is “the intrusion of identity politics into previously neutral arenas and the erection of taboos surrounding what kinds of things you are and aren't allowed to question, hiding more and more debatable claims behind curtains of, ‘How dare you push back on that!’”

To relate to feminization, Andrews stated that women tend to care more for victims than men (The Daily Signal). I think wokeness does that across the board every time: if you can frame a political issue as looking out for a weak or victim class, it is far easier to get women on board.

Wokeness blocks logical discourse “by continuing to accumulate more and more sacred victim classes that you're not allowed to question.”

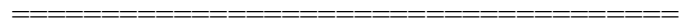
Thus, rolling back wokeness involves rolling back “The Great Feminization.”

Reversing “The Great Feminization” requires equalizing the playing field. Stop diversity bonuses for female college and employment candidates. Limit and define anti-discrimination law. “The weapon that these schoolmarms in the HR department have to wield is federal law because anti-discrimination law makes it illegal to have an unwelcoming workplace for women, and judges have interpreted that law very broadly,” Andrews told The Daily Signal.

“It is only by massively incentivizing women to enter paid work that we have created the situation where they are more than half of young associates at law firms,” she said. I think great feminization will fade if we remove their thumbs.

Andrews concluded, “I’m confident that would occur in America if we stopped deliberately manipulating gender relations in the toxic ways we’ve been doing so far.”

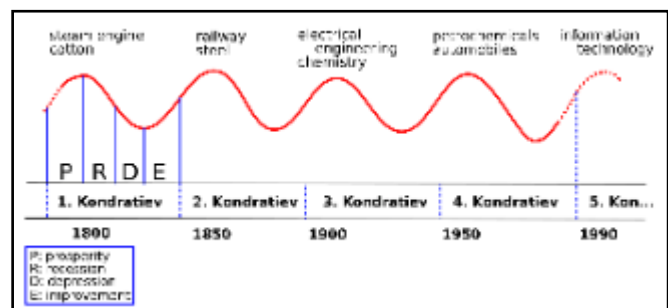
