

February 1, 2026, Spanish tennis star Carlos Alcaraz made

history at the Australian Open, becoming the youngest player ever to complete a career Grand Slam after defeating Novak Djokovic in a highly anticipated final. At just 22 years old, Alcaraz now joins the sport’s most elite company, capturing titles at all four major tournaments: the Australian Open, French Open, Wimbledon, and U.S. Open; Alcaraz’s victory marks a generational shift in men’s tennis. Long seen as the heir apparent to

the Big Three era, he delivered a commanding performance against Djokovic, whose dominance in Melbourne has defined the tournament for more than a decade. The match showcased Alcaraz’s trademark blend of speed, creativity, and relentless pressure—qualities that have propelled him to the top of the sport at a remarkably young age; Tennis analysts are already calling this milestone one of the most significant achievements of the modern era. Completing a career Grand Slam is rare; doing so before age 23 is unprecedented. For many fans, the moment symbolizes the arrival of a new global superstar whose impact may shape the next decade of the sport; Alcaraz’s win also energizes the broader tennis world, signaling a competitive landscape no longer defined by a single dominant figure but by a rising generation ready to take center stage.



February 4, 2026, Mayor Karen Bass is under renewed scrutiny after a report alleged she pushed to soften an after-action review of the 2025 Palisades Fire to protect her public

image. The claims, first raised in a Los Angeles Times investigation, center on whether Bass influenced edits that removed or diluted criticism of the city’s wildfire response. Sources cited in the report said Bass expressed concerns about legal exposure and asked then-interim Fire Chief Ronnie Villanueva to revise the draft. The final version released months later was noticeably less critical. Bass has denied directing any changes, insisting she only sought factual accuracy and never altered

the report herself. The controversy has intensified political tensions in Los Angeles, raising questions about transparency and accountability in the city’s emergency response. It has also revived speculation about future mayoral challengers, as critics seize on the episode to question Bass’s leadership.



February 8, 2026, The Seattle Seahawks captured Super Bowl LX with a commanding 29–13 victory over the New England Patriots in Santa Clara. Seattle’s top-ranked defense set the tone, sacking Drake Maye six times and forcing three turnovers,

including a 45-yard pick-six by Uchenna Nwosu; Running back Kenneth Walker III powered the offense with 161 total yards and became the first RB this century to win Super Bowl MVP. Kicker Jason Myers added five field goals as Seattle controlled the game wire-to-wire; The win marks the Seahawks’ second championship and a full-circle redemption 11 years after their Super Bowl XLIX loss to New England.



February 8, 2026, Japan Prime Minister Sanae Takaichi called a snap general election only a few months after taking office, seeking a fresh mandate for her economic and security agenda; The election was framed as a high-stakes gamble and

a referendum on her leadership, aimed at strengthening her position to pursue tax cuts, expanded military spending, and broader conservative reforms; Her Liberal Democratic Party (LDP) and coalition partners won a landslide victory, securing a supermajority in the 465-seat lower house—well above the 310 seats needed to override the upper house; This was described as a historic win, with projections of up to 328 seats for the LDP alone.



February 9, 2026, Prince Andrew Faces New Scrutiny Over Epstein Emails; Freshly unsealed U.S. Justice Department documents show that Prince Andrew forwarded internal U.K. trade reports to Jeffrey Epstein in 2010 while serving as the U.K.’s Special Representative for Trade and Investment. The emails included

details about official trips and investment opportunities. British authorities say they are reviewing the disclosures, which have sparked renewed concern within the royal family and intensified public scrutiny following the broader release of the “Epstein files.”



February 8, 2026, former downhill gold medalist Lindsey Vonn crashed just 13–14 seconds into the women’s downhill final at the 2026 Winter Olympics; She lost control after clipping a gate with her right shoulder and tumbled

down the slope before coming to a stop on her back; Her screams were audible as medics reached her, and she required extended on-slope treatment; She was airlifted from the course by helicopter—her second helicopter evacuation in nine days; Vonn was already racing with a fully ruptured ACL in her left knee, an injury she sustained nine days earlier but chose to compete with; The crash caused a broken leg, which was confirmed as the primary new injury.; She underwent surgery shortly after the crash to repair the fracture and was reported to be in stable condition afterward; The incident ended her attempted comeback after returning from retirement to compete in one final Olympics.



February 14, 2026, a coordinated announcement from five European Governments concluding Alexei Navalny was poisoned with a rare toxin has reignited global scrutiny of the death of the Russian opposition leader, nearly two years after he died in a remote Arctic penal colony; Officials from Germany, France, the United King-

dom, Sweden, and the Netherlands confirmed that independent forensic laboratories detected epibatidine—a highly potent neurotoxin originally identified in South American dart frogs—in biological samples taken from Navalny’s remains. The toxin, which can be synthesized in laboratories, causes rapid paralysis and respiratory failure; the findings directly contradict the Russian government’s longstanding claim that Navalny died of natural causes while serving a 19-year sentence in the Polar Wolf prison colony. Moscow dismissed the new evidence as “politically motivated,” but European leaders described the results as conclusive and said the poisoning could only have been carried out with state involvement; Navalny’s family welcomed the announcement. His mother said the forensic results “finally confirm what we have known from the beginning,” while human rights organizations renewed calls for an international investigation, arguing that Russian authorities have obstructed transparency since the day of his death; the coordinated release marks the most definitive public attribution to date and is expected to increase diplomatic pressure on Moscow. Western governments are now weighing additional measures, while Russian officials continue to deny responsibility.



February 19, 2026, Amazon officially

claimed the title of the world’s largest company by annual revenue, ending Walmart’s 13-year run at the top. The tech and retail giant reported \$717 billion in sales for 2025, edging past Walmart’s \$713.2 billion for the fiscal year ending January 31. Amazon’s rise is powered in large part by the continued strength of Amazon Web Services, which has become a major driver of the company’s revenue growth. This shift marks a significant moment in global retail and technology leadership, positioning Amazon to take the No. 1 spot on upcoming global rankings.



February 19, 2026, on his 66th birthday, Andrew Windsor, formerly known as Prince Andrew, was arrested marking one of the most dramatic turns in modern royal history. Thames

Valley Police confirmed that he was taken into custody at the Sandringham Estate on suspicion of misconduct in public office, following the release of millions of pages of documents related to Jeffrey Epstein; The arrest stems from allegations that emerged in newly unsealed Epstein files, prompting investigators to examine whether Andrew may have shared confidential government information during his time as a UK trade envoy. The inquiry also revisits long-standing scrutiny of his association with Epstein, which has shadowed the royal family for years; Police arrived at Wood Farm on the Sandringham Estate early in the morning, with unmarked vehicles and plain-clothes officers seen gathering outside the residence. Andrew was transported into custody for questioning as part of the ongoing investigation; His arrest is historically significant: Andrew is the first senior British royal to be arrested in nearly four centuries, the last being King Charles I. The development underscores the gravity of the allegations and the unprecedented nature of the legal process now unfolding; As the investigation continues, Buckingham Palace has not issued a detailed public statement, but the arrest has intensified public debate about accountability, privilege, and the future of the monarchy.



February 20, 2026, The Supreme Court ruled 6–3 that President Trump exceeded his authority when he imposed broad “reciprocal” tariffs under the International Emergency Economic Powers Act. The majority held

that the 1977 law does not permit presidents to use emergency powers to unilaterally reshape global trade policy. The decision invalidates tariffs enacted under IEEPA but leaves others intact, marking a significant curb on executive authority. Trump sharply criticized the ruling and signaled he will seek alternative paths to pursue his trade agenda.



February 20, 2026, in a stunning move that electrified the disclosure community, President Donald Trump ordered the Pentagon to begin releasing long-guarded UFO files; The directive commands Defense Secretary Pete Hegseth and top agencies to identify and disclose materials related

to UFOs and any information tied to extraterrestrial life; The announcement hit like a jolt. For decades, whispers of hidden programs and classified sightings have fueled speculation, but no president has pushed for transparency this directly. Now, with Trump’s order, long-sealed archives may finally see daylight; What will emerge — routine military reports or something far more explosive — remains unknown. But one thing is clear: the U.S. government has just taken its most dramatic step yet toward revealing what it knows about the phenomena in our skies.



February 21, 2026, Trump announced that he would raise global tariffs from 10% to 15%, effective immediately, in response to a Supreme Court decision the previous day that struck down his earlier tariff actions.

The announcement was made on Truth Social, and while he claimed immediate effect, some reporting noted uncertainty about formal implementation documents.



February 22, 2026, Mexico was shaken by the death of Nemesio “El Mencho” Oseguera Cervantes, the elusive and powerful leader of the Jalisco New Generation Cartel (CJNG). Killed during a Mexican military operation in Tapalpa, Jalisco, El Mencho succumbed to his wounds while being

transported to Mexico City. His death—one of the most significant cartel takedowns in a decade—triggered immediate and widespread retaliation. Vehicles were torched, roads blocked, and violence erupted across multiple states, prompting travel warnings and heightened security measures. Authorities have since deployed thousands of troops as Mexico braces for continued unrest.



February 24, 2026, President Donald Trump delivered the longest State of the Un-

ion address in modern history, using the nearly two-hour speech to tout what he called a national “turnaround,” highlight American achievements, and sharply criticize Democratic lawmakers; Accolades for Olympic Athletes and Heroic Americans; Trump honored several distinguished guests in the House gallery, including the gold medal-winning U.S. men’s hockey team, who received a bipartisan standing ovation. He also presented Medals of Honor and Purple Hearts to servicemembers and recognized individuals for acts of bravery and service; Although the women’s hockey team declined his invitation due to prior commitments, Trump publicly praised both the men’s and women’s teams for their historic Olympic victories, noting their achievements as emblematic of American excellence; Criticisms of Democrats; hroughout the address, Trump took aim at Democratic lawmakers, who largely remained silent during Republican applause lines. Some Democrats vocally pushed back, especially during sections on immigration and fraud. Trump responded sharply, at one point calling Democrats “crazy” amid interruptions and walkouts; Democrats countered with their own events and an official response from Virginia Gov. Abigail Spanberger, who accused Trump of misleading the public and failing to address affordability issues facing Americans.



February 26, 2026, Former UK ambassador to the United States Peter Mandelson was arrested in London, as part of an expanding investigation into whether he shared mar-

ket-sensitive government information with Jeffrey Epstein during his time as a senior minister. Police detained the 72-year-old on suspicion of misconduct in public office, following search warrants executed at multiple properties. He was later released on bail pending further inquiry. Newly released Epstein-related documents appear to show Mandelson providing advance notice of major financial policy decisions—including a €500 billion eurozone bailout—and sharing internal

government communications during the 2009–2010 financial crisis. Mandelson, who was dismissed as UK ambassador in 2025 over his ties to Epstein, has denied wrongdoing but previously apologized for maintaining contact with Epstein after his 2008 conviction.

February 27, 2026, Hillary Clinton's closed-door deposition before the House Oversight Committee ground to a halt after Representative Lauren Boebert snapped a photograph

of Clinton and her attorneys during the private session. The image quickly circulated on social media, purportedly leaked to MAGA influencer Benny Johnson, and the proceedings were paused while officials determined who violated House rules; The deposition, held at the Chappaqua Performing Arts Center near the Clintons' home in Westchester County, New York, resumed within an hour. But the disruption became a sideshow to what should have been the main event: a former secretary of state answering questions about her connections to Jeffrey Epstein's sex trafficking network; Congressional rules strictly prohibit lawmakers or witnesses from taking pictures inside closed-door testimony. A Clinton spokesman told the Daily Mail the hearing was paused "briefly while they figure out where the photo came from and why, possibly, members of Congress are violating House rules."

February 27, 2026, Paramount Skydance’s all-cash deal to acquire Warner Bros Discovery, closed out months of bidding drama and created one of the largest entertainment

Many doctors, when newly licensed to practice, start out by reciting the Hippocratic Oath.

Here’s a relevant part of it: ‘*With regard to healing the sick, I will devise and order for them the best diet, according to my judgment and means; and I will take care that they suffer no hurt or damage.*’

Of course, that sounds great in theory, but the fact that there are

rich lawyers who prosecute medical malpractice cases indicates that sometimes the medicos fall short of the promise.

But malpractice isn’t malfeasance usually, it’s a screw up.

There are a few other doctors however, that obviously didn’t get the memo about that Hippocratic Oath, and even if they did, didn’t pay any attention to it. These are the few that *intentionally* damage or kill their patients. These are the real Doctor Dooms. These are the members of the medical profession that have a murder obsession, and let’s take a look at some ‘blood samples’ from these scoundrels with a scalpel.

Certain German doctors in history have garnered rather bad reputations. Keeping up with the tradition, in April, 2025, an as of yet unnamed German physician was charged with murdering fifteen patients.

From the BBC News website, we learn ‘*He is accused of administering an anaesthetic and a muscle relaxant to his patients without their knowledge or consent. The relaxant "paralysed the respiratory muscles, leading to respiratory arrest and death within minutes", the prosecutor's office said in a statement.*’ [1]

In five of the cases, he allegedly set fire to the apartments of his victims to cover up his crimes.[2]

On the other side of the Atlantic, twenty-five years ago, we have Dr. Michael Swango, a then forty-five-year-old New York physician who was sentenced to life imprisonment for murdering three patients, but was sought to have racked up a total of sixty patients who died under his care.

In a 2000 *British Medical Journal* article, it seems that Swango didn’t have the best of reputations as a doctor. ‘*Swango is thought to have first started killing patients when he was a medical student at Southern Illinois University. After five patients under his care died mysteriously, he became known as “Double-O Swango—licensed to kill.*’ [3]

Keeping the British end up in the year before that Swango was sent to a gated community, Dr. Harold Shipman was on trial for killing fifteen of his patients. In the *British Medical Journal* reporting on the case, it was revealed from the prosecutor that *'the defendant killed those 15 patients because, in the submission of the prosecution, he enjoyed doing so. He was exercising the ultimate power of controlling life and death and repeated the act so often he must have found the drama of taking life to his taste.'* [4]

Back to the United States; to the State of New York, County of Nassau, where physician Dr. George Blatti in 2021, at the age of seventy-five was arraigned for the murder of five patients.

The Drug Enforcement Agency, on its website, reported that the prosecutor in her accusation stated *'We allege that Dr. Blatti showed depraved indifference to human life, total disregarded for the law, his ethical obligations, and the pleas of his patients and their family members when he prescribed massive quantities of dangerous drugs to victims in the throes of addiction, ultimately killing five patients who entrusted him with their care.'* [5]

In 2024, Blatti received up to fifteen years in prison, pursuant to a plea bargain in which he admitted to *'five counts of Manslaughter in the Second Degree.'* [6]

In his 2007 article in the *Australasian Journal of Psychiatry*, discussing this phenomenon of 'clenicide,' murder by doctors, author Robert Kaplan stated, *'Many clinicidal doctors have extreme narcissistic personalities, a grandiose view of their own capability and inability to accept that they could be criticized or need assistance from other doctors. Such doctors develop a God-complex, getting a vicarious thrill out of ending suffering and by determining when a person dies.'* [7]

We trust them, at least to some degree, and assume that what they prescribe for us, what they mandate should be the medical treatment we need, is correct and life supporting—not *fatal*.

It is no secret that the pharmaceutical industry promotes drugs that in one aspect will cure or assist in the cure of one disease, but anyone who has seen a drug commercial knows that at least half of the advertisement quickly details a plethora of side effects, some of which might be fatal.

But that is not an intentional harming by any means it is the disclosure to the patient of the inherent potential dangers of a prescribed treatment—one prescribed in good faith by a physician who has the intent to heal.

An altogether different thing is where there is malice in the medical professional, and he uses his knowledge and training to harm or kill his patients—decidedly on purpose.

Medicine is a licensed and restricted profession, with many privileges appurtenant to having that license. They are authorized to cut us up, they are allowed to prescribe to us what in certain incidences may be accidentally fatal to us, and in other instances will be intentionally fatal.

They have literally been given the power of life and death over their patients, and the patient who doesn't have the requisite medical knowledge — almost all of them — endows the physician with their trust, and from the treatments are given hope of a cure, or of at least a palliative result.

However, the more it is publicized about the prosecution of maniac medicos who use their knowledge and their licensed privilege to intentionally murder their patients, the less trust there will be in the profession, and those who practice it.

Space travelers can develop problems, 'specifically, symptoms of emotional dysregulation, cognitive dysfunction, disruption of sleep-wake rhythms, visual phenomena and significant changes in body weight, along with morphological brain changes, are some of the most frequently reported occurrences during space missions.'

Some of those changes referenced above can cause illusions and hallucinations, which are definitely risk factors to the successful completion of a mission.[1]

There is perhaps no greater opportunity to feel alone, in the larger sense at least, than to be in outer space, away from your planet, your country, your home and your family. It can be, especially on an extended trip, a significant stressor.

'The prolonged isolation and confinement that astronauts face in space can increase risks of behavioral issues and psychiatric disorders, such as anxiety and depression.'[2]

Anxiety and depression besides potentially leading to long term negative physical effects, can lead to difficulties which might cause a space mission to fail, not due to technological malfunctions, but human mental ones.

Relationships with the other crew members may be negatively impacted.

Astronaut efficiency can be impacted, and in a scenario where certain things must be performed at certain precise times to support the mission, tardiness and procrastination can prove fatal to a space mission.[3]

Prolonged depression can cause physical changes in the brain of the astronaut—it can shrink it.

'One of the most common changes seen in a depressed patient's brain is shrinkage, especially in the hippocampus, thalamus, frontal cortex, and prefrontal cortex.'[4]

The hippocampus is involved with memory and spatial navigation; rather important to be in good shape for an astronaut. The thalamus plays a significant role in sleep, consciousness and

alertness, among other functions.

The frontal cortex is responsible for higher level cognitive processes that are mission critical, planning, decision making and problem solving. The pre-frontal cortex, among other functions effects social relations, planning and the regulation of emotions.

One can imagine if all of these areas experienced the profound negative effects of shrinkage in gray matter volume on a space mission.

One need not imagine what can happen to an astronaut who has experienced all of the space stressors for a prolonged period, because we have an example in Lisa Nowak.

She graduated from the Naval Academy, had a degree in aeronautical engineering, and flew on the Space Shuttle. She also was charged with assault, burglary and attempted kidnapping involving another woman who was her rival for the attentions of a former lover.[5]

She received a year of probation and of course was tossed out of the space program.

Sometimes, it's not the trip out into space that can make you crazy, it's the return to earth, where things become both literally and figuratively mundane, when compared to the adventures of space exploration.

Buzz Aldrin, famous for being the second man on the moon, had a hard time after the glory moon days. He struggled with alcohol and depression. He went from pacing around on the moon, to walking the lot at a Cadillac dealership just a few years after receiving the Presidential Medal of Freedom.[6]

Now, we are thinking about sending men to Mars; a long and strange trip that will be. The increased time in space, the increased exposure to radiation, the increased likelihood of a one-way trip with a very hard landing all significantly ups the ante with respect to mental health risks for the astronauts.

'A typical round trip to Mars will last about three years, meaning that astronauts will be confined to a small space with a group of people for an extremely long time, with no possibility to conduct real-time discussions with Earth teams, family and friends.'[7]


Did moon rocks cure cancer?

This means you don't need to restock your pantry or overhaul your kitchen tools to boost your food's flavor. With just a few simple adjustments, you can bring out the best in the foods you already love. Here are some simple tips that can help enhance the taste of your food.



Some Foods Taste Better at Room Temperature

Studies have found that temperature plays a surprisingly crucial role in how we perceive flavor. Some foods, for instance, really do taste better at room tem-

perature, around 68 to 74 degrees Fahrenheit.

The science behind the correlation between temperature and taste isn't fully understood, but researchers do have some theories. Receptors such as TRPM5, a protein found in the taste buds, become more active at warmer temperatures — although if food gets too hot, the subsequent burning sensation may overwhelm taste.

Similarly, extremely cold temperatures may dull our perception of certain tastes and textures such as sweetness or creaminess. Ice cream, for instance, is just cold enough to be pleasantly sweet without freezing our taste buds, but when melted, it can become almost sickly sweet.

Taste is also impacted by flavor compound concentrations (the amount of specific taste molecules present in a food or beverage), which part of the tongue is stimulated, and aromas, which are less potent in chilled foods.

Because of this, many foods taste best at room temperature. Cheese, especially soft varieties such as brie, should be at room temperature for best consistency and flavor, otherwise they can taste a bit bland. Cured meats, too, take on a richer flavor when their fat content is allowed to soften at room temperature. Of course, don't forget to be mindful of food safety — the FDA doesn't recommend letting perishable food sit out for more than two hours at a time.

Cups and Cutlery Make a Difference

Unless you're hosting a dinner party, you may not give much thought to what you're eating with or drinking out of, but the cutlery and cups you use can impact how your meal tastes. But resist the urge to pull out the fancy old-fashioned silver flatware; silver can sometimes react with food and impart a mild metallic taste. In fact, the — ahem — gold standard for a pleasant eating experience is using utensils made of the very inert (aka chemically inactive) gold, but the tried and true stainless steel is also quite neutral. Both can ensure you're tasting the best possible version of your meal — minus the taste of the tools you use to eat it.

And as it turns out, sticklers about using the proper wine glass are right: Glasses are carefully designed to enhance aroma and flavor. Red wine glasses usually have a larger, rounder bowl to allow more room for swirling and let in more air, which helps soften tannins — the naturally astringent compounds found in grape skins, seeds, and stems. This also releases more aroma, and as we know, aroma is closely tied to taste. On the other hand, white wines tend to have more delicate aromas, so the more narrow bowl helps preserve those while also keeping the temperature cooler, which is optimal for white wines.



Variety Keeps Your Taste Buds on Their Toes

You may have noticed that when you've eaten enough to feel sufficiently full, you still crave a little something extra — often, something sweet. This is thanks to a phenomenon known as sensory-specific satiety. As we consume more of a particular dish, our response to that flavor diminishes, making that food less appealing. But this isn't usually the case for a secondary flavor, which is why after you've had your fill of pasta, you may still be craving a slice of cake.

One 2025 study suggests we crave the dopamine-driven reward response of sugary desserts, which hijacks our internal satiety indicators and overrides our fullness. Some researchers suggest this is an evolutionary adaptation, one that once ensured our ancestors ingested adequate calories and nutrients from different foods. It explains why even when a person tires of eating plain french fries, they may happily eat more if offered some ketchup to dip them in. This need for variety may also explain why many of us enjoy charcuterie boards and other such dishes that offer us a range of foods to pick and choose from.

Let Leftovers Linger

You're not imagining it — some foods really do taste better the next day. Dishes such as chillies, curries, and stews — ones rich in aromatics such as onion, garlic, or herbs — often develop deeper, richer flavors after sitting in the fridge overnight. That's because cooling and reheating gives certain ingredients time to mingle. The chemical reactions that begin during the cooking process don't just stop once the heat turns off; they slow down and evolve. As the food rests, flavors from the various spices, fats, and proteins continue to blend, often making for a more well-rounded flavor over time.

In meat-based dishes specifically, collagen continues to break down into flavor-holding gelatin that gets redistributed throughout the dish. When making rich, seasoned sauces, spices including black pepper, cloves, and nutmeg dissolve best in fats such as oil, cream, or coconut milk, so as their flavors continue to spread, the taste becomes more potent.

Of course, not all foods improve as leftovers — dressed salad is better off finished or tossed before it wilts into mush, while mashed potatoes or other starchy foods, though not bad, undergo a process called retrogradation that causes the waters to separate and the food to dry out. It's also important to remember that leftovers should only be kept for three to four days and frozen if they're not finished by then.



Chew Slowly and Breathe Deeply

It's a truth universally acknowledged that food just tastes better when we're hungry. But as tempting as it is to eat as quickly as possible in that state, chewing slowly and breathing deeply will make the experience even more enjoyable. That's because taste isn't just about your tongue; it's also about your nose. The aromas of food reach your nose best through what's called retronasal olfaction — essentially, smelling from the inside out as you chew and breathe. As you exhale, the aromatic food molecules released when you chew are swept up to your nasal cavity where you can smell them. Eating and breathing too quickly or erratically means more of those flavorful particles are lost to the lungs instead of reaching your nose.



Less Can Be More

Less really can be more when it comes to taste. While those first few bites of a meal offer the most pleasure, as you continue eating, your taste buds can begin to adapt and the food can lose some of its appeal — a phenomenon known as “taste fatigue.” A study from Cornell University found that even a small portion of fan favorite snacks such as chips or sweets led to a significant drop in cravings 15 minutes after eating — the same as if a large portion had been consumed but without burning out your taste buds.

When given smaller portions, people tend to have a more mindful eating experience. Aside from aiding in digestion, small portions tend to make us eat more slowly and therefore focus more on the texture of the food, which is very helpful in augmenting taste. So if you’re going for maximum flavor, try starting small and really savoring every bite.

THE END OF JAPAN’S PACIFIST TRADITION?



From the desk of Joel Hilliker:

Good morning!

Will Japan become a military superpower? A landslide election win gives Japan’s hawkish prime minister, Sanae Takaichi, authority to change the nation’s pacifist Constitution. That restriction was imposed by America after the atrocities Japan committed in World War II. Yet now, America’s president is cheering and facilitating Japan’s remilitarization.

Quite the turnaround. General MacArthur would be rolling in his grave.

Donald Trump has avidly supported Takaichi, boosting momentum for her campaign. He gave her a rare public endorsement before the election, praised her coalition’s achievements, congratulated her historic two-thirds supermajority, and wished success for her “Peace Through Strength” agenda.

President Trump wants his greatest legacy to be that of a peacemaker. Yet his pursuit of that goal is producing extraordinary unintended consequences.

To recognize them, though, you have to know the outline of end-time biblical prophecy.

That outline shows four major end-time power blocs: 1) America and the English-speaking peoples; 2) “the king of the south,” an Iran-led Islamist coalition; 3) “the king of the north,” a German-led European empire; and 4) “the kings of the east,” an Asian alliance. It foretells a shocking shift in power away from the first of those blocs toward a brutal competition among the other three.

One of the most stunning trends in world affairs—even going back to just after World War II—is how much the U.S. has been directly responsible for aiding the rise of these powers that are prophesied to attack and conquer it. Think of it:

- Rebuilding Germany after the war through the Marshall Plan
- Facilitating China’s integration into the global economy
- Neutralizing Iran’s top regional competitor, Iraq

Barack Obama and Joe Biden intensified these trends: ignoring Russia’s annexation of Crimea; signing the Iran deal that facilitated Iranian nuclear aims; driving Russia and China into deeper cooperation.

But President Trump is unwittingly shifting things into overdrive. He truly is transforming the world in several ways that align with end-time prophecy. It is especially stunning the way his administration is turbocharging European unification and militarization, even German leadership specifically. This is the Frankenstein monster on an international scale.

Japan is prophesied to be integral to the end-time Asian confederation. It has the technical and industrial capacity to contribute much militarily, and its every step away from pacifism raises the ceiling of just what it could add. The Trumpet has warily watched Japan’s growing militarism as it marches toward its place in the coming world war.

How much responsibility will President Trump bear for Japanese weapons being used in that war?

We’ll only know for sure after all the prophecy flips to history. But it is looking like this would-be peacemaker may end up being, more than any other one man, the catalyst that hastens World War III.

Death knell for Japan's pacifist Constitution?

Prime Minister Sanae Takaichi secured a supermajority in the lower house of Japan's legislature yesterday, a victory in snap elections that could empower the hawkish leader to officially end Japan's postwar political era and dramatically accelerate its re-militarization.

- During her campaign, Takaichi called for a revision to Article 9 of Japan's Constitution, the so-called pacifist clause that was intended to prevent a return to full militarism.

- She aims to increase offensive capabilities with new cutting-edge drones, missiles and other extended-range weaponry.

Under Takaichi's leadership, Japan will hit its goal of spending 2 percent of GDP on defense next month—nearly two years ahead of what was already a tremendously ambitious schedule.


"I think we should possess nuclear weapons," a leading security official in her cabinet told reporters on December 17. "In the end, we can only rely on ourselves."

In November, Takaichi said in the Diet: "If China invades Taiwan," Japan would view it as an "existential crisis situation" and possibly deploy its Self-Defense Force.

From adversaries to allies: At present, animosity and fear are rising between Japan and China, driving both economic and military powerhouses to amass extraordinary military power, and fueling the popularity of hawkish figures such as Takaichi. Biblical prophecy shows, however, that these two nations will soon come together, for a brief but pivotal moment. They will align under Russian leadership and turn their firepower against the West, helping unleash the most destructive war in mankind's history.

These zombie companies crowded out healthy businesses, kept prices artificially low, hoarded workers and resources, and took up bank credit, leading to a sclerotic economy.

American economic policies post-2008 and 2020, including zero interest rates and massive quantitative easing, have created conditions mirroring Japan's 1980s, leading to asset prices disconnected from reality and a significant percentage of US companies operating as zombies.

The Federal Reserve faces an "inescapable trap": raising rates collapses zombie companies and commercial real estate, while cutting rates to save them causes inflation to roar back and leads to the same deflationary zombie economy Japan experienced.

Japanification for regular people means wage stagnation (Japanese wages flat for 21 years), declining opportunities for young people, asset price deflation/stagnation, and the death of retirement.

America's situation is potentially worse than Japan's due to its diverse, individualistic, and divided society, and critically, the dollar's role as the global reserve currency.


